Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Riverside Research Institute Non-Contributory Retirement Income Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Notes to the Financial Statements

1. Description of the Plan

The following description of the Riverside Research Institute Non-Contributory Retirement Income Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General and Eligibility

The Plan is a defined contribution plan established by the Plan sponsor, Riverside Research Institute (the Organization), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. All employees aged 21 or older with one year of service are eligible to participate, except leased employees, independent contractors and consultants. Years of service are based on an employee completing 1,000 hours within the first anniversary of the start of their employment. Upon enrollment in the Plan, participants may direct contributions to any combination of available investment options.

Trustee and Administration of the Plan

The trustee and recordkeeper of the Plan is Empower Annuity Insurance Company and Empower Trust Company, LLC (collectively, Empower). The administrator of the Plan is the Organization. Empower holds all assets of the Plan in accordance with the service provider contract with the Organization. The Plan's investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Organization's Board of Trustees.

Contributions

Contributions to the Plan are made by the Organization on behalf of each participant. The Organization's contribution is calculated based on a set percentage of participants' monthly compensation and years of credited service, determined as of the first day of the month.

Credited Service	Monthly Employer Contributions
Less than 10 years	5.0% of compensation
10 or more but less than 20 years	7.5% of compensation
20 or more years	10.0% of compensation

In addition, the Organization may amend the Plan and make an additional contribution at the end of the Plan year for participants employed on the last day of the Plan year. The additional contribution to the Plan is determined annually for all eligible participants. This amount is typically a percentage of the monthly employer contributions to eligible participant accounts for the year. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers).

Participant Accounts

Each participant's account is credited with employer and rollover contributions as well as an allocation of the Plan's earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances

or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their rollover contributions plus actual earnings thereon. In addition, participants who are terminated from the Plan because of death, early or normal retirement or disability retirement, as defined in the Plan document, become 100 percent vested in the Organization's contributions. The Organization's contributions and earnings thereon vest in accordance with provisions of the Plan as follows:

<u>Years of Service</u>	<u>Percentage</u>
1 but less than 2	25%
2 but less than 3	50%
3 or more	100%

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance less any current outstanding loan balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. These loans are secured by the balance in the participants' accounts. The loans bear interest at the prime rate plus one percent. Principal and interest are paid ratably through payroll deductions. Employees who have terminated service with the Organization but wish to continue to make monthly loan repayments on outstanding notes receivable may do so at their option. Loans may be refinanced in accordance with the rules established by the Plan Administrator.

Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the Plan document. The Plan provides for normal retirement at age 62. Participants with vested benefits in excess of \$5,000 may elect to receive distributions in the form of a lump sum payment, installments or an annuity. For a participant with vested benefits of \$5,000 or less, the benefits will be distributed to the participant or beneficiary as a lump sum amount equal to the value of the participant's vested interest in his or her account at the time of separation.

Participants experiencing financial hardship may withdraw a portion of this account balance as defined in the Plan document.

Transfer from Other Plan

Certain eligible participants are allowed to transfer a balance of their accrued benefits from a separate defined contribution plan sponsored by the Organization into the Plan.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$80,339 and \$159,075, respectively. These accounts will be used to reduce future Organization contributions or pay Plan expenses. During the year ended December 31, 2024, the Organization utilized \$290,613 of forfeiture assets to reduce employer contributions and to pay Plan administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investments contract, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further information related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Payment of Benefits

Benefits are recorded when paid.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustee and recordkeeper of the Plan, a qualified institution.

4. Fair Value Measurements

Financial Accounting Standards Board (the FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- *Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2* - Inputs to the valuation methodology, including the following:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- *Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value, as well as the general classification pursuant to the valuation hierarchy. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market funds held by the Plan are deemed to be actively traded.

- Separate accounts are valued based on NAV per unit of participation in the fund and have no unfunded commitments. In an effort to reduce market timing and excessive trading, shareholders are locked out of an account for 90 days if a purchase, sale, and repurchase within that account is made within a 60-day period, other than for the money market account. NAV is valued based on the fair value of the underlying assets of the fund derived from or corroborated by observable market data by correlation or other means, although not based upon quoted market prices in an active market.

5. Investments at contract value

The Plan has a fully benefit-responsive investment contract, which is reported at contract value, in the Massachusetts Mutual Guaranteed Interest Account which totaled \$16,155,183 and \$18,435,235 at December 31, 2024 and 2023, respectively.

The Plan's fully benefit-responsive investment contract comprises a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The following represents the contract value of investment contracts held by the Plan.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuers are contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuers but may not be less than 3%. The crediting rate is reviewed on a semi-annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contract is dependent on the third-party issuers' ability to meet its financial obligations. The issuers' ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events could limit the ability of the Plan to transact at contract value, including, but not limited to, premature termination of the contract by the Plan or plan termination. TIAA may also apply a two-year payout restriction to fully pay out the fund upon termination of the contract, which would include a discontinuance fee. This would cause a one-time adjustment to the aggregate contract value, resulting in a fair value different from the contract value; however, the Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value are probable of occurring.

6. Income Tax Status

The Plan adopted a defined contribution plan and trust basic plan document, which received a favorable opinion letter dated June 30, 2020 from the IRS that states that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (the IRC). The opinion letter may constitute reliance for an employer adopting the approved Plan. The Plan

Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified and the related trust is tax exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan provides for various investment options. Investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the values of investment securities, it is at least reasonably possible that changes in risk in the near term would materially affect the amounts reported in the Plan's financial statements and participant account balances.

8. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

9. Related Party and Parties-in-Interest Transactions

Certain of the Plan's investments are shares of investment contracts managed by Empower. Empower is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA. Fees incurred by the Plan for the investment manager services are included in net appreciation of investments. The Plan sponsor pays directly any other fees related to the Plan's operations. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan.

10. Subsequent Events

The Plan Administrator has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued. The Plan Administrator is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
