## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Vanguard Industries East 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. DESCRIPTION OF THE PLAN

The following description of the Vanguard Industries East 401 (K) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### GENERAL

The Plan is a retirement plan under Internal Revenue Service Code Section 401(k) effective January 1, 1997 and was amended/restated on various dates to comply with current ERISA regulations.

All employees of Vanguard Industries East, Inc. (the "Company") who have attained the age of 18, completed 12 months of service, and worked at least 1,000 hours are eligible to participate in the Plan. The effective date of participation is the first day of each calendar month of the Plan Year, coincident with or next following satisfaction of the eligibility requirements.

The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA) and subsequent amendments.

#### Participant Contributions

Participants may elect to contribute to the Plan from his or her salary an amount not exceeding the limit specified under Code Section 402(g) in effect at the beginning of the taxable year (\$23,000 for 2024, plus "catch-up" contribution of \$7,500 for eligible employees).

#### Employer Contributions

The Company matches the employee's contribution up to 4% of salary.

#### Participants Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and, (b) plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings, account balances, or

specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from participant's vested account.

### **Vesting**

Participants are immediately vested in their contributions, Company's contribution portion of their accounts and actual earnings thereon.

### **Investment Options**

Upon enrollment in the Plan, a participant must direct his or her contributions in any investments offered by the Plan as listed in Schedule H -Schedule of Assets (Held at End of Year).

### **Notes Receivable from Participants**

Participants may borrow from their accounts up to 50% of his or her vested account balance up to a maximum of \$50,000. The minimum loan amount is \$1000. The notes are secured by the balance in the participants' accounts and bear interest at a rate determined by the plan administrator. The notes issued during the current year bear interest at the rate of 1% over prime rate and is fixed for the life of the loan. Generally principal and interest are paid ratably through payroll deductions. All loans are required to be repaid within 5 years of the loan unless the purpose of the loan is to acquire a dwelling unit which is to be used within a reasonable time as the principal residence of the participant, in which case the repayment term extends to 15 years.

### **Payment of Benefits**

Upon retirement, disability, death or termination of employment, the participant shall become entitled to the total value of his or her vested account. Distributions will be paid in a lump sum either directly to the participant or in a rollover to an individual retirement account or another employer plan, based upon election of the participant, as defined in the Plan. Participants may make withdrawals from their accounts prior to age 59 ½, in the case of hardship. The Plan allows in-service distribution of all or a portion of participants' balances once a participant reaches age 59 ½.

### **Cash Outs of Accounts and Consent to Distribution**

The balance of a terminated participant's account will be transferred to an IRA in situations where the participant is non-responsive to requests to remove their account balance from the plan. This transfer out of the plan will occur for unresponsive terminated participants with account balances of \$1 to \$7000.

### **Operating Expenses**

Substantially all expenses of the Plan are paid by the Company. Loan fees are deducted directly from the participant's account.

### **Forfeited Accounts**

At December 31, 2024 and 2023 forfeited accounts totaled \$10,473 and \$6,210 respectively and will be used to reduce future employer contributions or plan administrative expenses.

## **2. SUMMARY OF ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting using accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan managers to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments (except for fully benefit-responsive investment contracts, which are reported at contract value) are reported at fair value. Fair value is the

price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses (realized and unrealized) on investments bought and sold, as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on accrual basis and related fees are recorded as administrative expenses. Delinquent loans are treated as distributions based on the terms of the plan document.

### **Contributions**

Contributions from Plan participants and matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

### **Payment of Benefits**

Benefits to participants are recorded when paid.

### **Plan Expenses**

The majority of administrative expenses are paid by the plan sponsor. Fees related to participant loans and investment redemptions are allocated to the specific participants. The plan sponsor bears all other costs related to administering and maintaining the Plan. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Plan also uses excess revenue sharing receipts (ERISA Spending Account) from investment companies for paying Plan expenses.

### 3. TRUSTEES

Empower Trust Company LLC (“ETC”) is the Trustee/Custodian of the Plan and Empower Retirement, LLC is the record keeper for the Plan.

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that Plan has the ability to access.

Level 2: Inputs to valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. FULLY BENEFIT-RESPONSIVE CONTRACTS

The Plan entered into a fully benefit-responsive Guaranteed Interest Account (GIA) contract with Massachusetts Mutual Life Insurance Company, provided through a Group Annuity Contract and as of December 31, 2024 the contract value of these investments were \$558,988 (2023 \$501,037). Under the terms of the contract, a crediting rate is established half yearly for amounts invested in the GIA (2024 and 2023 1.15%). MassMutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract Value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events at Plan level such as Plan termination, prohibition on competing investments options, bankruptcy of the Plan sponsor, failure of the trust to qualify for tax exempt status and premature termination of the contract can affect the ability of the Plan to transact at contract value with the issuer.

Furthermore, certain events such as uncured violation of the Plan investment guidelines, material amendments to the contract without issuer's consent, violation of a material obligation under the contract or a material misrepresentation allow the issuer to terminate the contract with the Plan at an amount different from contract value. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

### **6. CERTIFIED INFORMATION**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company LLC.

### 7. PARTY-IN-INTEREST TRANSACTIONS

During the year ended December 31, 2024, there were plan transactions involving parties-in-interest, as defined by ERISA. ### **9. TAX STATUS**

The trust established under the Plan to hold the Plan's assets is qualified in accordance with the appropriate section of the Internal Revenue Code and, accordingly, the Plan's net investment income is exempt from income taxes. Although the Plan has been amended/restated since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **10. RISK AND UNCERTAINTIES**

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **11. SUBSEQUENT EVENTS**

Management has evaluated, for potential recognition and disclosure, events subsequent to the date of the statement of net assets available for benefits through October 01, 2025 the financial statements were available to be issued.
