- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### *Auditor's Responsibilities for the Audit of the Financial Statements*

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a significant likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

*Other Matter - Supplemental Schedule Required by ERISA*

The supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or are derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

#### Note 1 - Description of the Plan

The following description of Choate Rosemary Hall Foundation, Inc. DC Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

##### **General**

The Plan is a contributory Internal Revenue Code (the "IRC") Section 403(b) defined contribution retirement plan covering all eligible employees of Choate Rosemary Hall Foundation, Incorporated (the "School"). Employees age 21 or older become eligible to make salary deferral contributions to the Plan as soon as administratively feasible following their date of hire. Student employees are excluded from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the IRC. The Trustees of the School are responsible for oversight of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Trustees of the School.

##### **Contributions**

Each year, participants may make salary deferral contributions to the Plan equal to 100% of their pre-tax annual compensation, as defined by the Plan. Participants may designate all or a portion of their salary deferral contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan has also elected to allow participants to make Qualified Organization Catch-up Contributions provided they have completed at least 15 years of service. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Each year, the School makes a nonelective contribution to the Plan on behalf of each eligible participant based upon a formula equal to 15% of a participant's eligible compensation, as defined by the Plan. All employees age 21 or older are eligible to receive an allocation of the School's contribution, provided they are not part of an excluded class of employees. Employees who normally work less than 20 hours per week, collective bargaining (union) employees and temporary employees, as defined, are excluded from receiving any of the School's nonelective contributions. A participant becomes eligible for the School's nonelective contribution on the first day of the month following the satisfaction of the eligibility requirements. Participants also direct the investment of the School's contributions. All contributions are subject to certain IRC limitations.

##### **Participant accounts**

Each participant's account is credited with the participant's contributions and an allocation of the School's nonelective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their salary deferral contributions and rollover contributions plus actual earnings thereon. In the event of termination due to death, total and permanent disability or normal retirement, participants shall become 100% vested in the School's nonelective contribution portion of their account. For all other participants, vesting in the School's nonelective contribution portion of their account is based on credited years of service, as defined by the Plan, according to the following schedule:

#### Payment of benefits

On termination of service due to death, disability or normal retirement, a participant with account balances of \$5,000 or less will receive a lump-sum distribution. Participants with account balances greater than \$5,000 may elect to receive a single lump-sum amount, partial payments, installment payments for a specified term or purchase of an annuity contract equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Withdrawals from a participant's salary deferral account may be made in the event of a financial hardship or disability, in accordance with the provisions specified in the Plan. Withdrawals from a participant's rollover account may also be made at any time, in accordance with the provisions specified in the Plan. Additionally, in-service withdrawals are allowed in accordance with the provisions specified in the Plan for participants who have attained age 59½.

#### Notes receivable from participants

Participants may borrow from their TIAA and CREF fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account. The loan interest rate is based on the prime rate at the time the loan is approved, plus 1%. Principal and interest payments are made directly by participants to TIAA-CREF.

#### Forfeited accounts

When a participant is terminated, nonvested accounts are forfeited by the participant. There was \$13,193 and \$81,592 of forfeited nonvested accounts as of December 31, 2024 and 2023, respectively. These amounts may be used to pay Plan administrative expenses or used to reduce future employer contributions. For the year ended December 31, 2024, forfeitures of \$264,898 were utilized to reduce employer contributions.

#### Note 2 - Summary of accounting policies

##### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in three types of fixed annuity contracts, of which two are considered fully benefit-responsive.

##### **Investment valuation and income recognition**

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value (see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by Teachers Insurance and Annuity Association of America ("TIAA"), College Retirement Equities Fund ("CREF") and Ascensus, LLC, as an authorized representative of Ascensus Trust Company ("Ascensus"). See Note 5 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### **Contributions**

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. The nonelective contributions from the School are recorded in the year in which the contributions are earned.

##### **Payment of benefits**

Benefits are recorded when paid.

##### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

##### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the School. Expenses that are paid by the School are excluded from these financial statements. Certain account service fees and loan processing fees are charged directly to participant accounts and are included in administrative expenses. Certain investment advisory fees and other administrative expenses are also paid directly by the Plan and included in administrative expenses. Indirect investment related expenses are included in the net appreciation in fair value of investments.

#### Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Subsequent events

The Plan has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued.

#### Note 3 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by TIAA, CREF and Ascensus.

#### Note 4 - Fully benefit-responsive investment contracts

The Plan has entered into traditional fully benefit-responsive fixed annuity contracts with TIAA, an insurance company, referred to as the TIAA Traditional Annuity, totaling \$15,707,276 and \$15,192,156 as of December 31, 2024 and 2023, respectively, and the TIAA Stable Value Fund, totaling \$1,921,712 and \$1,596,240 as of December 31, 2024 and 2023, respectively. TIAA maintains the contributions in a general account for each type of contract. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and ranges between 1% and 3%. Additional amounts above the guaranteed minimum interest rate may be declared at the discretion of the TIAA Board of Trustees on a year-by-year basis. The crediting rate is reviewed on an annual basis for funds that are already invested in the TIAA Traditional Annuity and TIAA Stable Value Fund and on a monthly basis for new contributions coming into these contracts in the accumulation phase for resetting. The fixed annuity contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

These contracts meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include: 1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), 2) changes

to the Plan's prohibition on competing investment options, 3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemptions under ERISA, or 5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: 1) an uncured violation of the Plan's investment guidelines, 2) a breach of material obligation under the contract, 3) a material misrepresentation, or 4) a material amendment to the agreements without the consent of the issuer.

#### Note 5 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Variable annuity contracts:* Valued at the unit value as reported by the accounts. The unit values are listed on the National Association of Securities Dealers Automated Quotations ("NASDAQ") website and updated overnight for each day that the NASDAQ is open. The accounts held by the Plan are deemed to be actively traded.

*Nonfully benefit-responsive fixed annuity contracts:* Valued based on the accumulated cash contributions and interest credited to the Plan's contracts, less withdrawals. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate. These annuity contracts are not available for sale or transfer on any securities exchange. Withdrawals under the retirement annuity contracts may be made in the form of a life annuity or in 10 annual installments. The fully benefit-responsive fixed annuity contracts are valued as described in Note 4.

*Pooled separate account:* Valued at the unit value as reported by the account. The unit values are listed on the NASDAQ's website and updated overnight for each day that the NASDAQ is open. The account held by the Plan is deemed to be actively traded.

**Note 6 - Plan termination**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 7 - Plan loans**

Participants were allowed to borrow from the Plan using the assets in the participant's salary deferral or rollover accounts with TIAA and CREF as collateral. Under this arrangement, TIAA and CREF have the right to collect the collateral in the event of a default. Principal and interest payments are made directly by participants to TIAA and CREF. Effective January 1, 2022, the Plan loan program offered by TIAA was discontinued; however, Plan participants may continue to borrow from certain portions of their account in the form of notes receivable (see Note 1). At December 31, 2024 and 2023, Plan loans totaling \$14,241 and \$55,524, respectively, were outstanding under this arrangement, of which no amounts have been defaulted.

#### Note 8 - Tax status

The Plan has been designed using a volume submitter 403(b) plan document sponsored by TIAA. TIAA received an advisory letter dated August 7, 2017, in which the Internal Revenue Service (the "IRS") stated that the volume submitter 403(b) plan document, as then designed, satisfies the applicable requirements of the IRC. Although the Plan itself has not received a determination letter from the IRS, the Plan administrator believes that the Plan is designed, and is currently operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 9 - Related party and party-in-interest transactions

Plan investments are managed by TIAA and CREF. TIAA and CREF are the insurance entities who hold certain investments of the Plan and TIAA is also the recordkeeper as agent for TIAA Trust, N.A. the custodian holding other investments of the Plan. Other Plan investments are held and managed by Ascensus. Therefore, these transactions qualify as party-in-interest transactions. Indirect expenses incurred by the Plan for investment management and other administrative services from these parties-in-interest are included in the net appreciation in fair value of the related investments. Direct expenses charged to certain participant accounts held with TIAA and CREF for loan processing and maintenance fees were \$250 for the year ended December 31, 2024. Direct expenses charged to certain participant accounts held with Ascensus for account service fees were \$590 for the year ended December 31, 2024. These direct expenses are included in administrative expenses in the accompanying statement of changes in net assets available for benefits. The Plan sponsor pays directly any other fees related to the Plan's operations. The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions.

At December 31, 2024 and 2023, the Plan's revenue sharing account totaled \$20,363 and \$221, respectively. The Plan received revenue sharing credits from TIAA in the amount of \$32,610 for the year ended December 31, 2024. These amounts, which are shown as other income in the accompanying financial statements, may be used to pay Plan expenses or may be reallocated to Plan participants. For the year ended December 31, 2024, revenue sharing credits of \$13,250 were utilized to pay certain investment advisory fees and auditing fees related to the Plan.

#### Note 10 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.



