The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of American United Life Progress Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of the Plan

The following description of American United Life Progress Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined-contribution plan sponsored by American United Life Insurance Company (Company) for the benefit of its employees. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Company serves as Plan custodian.

A member of Company management serves as trustee of the Plan. In addition, there are two benefit oversight committees; Benefit Plans Investment Committee and Benefit Plans Administrative Committee.

The Plan is funded in its entirety by a group annuity contract. Contributions are allocated to either a fixed interest investment option, or a Company separate account where participants purchase units of portfolios within the separate account, which in turn purchases shares of corresponding mutual funds.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 80% of eligible compensation. Highly compensated employees may defer up to 16% of their eligible compensation. There are no age or service requirements for participants to make employee contributions. Rollover, Roth, and catch-up contributions are also permitted.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an annual increase in the percentage deferred and is ultimately capped at 10%.

The Company contributes a match of 50% of participants' elective deferral amounts or Roth contributions on the first 6% of participants' eligible compensation for each payroll period. Matching contributions are capped at 3% of eligible compensation.

The Company can also contribute a discretionary profit-sharing contribution. Any profit-sharing contributions made for the Plan year shall be allocated to each eligible participant employed on the last day of the Plan year. There were no profit-sharing contributions made to the Plan during 2024 and 2023.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and is charged with any applicable administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Effective January 1, 2023, vesting in the Company's contributions plus earnings thereon is based on years of continuous service. A participant is fully vested after two years of continuous service. Employees who were hired before January 1, 2023 are immediately vested in the Company's contributions plus earnings thereon.

Payment of Benefits

Upon termination of service, participants may receive distributions through a single lump-sum payment. Participants may also receive distributions through substantially equal installments and partial distributions are allowed twice each calendar year if the participant has attained early retirement age. Annuity payments will be the normal form of payment for any amounts transferred from money purchase plans. In-service withdrawals for participants that reach 59 1/2 or have hardship issues are permitted by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$26,458 and \$4,371, respectively. These accounts will be used to reduce future employer contributions or to pay Plan expenses. During 2024, employer contributions were reduced by \$47,462 from forfeited nonvested accounts.

Notes Receivable to Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans are at the prime rate as published in the Wall Street Journal on the first work day of a month plus 2%.

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as benefit payments based upon the terms of the Plan Document.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 2. Summary of Significant Accounting Policies

Method of Accounting

The accompanying financial statements are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Quoted market prices, if available, are used to value investments. Separate accounts are valued at estimated fair value as provided by the Company.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

AUL Fixed Interest Account

The Plan's fully benefit-responsive fixed interest investment option with the Company is maintained in the Company's general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed interest investment option issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract may be subject to a market value adjustment upon contract termination. Crediting interest rates on the fixed fund portion of the insurance investment contract are determined quarterly by the issuer with a minimum rate of 4.00%, subject to limitations relating to Plan termination, early retirements, etc.

As described above, because the fixed interest investment option is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed interest investment option. Contract value, as reported to the Plan by the Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the Company. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Plan Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a pre-approved 401(k) profit sharing plan sponsored by OneAmerica Financial Partners, Inc. The Plan has obtained a determination letter on September 26, 2022, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the employer or the Plan, at the employer's discretion.

Note 3. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, American United Life Insurance Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. Level 2 securities include separate account investment options. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan holds no Level 1 or Level 3 securities.

Separate account investment options: Valued at the net asset value (NAV) per accumulation units held by the Plan at year end.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Investments held by the Plan are managed and maintained by the Company at no expense to the Plan. Administrative fees paid to investment service providers by the Plan totaled \$120,447 and \$128,033 during 2024 and 2023, respectively. Additional fees paid to other service providers totaled \$39,613 and \$39,608 during 2024 and 2023, respectively. The Company also provides certain administrative services at no cost to the Plan.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 7. Subsequent Events

Effective January 1, 2025, VOYA acquired OneAmerica's recordkeeping business. This transaction impacted more than 20% of the Plan participants, therefore, this constituted a partial plan termination. Impacted employees became fully vested in their employer contribution accounts.

Impacted employees are considered terminated from the Company and have the option to rollover their account balance to the VOYA sponsored 401(k) Plan, or they can leave their balances in the Plan, if the balance is over \$7k. Any balances under \$7k would be distributed in accordance with the Plan force-out provision.

Subsequent events have been evaluated through September 29, 2025, which is the date the financial statements were available to be issued.
