## **Independent Auditors' Report**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of Wawona Frozen Foods 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Plan Description**

The following description of Wawona Frozen Foods (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan. The Plan was established on January 1, 1991, and was restated for the cycle 3 restatement on August 1, 2021. The Company is part of a control group with common ownership. Affiliated employers may adopt the Plan as a participating employer with the completion of a participating employer agreement. Clovis Food Products, Inc. signed a participating employer agreement on April 1, 2023, and then signed on to the amended and restated Plan in 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

During 2024, the Plan was amended and restated. The amendments changed employee eligibility from previously allowing all employees of the Companies to participate, to excluding union employees, non-resident aliens, leased employees, and seasonal employees. Additionally, employees previously had to attain age 21 and provide three months of service to make contributions and receive employer contributions in the Plan. The Plan was amended to allow employees to immediately make elective deferrals to the Plan, and to attain age 18 and provide three months of service to receive employer matching contributions.

During 2024, the Plan was also amended to change the Trustee and Custodian of the Plan. Plan assets were transferred from John Hancock Life Insurance Company to Nationwide Trust Company. Additionally, the Plan appointed Pentegra Retirement Services as the named 3(16) Plan Administrator.

Contributions

Eligible employees of the Company may elect to contribute up to the maximum limit established annually by the Internal Revenue Service as pre-tax or after-tax Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company may elect to contribute a discretionary matching contribution. For 2024, the Company matched 100% of participant contributions up to 3% of eligible compensation. In addition, the Company may elect to make a non-elective contribution. In order to receive the non-elective contribution under the Plan, the participant must have worked at least 1,000 hours during the Plan year and be employed on the last day of the Plan year. Participants direct the investment of the contributions into various options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, and allocations of (a) Plan earnings and (b) administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Plan Description** (continued)

Vesting

Participants are immediately 100% vested in their employee deferral contributions and rollover contributions, plus actual earnings thereon prior to March 31, 2024. The Company's discretionary matching and non-elective contributions are vested at 20% each year after two years of service of credited vesting service. Effective March 31, 2024, the Plan changed vesting to a five year graded schedule. Participants vest 20% each year and are fully vested after five years of service.

Investment Options

Participants direct the investment of their accounts into various investment options offered by the Plan. Participants may currently choose from a variety of different mutual funds with varying investment objectives and degrees of risk.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their deferral account balance, whichever is less. The interest rate charged to the participant for the loan is credited to the participant's account. Loan payments are made through payroll deductions and must be paid back within five years. Loans for a principal residence may exceed five years. The loans are secured by the balance in the participant's account. If the participant terminates employment with the Company prior to completing payments on the loan, the outstanding balance may be taxed and subject to penalty.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum distribution of the participant's total account balance. On termination of employment, a participant may receive a lump sum payment of the participants vested interest in their account. If a participant's vested accounts are less than \$5,000, the Plan Administrator will distribute the accounts to the participant automatically. For vested account balances between \$1,000 and \$5,000, the Plan Administrator may distribute the account to an individual retirement account in the participant's name. The Plan also permits distributions due to hardship under certain circumstances. Additionally, participants may elect to receive in-service withdrawals if they become 59½ during the Plan year. Participants are allowed hardship withdrawals in excess of \$500.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$49,558 and \$22,822, respectively. During 2024, participants forfeited \$23,731 of non-vested Company contributions. Amounts accumulated in the forfeiture account will be used to reduce Company contributions and pay administrative fees of the Plan. Forfeitures were used to reduce Company contributions and pay administrative fees during the years ended December 31, 2024 and 2023, respectively.

**Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan Administrator to make estimates and assumptions that may affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except the fixed interest account contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment custodians, and insurance company. See Fair Value footnote for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses

Administrative expenses paid by the Plan relate to recordkeeping fees. All other expenses incurred in administering the Plan are paid by the Company and are excluded from these financial statements.

**Fair Value Measurements**

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Fixed Interest Account**

The Plan maintains a contract (fixed interest account) with Nationwide. Nationwide maintains the contributions in a general account. The average yield for the year ended December 31, 2024 was 2.19%, and is reviewed on a quarterly basis for resetting. The fixed interest account issuer, Nationwide, is contractually obligated to repay the principal and the specified guaranteed interest rate to the Plan. Contract value represents contributions made under the contract, plus earnings less participant withdrawals. As of December 31, 2024 and 2023, the Plan has recorded the fixed interest account at the contract value in the amount of \$1,856 and \$366, respectively.

The Plan's ability to receive amounts due is dependent on Nationwide's ability to meet economical obligations. Nationwide's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with Nationwide. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

**Certified Investment Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C), pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulation for Reporting and Disclosure under ERISA. Accordingly, Nationwide Trust Company LLC and John Hancock Trust Company, both qualified institutions, have certified the following information included in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) as complete and accurate:

- Investments and participant notes receivable as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments and dividends and interest as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024;
- Investment information included in the Notes to Financial Statements;
- All investment information included in the Supplemental Schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) – As of December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information included in the financial statements and ERISA-required supplemental schedule.

**Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan paid \$45,753 of administrative fees to the recordkeepers and Custodians for the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

Certain Plan investments are shares in accounts that are managed by Nationwide Life Insurance Company and John Hancock Life Insurance Company. Nationwide Life Insurance Company and John Hancock Life Insurance Company are the Custodians as defined by the Plan and qualify as parties-in-interest.

**Tax Status**

The Company adopted a prototype non-standardized profit sharing plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

**Tax Status** (continued)

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Recent market conditions have resulted in an unusually high degree of volatility and increased the risks and short-term liquidity associated with certain investments held by the Plan, which could impact the value of investments after the date of these financial statements.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

**Subsequent Events**

The Plan evaluated subsequent events through September 27, 2025, the date the financial statements were issued.
