### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Armstrong Bank 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

#### **Note 1: Description of the Plan**

The following description of Armstrong Bank 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan sponsored by Armstrong Bank and covers all non-union, resident employees, excluding contract employees who work less than 1,000 hours of Armstrong Bank and Ironhorse Financial Group, Inc. (collectively, the Company). Non-contract employees are eligible to participate in the Plan after reaching the age of 18 and completing 60 days of service. Contract employees are eligible to participate in the Plan after reaching the age of 18 and completing 1,000 hours of service during a 12-month period. All employees are entitled to receive employer discretionary matching contributions when they become eligible to participate in the Plan. To receive employer discretionary profit-sharing contributions, employees must be employed on the last day of the plan year, regardless of the amount of service completed during the year.

The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the current Internal Revenue Code (IRC) and similar state laws. The Plan is subject to the current provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Empower Annuity Insurance Company of America (Empower Insurance) and Empower Trust Company, LLC (Empower Trust) serve as record-keepers and trustees of the Plan.

#### **Contributions**

The Plan permits eligible employees, through a salary deferral election, to have the Company make annual contributions up to, but not exceeding, the maximum allowed under federal regulations. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

Prior to January 1, 2023, the Company provided a discretionary matching contribution equal to a percentage of employee pre-tax contributions determined by the Board of Directors. Effective January 1, 2023, the Plan was restated to allow for safe harbor matching contributions equal to 100% of elective deferrals that do not exceed 5% of the individual employee compensation. The Company, at the discretion of its Board of Directors, may also make annual discretionary profit-sharing contributions. The Plan also allows a discretionary additional matching contribution up to 6% of compensation as well as a discretionary nonelective contribution. The Company did not make either of these contributions in 2023 or 2024. Contributions are subject to certain limitations.

#### **Participant Investment Account Options**

Individual participants have the option of directing their contributions into any of the separate investment accounts and may change the allocation daily. The plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Company's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions and the Company contributions plus earnings thereon, effective January 1, 2023. Prior to January 1, 2023, vesting in the Company's contribution portion of their accounts plus earnings thereon was based on years of continuous service. The Plan measured a year of service based on a 12-consecutive-month period during the plan year in which the participant must complete at least 1,000 hours of service. A participant vested 20% per year beginning after two years of service and continued to vest at the rate of 20% for each successive year until 100% vested after six years of credited service. The nonvested balance was forfeited upon termination of service; however, if the participant incurred a severance from employment as a result of death or disability, the participant was considered 100% vested. Also, if the participant was hired before August 1, 2012, 100% vesting was attained upon reaching the age of 55.

### ***Notes Receivable from Participants***

The Plan does not allow for notes receivable from participants; however, as a result of a plan transfer in 2020, certain notes receivable were held by the Plan. The loans were secured by the balance in the participant's account. Principal and interest were paid ratably through bi-weekly payroll deductions. All loans were paid or distributed in 2023.

### ***Payment of Benefits***

Participants or their beneficiaries are eligible for benefits upon retirement, termination, death, or disability. Benefits shall be distributed through the participant option of a lump-sum payment or an installment. In-service distributions are permitted for participants at age 55 if they became participants prior to August 1, 2012. A participant may also elect to receive a distribution upon turning age 59½ while continuing to work.

If the vested account value is greater than \$5,000, the participant may choose to 1) leave the funds in the Plan where they remain tax-deferred and invested at the participant's direction, 2) request a direct rollover into an individual retirement account (IRA) or to another qualified plan that accepts direct rollovers, or 3) take a distribution of the benefit, as fully described in the plan document.

If the vested account value is less than \$5,000, the participant must request, in writing, 1) a direct rollover into an IRA selected by the individual or to another qualified plan that accepts direct rollovers or 2) a lump-sum distribution of the benefit. Without a written directive, 1) a participant account with a vested account value greater than \$1,000 but less than \$5,000 will be rolled into an IRA designated by the Plan or 2) a participant account with a vested account value less than \$1,000 will be paid as a lump-sum distribution.

### ***Unallocated Accounts***

The Plan participates in an agreement with Empower where excess revenue may be returned and deposited into an unallocated Plan expense account. The amounts in the Plan expense account are used to pay reasonable and necessary Plan expenses. At December 31, 2024 and 2023, \$21,620 and \$22,679 was held in the Plan expense account, respectively. During the years ended December 31, 2024 and 2023, \$1,543 and \$12,671 were used from the Plan expense account, respectively.

### ***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$27,192 and \$32,560, respectively. According to the plan document, the Company may elect to allocate forfeitures as additional employer contributions or use forfeitures to pay plan expenses. In 2024 and 2023, the Company elected to allocate forfeitures of \$32,431 and \$150,215, respectively, as additional employer contributions.

## **Note 2: Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Pooled separate accounts are valued at estimated fair value as provided by Empower Annuity Insurance Company.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Participant transactions (purchases and sales) may occur daily. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from Plan Participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan at the Company's discretion.

**Note 3: Certifications of Plan Trustees**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Insurance and Empower Trust, both being trustees of the Plan and qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information except for comparing such information to the related information included in the accompanying financial statements and ERISA-required supplemental schedule.

#### **Note 4: Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of mutual funds and fully benefit-responsive investment contracts managed by Empower Insurance and Empower Trust. Empower Insurance and Empower Trust are the trustees as defined by the Plan and Cetera Advisory Networks, LLC is the investment advisory; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments in the accompanying statements of changes in net assets available for benefits as they are paid through revenue-sharing rather than a direct payment. The Company directly pays any other fees related to the Plan's operations. The Company provides certain administrative services at no cost to the Plan.

The Plan paid trustee, administrative, and other fees of approximately \$195,000 and \$187,000 in 2024 and 2023, respectively, to Empower, Cetera Advisor Networks, LLC, and the Company. Of those amounts, approximately \$40,000 and \$46,000 in 2024 and 2023, respectively, were paid through revenue-sharing.

#### **Note 5: Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, or other inputs that are observable or

hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

#### ***Investments***

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such investments are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy. The Plan did not have any Level 2 or Level 3 investments for the years ended December 31, 2023 or 2024.

#### **Note 6: Investment Contract with Insurance Company**

In 2017, the Plan entered into a fully benefit-responsive investment contract with Empower Insurance maintaining the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. The guaranteed investment contract is fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Empower Insurance, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: 1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or 4) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The guaranteed investment contract only holds traditional investment contracts.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

### **Note 8: Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a pre-approved profit sharing plan sponsored by Empower Retirement LLC. This pre-approved plan document has been filed with the appropriate agency and has obtained an opinion letter from the Internal Revenue Service stating that the pre-approved plan constitutes a qualified plan under Section 401 of the IRC. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

### **Note 10: Subsequent Events**

Subsequent events have been evaluated through September 5, 2025, which is the date the financial statements were available to be issued.
