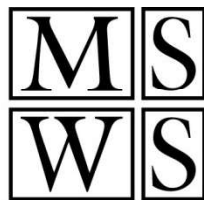

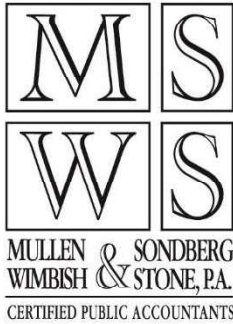

## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Board of Directors of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Retirement Plan for Faculty and Administrators of Annapolis Area Christian School, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Retirement Plan for Faculty and Administrators of Annapolis Area Christian School and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Note 1 - Description of Plan

The following description of the Retirement Plan for Faculty and Administrators of Annapolis Area Christian School (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*General:* The Retirement Plan for Faculty and Administrators of Annapolis Area Christian School, was established September 1, 1992 and restated effective August 1, 2023. The Plan covers all employees of Annapolis Area Christian School (the Employer). Per Plan provisions, there is no age or service requirement for employee elective deferrals or employer matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions:* Participants may elect to defer from 1% to 100% of their compensation and have such deferrals contributed by the Employer to his or her account under the Plan. Participant contributions are subject to the annual Internal Revenue Code limits as adjusted each year. The Employer determines at its sole discretion how much, if any, it will make as an employer contribution. Contributions made by the Employer for the years ended December 31, 2024 and 2023 totaled \$69,582 and \$69,929, respectively.

*Participant Accounts:* Each participant's account is credited with (a) the participant's salary deferrals, (b) the Employer's match of salary deferrals, (c) allocation of Plan earnings, and (d) an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Contributions are invested, at the discretion of the participants, in one, several, or all of the investment alternatives selected by the plan administrator.

*Vesting:* Participants are fully vested immediately in their elective contributions plus actual earnings thereon. Participants are also fully vested immediately in the employer matching contributions.

*Payment of Benefits:* On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount, annuity contract, or annual installments. Eligible distributions may also be rolled over to another qualifying plan or IRA. Hardship withdrawals are permitted in accordance with Internal Revenue Service regulations.

*Forfeitures:* Participants are fully vested immediately in the Employer matching and employee contributions; therefore there are no forfeited non-vested accounts.

*Administrative Expenses:* The administrative expenses related to the Plan's Trustees are paid by the Plan. The Employer pays all other administrative expenses of the Plan.

Note 1 - Description of Plan (Cont.)

*Notes Receivable from Participants:* Under certain circumstances, as outlined in the Plan document, the Plan allows employees to obtain loans from the Plan. Participants are allowed to borrow amounts within the limits set by Internal Revenue Service Code. These loans are secured by the vested portion of the participants account and bear interest at prime plus 2%. Repayment of loans is provided through automatic payroll deductions.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. This basis of accounting involves the application of accrual accounting; consequently, revenues and gains are recognized when earned, and expenses and losses are recognized when incurred.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. These loans are secured by the vested portion of the participants account and bear interest at 5.25% - 10.50%. As of December 31, 2024 and 2023, the loan balances outstanding totaled \$12,664 and \$8,081, respectively.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Cont.)

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participant would receive if they were to initiate permitted transactions under the terms of the Plan. The statement of net assets available for benefits presents the fair value of the investment contracts as well as the adjustment of the fully benefit-responsive investment contracts from fair value to contract value. The statement of changes in net assets available for benefits is prepared on a contract value basis.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and (losses) on investments bought and sold as well as held during the year.

Contributions and Related Receivables

Contributions from the employer and participants of the Plan are accrued in the period in which they become obligations under the provisions of the Plan document. All participant and Employer contributions are participant-directed. Management of the Plan evaluates employer contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection. Management has determined that all contributions receivable are fully collectible as of December 31, 2024 and 2023. Consequently, no amount has been recorded as an allowance for credit losses in the accompanying statements of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid. Benefits paid to participants amounted to \$363,468 and \$506,514, respectively, for the years ended December 31, 2024 and 2023.

Note 3 - Information Prepared and Certified by Trustees

Investment Data

Talcott Resolution Life Insurance Company (Talcott) and Teacher's Insurance and Annuity Association – College Retirement Equities Fund (TIAA- CREF) were the Trustees of the Plan for the years ended December 31, 2024 and 2023. American Trust Company was a Trustee of the Plan for the year ended December 31, 2024. All data contained in the statements of net assets available for benefits for the years ended December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the Schedule H, line 4i – Schedule of assets (held at end of year) for the year ended December 31, 2024, were summarized from information supplied and certified as complete and accurate by the Trustees of the Plan.

Note 4 - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits (except for fully benefit-responsive investment contracts, which are reported at contract value). The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*ASC 820-10 Fair Value Measurements* establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level with the fair hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Note 4 - Fair Value Measurements (Cont.)

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024 and 2023:

*Non-benefit responsive insurance company:* The non-fully benefit-responsive investment contracts with insurance companies are not actively traded and significant other observable inputs are not available, therefore are classified as Level 3. The contract value is equal to the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Variable annuities held by the Plan are typically invested in mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The variable annuities held by the Plan are deemed to be activity traded.

*Pooled separate account:* Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The REA sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources.

Shares are available for transaction at the closing net asset value per share on any day the NYSE is open for business.

Note 5 - Investments Contracts with Insurance Companies Measured at Fair Value

The Plan has a non-fully benefit-responsive investment contract with TIAA-CREF. This contract does not meet the fully benefit-responsive investment contract criteria, and therefore, is reported at fair value. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. The fair value of the insurance contract at December 31, 2024 and 2023 was \$1,126,266 and \$1,164,399, respectively.

Certain events limit the Plan's ability to transact at contract value with TIAA-CREF. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The non-fully benefit-responsive investment contract with an insurance company does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The average yields were 4.49% and 4.75% for the years ended December 31, 2024 and 2023, respectively.

Note 6 - Investment Contracts with Insurance Companies Measured at Contract Value

The Plan has investment contracts with Talcott and TIAA-CREF that meet the fully benefit-responsive investment contract criteria, and therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The total contract value included in the financial statements as of December 31, 2024 and 2023 was \$400,605 and \$454,128, respectively.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following: (1) the Plan's failure to qualify under Section 403(b) of the IRC or the failure of the Trust to be tax-exempt under Section 501(a) of the IRC; (2) premature termination of the contracts; (3) Plan termination or merger; (4) changes to the Plan's prohibition on competing investment options; or (5) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Example of such events include the following: (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreements without the consent of the issuer.

Note 7 - Reportable Transactions

A reportable transaction is a transaction, or series of transactions, exceeding five percent of the current value of the Plan's assets at the end of the year. There were no reportable transactions during the plan years ended December 31, 2024 and 2023.

Note 8 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 9 - Tax Status

Effective August 1, 2023, the Plan adopted a volume submitter prototype plan. The prototype plan obtained its latest opinion letter on August 1, 2019 from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan has been amended since the prototype received its opinion letter. However, the Plan administrator believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 11 - Party-in-Interest Transactions

Certain Plan investments are managed by Talcott, TIAA-CREF, and American Trust Company. Talcott, TIAA-CREF, and American Trust Company are Trustees as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$32,334 and \$9,458 for the years ended December 31, 2024 and 2023, respectively.

Note 12 - Subsequent Events

The Plan has evaluated the impact of significant subsequent events. Except as disclosed below, there have been no subsequent events through September 15, 2025, the date the Plan's financial statements were available to be issued that require recognition or disclosure.
