Independent Auditor's Report

To the Board of Trustees
Teamsters, Chauffeurs and Helpers Local 687
Insurance Trust

Opinion

We have audited the accompanying financial statements of Teamsters, Chauffeurs and Helpers Local 687 Insurance Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Teamsters, Chauffeurs and Helpers Local 687 Insurance Trust as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Operations

The Teamsters, Chauffeurs and Helpers Local 687 Insurance Trust (the Plan) provides death benefits to both active and retired participants. The fund office is located in Potsdam, New York, and covers participants in the upstate and central regions of New York State.

Description of Plan

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

The Plan is funded entirely by participants' contributions and earnings on investments. The participants' contributions are at a fixed rate of \$3.00 per month. Net assets available for benefits are reserved for the cost associated with the administration of such plan.

The Plan is administered by union Trustees. The Plan may be terminated by the Trustees at any point in the future. Upon termination of this Plan, participants and beneficiaries would have no further right or vested interests in the Plan. In the event of Plan termination, the net assets will be allocated as prescribed by ERISA and regulations pursuant thereto.

Participation

A participant is any member of Teamsters Local Union 687 contributing to the Plan. The employee must belong to a class of employees covered by this Plan. A qualified retiree may participate in the Plan if the participant is a retired member of Teamsters Local Union 687.

Benefits

The Plan provides \$3,500 of basic life and accidental death and dismemberment insurance to active, full-time members, \$2,500 of basic life insurance for full-time members who retired on or after August 1, 2005, and \$2,000 of basic life insurance to retirees who retired prior to August 1, 2005 through the First Reliance Standard Life Insurance Company.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting, in which revenue is recognized when earned or otherwise available, and expenses are recognized when incurred, and follows Financial Accounting Standards Board authoritative guidance on Accounting and Reporting by Health and Welfare Benefit Plans for reporting purposes.

Contributions Receivable

Contributions receivable are from Teamsters Local Union 687 are valued at cost, and are accrued based upon contribution reports received subsequent to the year-end, which include contributions due in the current year. The Plan has not recorded an allowance for doubtful accounts as all receivables are deemed collectible.

Investment Valuation and Income Recognition

Investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the statements of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with the accrual basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 2 RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements.

NOTE 3 FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board authoritative guidance on fair value measurement establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

NOTE 3 FAIR VALUE MEASUREMENTS (Continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

All assets have been valued using a market approach.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 TAX STATUS

The Trust established under the Plan to hold the Plan's net assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code, and accordingly, the Plan's net investment income is exempt from income taxes. The Plan obtained its latest determination letter on July 2, 1979, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and tax counsel believe that the Trust, as amended, continues to qualify and operate within the provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

NOTE 5 RELATED PARTY TRANSACTIONS

The Plan shares common management and trustees with the Teamsters Local Union 687. There are no compensation arrangements between the Plan and Teamsters Local Union 687.

Teamsters Local Union 687 collects contributions on behalf of the Plan. Amounts due to the Plan are recorded as contributions receivable in the Plan's financial statements and totaled \$5,175 and \$4,008 at December 31, 2024 and 2023, respectively.

NOTE 6 PARTY IN INTEREST

A party-in-interest is defined under the Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan or an employer whose employees are covered by the Plan. The Plan pays expenses related to Plan operations and investment activity to various service providers. Therefore, payments to such service providers by the Plan qualify as party-in-interest transactions.

Certain Plan investments are in mutual funds sponsored by the custodian of the Plan (SEI Trust Company) and, as such, are a party in interest. Investments in these mutual funds represented 90% of the Plan's net assets available for benefits at December 31, 2024 and 2023.

NOTE 7 FIDELITY BOND COVERAGE

The Plan presently carries Fidelity Bond Insurance in the amount of \$500,000, which is the maximum amount required.

NOTE 8 SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 24, 2025, the date on which the financial statements were available to be issued.
