## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the  
Boston Newspaper Retirement Fund

### Opinion

We have audited the financial statements of the Boston Newspaper Retirement Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (in liquidation) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (in liquidation) for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, information regarding the Plan's net assets available for benefits (in liquidation) as of December 31, 2024 and 2023, and the changes in its net assets available for benefits (in liquidation) for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Boston Newspaper Retirement Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Liquidation Basis of Accounting

As described in Note 1 to the financial statements, the Plan terminated due to a mass withdrawal of all employers on January 3, 2010. In accordance with accounting principles generally accepted in the United States of America, the Plan changed the basis of accounting used to determine at which value all assets, liabilities and the accumulated benefit information are stated on January 3, 2010, from the ongoing basis to the liquidation basis. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

### **Report on Supplemental Information**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental Schedule of Assets Held at End of Year and Schedule of Reportable Transactions are presented for the purpose of additional analysis and are not a required part of the financial statements but are supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### NOTE 1. DESCRIPTION OF PLAN

**General** - The Boston Newspaper Retirement Fund (the Plan) is a noncontributory, defined benefit plan covering certain collectively bargained employees of the Boston Herald, Inc. and the Globe Newspaper Company (the Employers). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Pension Termination** - As a result of collective bargaining between the Unions participating in the Plan and the two contributing employers, the Plan terminated due to a mass withdrawal of all employers on January 3, 2010. On June 4, 2010, the Plan notified the Pension Benefit Guaranty Corporation (PBGC) of the occurrence of a mass withdrawal and termination of the Plan. On June 16, 2010, the PBGC acknowledged receipt of the notice of termination and advised the Trustees to proceed with the termination of the Plan.

Pursuant to the provisions of ERISA, the mass withdrawal caused the Employers to incur a “withdrawal liability” to the Plan. The Plan recorded estimated withdrawal liability contributions receivable in the amount of \$10,300,000 as of December 31, 2010 representing the discounted present value of the future quarterly withdrawal liability payments by the Employers. Under the factual circumstances of the Plan there are two reasonable interpretations of the applicable statutory rules for determining the annual withdrawal liability payments and the Employers have requested advice from the PBGC as to the appropriate interpretation. The PBGC has indicated that it does not intend to provide guidance on this issue. As a result, the Trustees hired an independent Trustee with expertise in this area. The independent Trustee’s conclusion was that the basis under which the Employers were paying withdrawal liability was the correct one under the circumstances and that the payments should continue under that basis. The Employers have not challenged this decision and the period in which the Employer could challenge the decision has expired. Accordingly, it is no longer considered reasonably possible that a change in the withdrawal liability receivable will occur in the near term.

The Plan will continue to be operated by the Plan Administrator under the direction of the Trustees. Per the actuarial projections received by the Plan in the December 31, 2024 valuation report, the Plan is expected to have sufficient assets to continue to provide benefits for a period of approximately 2 years or by the year ended December 31, 2026, assuming collection from the contributing employer of withdrawal liability which has been incurred by the Employer. Federal law requires that certain benefits other than nonforfeitable benefits under the Plan be reduced or eliminated.

Whether all participants receive their benefits will depend on the sufficiency of the Plan’s net assets available to provide those benefits, the priority of those benefits to be paid, and the level and type of benefits guaranteed by the PBGC at that time. Some benefits may be fully or partially provided by the then existing plan assets and the PBGC guaranty, but other benefits may not be provided at all.

**NOTE 1. DESCRIPTION OF PLAN (continued)**

**General Description** - The following description of the Plan provides general information only. Participants should refer to the plan documents for more complete information.

The Plan has three sub-plans. The sub-plans are defined by the plan documents as follows:

Plan A - Any participant who is not covered by Plan B benefits or Plan C benefits.

Plan B - Any participant who was employed by one of the participating Employers on or after December 31, 1965 and who was, at the time of retirement or other time of reference, in a bargaining unit as defined in a collective bargaining agreement between any participating Employer and any of the following unions:

- Boston Newspaper Printing Pressmen's Union, Local #3
- Graphic Communications International Union, Local #600
- Paper, Allied-International, Chemical and Energy Workers International Union (PACE), PACE Local 1-366, and prior to January 4, 1999 The Oil, Chemical and Atomic Workers International Union, Quincy Local #8-366 (formerly Oil Workers International Union, Local #542)
- Paper Handlers, Plate Handlers and Press Clerks (formerly a separate Local #21) and now represented by Boston Newspaper Printing Pressmen's Union, Local #3
- Boston Printing Pressmen's Union, Local #67
- International Brotherhood of Carpenters, AFL-CIO, Local #40
- Local #11, Boston, MA, Brotherhood of Painters, Decorators and Paperhangers, AFL-CIO
- Local #537, Boston, MA, United Association of Journeymen, Plumbers & Pipefitters, AFL-CIO
- Local Union #12, Boston, MA, United Association of Journeyman, Plumbers & Pipefitters

Plan C - Any active participant who was employed by one of the participating Employers on or after June 30, 1968 and who was, at the time of retirement or other time of reference, in a bargaining unit as defined in a collective bargaining agreement between any participating Employer and the Boston Newspaper Chauffeurs, Distributors and Helpers, Local Union #259. Effective on and after November 10, 1978, such employees ceased to be, and may no longer become, participants covered by the Plan. In addition, the Plan transferred the plan assets associated with the accrued benefits of the Plan C participants, retirees and beneficiaries as well as the related obligations to United Omaha Life Insurance Company in 2006 through the purchase of a Nonparticipating Single Premium Group Annuity Contract.

**Benefits** - The benefits are payable in amounts determined based upon length of service up to a maximum as defined in the plan documents. Covered employees and, if elected, their beneficiaries receive monthly benefits for life upon normal or early retirement or upon disability as defined in the plan documents. Death benefits in the amount of \$1,000 are provided for retired employees under a group life insurance policy. Premiums on the death benefit policy are paid by the Plan. Life insurance benefits were eliminated from the plan effective June 30, 2011.

**NOTE 1. DESCRIPTION OF PLAN (continued)**

**Vesting** - All participants became fully vested on January 3, 2010.

**Administrative Expenses** - The Plan pays all administrative expenses.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Method of Accounting** - As a result of the Plan termination, the Plan's financial statements have been prepared using the liquidation basis of accounting.

**Use of Estimates** - The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Withdrawal Liability Contributions** - The Plan assesses withdrawal liability to employers who have withdrawn from the Fund in accordance with plan provisions and related regulations. Amounts assessed as withdrawal liability are recorded as a receivable when collection of the assessment appears reasonably assured. An allowance for credit losses are established if collection becomes uncertain based on payment history and specific credit considerations. The Plan believes that the receivables are fully collectible; therefore, no allowance for credit losses is recorded.

**Investment Valuation and Income Recognition** - The Trustees have appointed investment managers and an investment custodian. Subject to an investment policy adopted by the Trustees, the investment managers have discretionary authority concerning purchases and sales of investments, which consist of registered investment companies, common trust funds, and cash equivalents. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investment bought and sold as well as held during the year.

**Benefits** - Benefits to participants are recorded upon distribution.

**NOTE 3. ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS**

Accumulated plan benefits are those future periodic payments that are attributable under the Plan's provisions to the service participating employees have rendered as of the valuation date. Accumulated Plan benefits include benefits expected to be paid to (a) retired or terminated employees and, if elected, their beneficiaries and (b) present employees.

The actuarial present value of accumulated plan benefits is determined by The Segal Company and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payments (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

**NOTE 3. ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS (continued)**

As a result of the Plan's termination the actuarial present value of accumulated plan benefits has been calculated under a liquidation assumption.

Previously the Plan used the beginning of the year actuarial valuation date. For the current year, the Plan is using the end of the year actuarial valuation date.

The foregoing actuarial assumptions reflect the mass withdrawal that occurred on January 3, 2010. As more fully discussed in Note 1, all benefit accruals under the Plan have ceased.

**NOTE 4. TAX STATUS OF THE PLAN**

The Plan is qualified under Section 401(a) of the Internal Revenue Code and the related trust is exempt from federal income tax under Section 501(a).

The Plan obtained its latest determination letter dated September 14, 2017, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the “Code”).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5. RISKS AND UNCERTAINTIES**

The Plan invests in various investments. Investments, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonable possible that changes in the values of investments will occur in the near term and such changes could materially affect the amounts reported in the Statements of Net Assets in Liquidation Available for Benefits.

The withdrawal liability and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**NOTE 6. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions qualify as party in interest transactions under ERISA.

## NOTE 7. INVESTMENTS AT FAIR VALUE

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

### Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used. There have been no changes in the methodologies used at December 31, 2024 and 2023.

### *Registered investment companies*

- These Investments are public investment vehicles valued based on the shares of interest held by the Plan. The share value is based on the quoted price at the end of the day on the active market in which the individual registered investment companies are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
