## Union Bank and Trust Company Welfare Benefits Plan Notes to Financial Statements

### NOTE 1 - PLAN DESCRIPTION

The following description of the Union Bank and Trust Company Welfare Benefits Plan (the "Plan") provides only general information. Participants should refer to the Plan document and summary Plan description for a more complete description of the Plan's provisions, which are available from the Plan Sponsor.

#### **Organization**

The Plan is a health and welfare benefits plan sponsored by Union Bank and Trust Company (the "Sponsor" and "Trustee") and its affiliates and subsidiaries who have adopted the Plan. The Plan has several participating employers; however, it operates as a single employer sponsored plan. The Plan is not a multiple employer welfare arrangement (MEWA). The Plan and related trust were established on January 1, 2010, and together constitute a voluntary employees' beneficiary association (VEBA) within the meaning of Section 501(c)(9) of the Internal Revenue Code of 1986, as amended. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Sponsor serves as the Plan administrator and has engaged Meritain Health and Ameritas (the "Plan Supervisors") to provide third-party administrative services for the Plan.

#### **Eligibility**

The Plan provides health benefits (medical and dental) to full-time employees of the Sponsor (those who are regularly scheduled to work at least 30 hours per week) and to their beneficiaries and covered dependents.

#### **Contributions**

To the extent permitted by law, the Sponsor is free to determine the manner and means of funding the Plan. Currently, the Sponsor has the objective of funding the Plan from approximately 30% participant contributions and approximately 70% employer contributions. The Sponsor is responsible for ensuring the funding of the Plan and makes additional contributions sufficient to cover actual Plan costs if necessary.

#### **Benefits**

The Plan provides medical, dental, health screenings and prescription drugs benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

#### **Stop Loss Coverage**

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits. This includes individual participant claims over a specific dollar amount as well as its aggregate exposure for all claims.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Plan are presented under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### **Contributions**

Contributions from Plan participants and the contributions from the Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

#### **Administrative Expenses**

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, the Trustee, and actuary. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

#### **Payment of Benefits**

Premiums paid by either the Sponsor or the Employee participants are recorded as insurance premiums paid for health benefits in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. These payments are recorded as benefits paid for participants in the accompanying statement of changes in net assets available for benefits.

#### **Stop Loss**

Premiums for stop loss insurance are included in insurance premiums paid for health benefits in the accompanying statement of changes in net assets available for benefits. Stop loss refunds totaling \$1,589,896 have been included as reinsurance recoveries in the accompanying statement of changes in net assets available for benefits.

#### **Prescription Rebates**

Prescription drug rebates are recorded in the period to which the related claims were paid and are reported as other income.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

#### Plan Benefit Obligations

Plan obligations at December 31, 2024 and 2023 for medical and dental claims incurred by active participants but not reported at that date, are estimated by the Plan's actuary in accordance with accepted actuarial principles. Such estimated amounts are reported in the accompanying statements of benefit obligations.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Sponsor to make estimates and assumptions that affect certain reported amounts and disclosure. Accordingly, actual results could differ from those estimates.

#### Subsequent Events

Subsequent events were evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

### NOTE 3 - CERTIFICATIONS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and investment income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Union Bank and Trust Company.

### NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable or substantially the full term of the asset or liability.

**NOTE 4 - FAIR VALUE MEASUREMENTS (CONTINUED)**

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Fund:* Valued at the daily closing price as reported by the fund. The money market fund held by the Plan is an open-end mutual fund registered with the SEC. This fund is required to publish their daily net asset value (NAV) and to transact at that price. The money market fund held by the Plan is deemed to be actively traded.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor, has the right, under the Plan, to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

### **NOTE 6 - TAX STATUS**

The VEBA trust funding certain benefits of the Plan received an exemption letter from the IRS dated November 10, 2011, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the IRC. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 7 - RELATED-PARTY TRANSACTIONS**

Certain Plan assets may be invested in a common trust fund managed by the custodian of the Plan. As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions are party in interest transactions under ERISA. Union Bank and Trust Company (the "Agent") agrees to maintain an agency account referred to as the UB&T Company Welfare Benefits Trust Investment Agency. The Agent may retain assets held in the Account and is authorized to sell, settle or transfer any securities to a depository or safekeeping. The Agent shall be paid a fee in accordance with the current published fee schedule. No fees paid by the Plan for the investment management services were incurred in 2024 and 2023.

### **NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would-be material to the financial statements.
