Note 1 - Plan Description

The following description of FEV North America, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that provides benefits to eligible employees of FEV North America, Inc. (the "Company"), as determined according to the provisions of the plan agreement. Employees, other than interns, are eligible to participate in the Plan after reaching the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Contributions to the Plan are invested as directed by the participants into various investment options offered by the Plan. Participant contributions to the Plan are subject to the limits defined by the Internal Revenue Code. Contributions can be made on a pretax or after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. The Plan provides for a fixed employer contribution based on 5 percent of each participant's compensation. The Plan also provides for an employer discretionary contribution, provided that the total of all employer contributions does not exceed limitations imposed by the Internal Revenue Code. There were no discretionary contributions for 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions, rollover contributions, the Company's contributions, and actual earnings thereon.

Participant Notes Receivable

Participants may borrow money from the Plan up to the lesser of \$50,000 or half of their account balances, as prescribed in the Plan and in the Internal Revenue Code. Participant notes receivable must have a term of no longer than five years, unless for a primary residence. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate. Additionally, participants may not have more than two participant notes receivable outstanding at any one time.

Payment of Benefits

Upon termination of service, a participant can receive his or her account balance in a lump-sum amount. In the event of an employee's death, the entire account balance can be paid to the participant's named beneficiary.

Hardship Withdrawals

Participants may request that all or a portion of their accounts be distributed in the case of a financial hardship, as defined in the Internal Revenue Code.

Note 1 - Plan Description (Continued)

Transfer Out

During 2024, the Company sold its Software and Testing Solutions North America, LLC division (STS) to an unrelated third party. As a result, participant account balances and participant notes receivable totaling \$6,002,300 were transferred out of Plan.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive unallocated investment contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. Refer to Note 4 for additional information.

The common/collective trust fund and pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. Mutual funds are valued based on quoted market prices. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Party-in-interest Transactions

Certain plan investment assets are in investment funds managed by Principal Life Insurance Company (Principal Life), Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust), and Principal Global Investors Trust Company (Principal Global) or their affiliates. Principal Life, Principal Trust, and Principal Global are the custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Certain administrative expenses of the Plan were paid by the Company during 2024. These transactions also qualify as party-in-interest transactions.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 29, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Principal Life, Principal Trust, and Principal Global hold the Plan's investments and execute all related transactions. The investment balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information provided by Principal Life; Principal Trust; and Principal Life, on behalf of Principal Global.

Note 4 - Unallocated Investment Contract

The Plan has a benefit-responsive unallocated investment contract with Principal Life Insurance Company. Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting. When establishing interest crediting rates for this product, Principal Life considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

As described in Note 2, because the contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Note 5 - Fair Value Measurements (Continued)

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
