### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Monteith Construction Corp. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. PLAN DESCRIPTION:

The following description of the Monteith Construction Corp. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is sponsored by Monteith Construction Corp. (the Employer).

**General** - The Plan is a defined contribution retirement savings plan under Section 401(k) of the Internal Revenue Code and covers all full-time employees who have attained 21 years of age and have one year of service. Plan entry dates are monthly. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is not covered by the Pension Benefit Guarantee Corporation (PBGC). Additionally, the Plan assets have no other form of insurance. The Plan provides several investment options, all of which are participant directed.

**Contributions** – Salary deferral contributions may be made by all eligible employees. Salary deferral contributions shall not exceed amounts prescribed by the Secretary of the Treasury. Contributions in excess of allowable amounts are refunded to the participant. Employer matching contributions equal a percentage as determined annually by the Employer. Additional discretionary contributions may be contributed to the Plan at the Employer's discretion. No such contributions were made during the year ended December 31, 2024.

**Participant accounts** - Each participant's account is credited with the participant's contributions, the allocation of the Company's contributions, if any, and plan earnings and charged with benefits payments and allocations of plan losses and administrative expenses. Allocations are based on participant earnings or account balances as defined in the Plan. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Each participant is immediately 100 percent vested in his or her salary deferred contribution, Employer's contributions and related earnings.

**Investment options** – Participants direct the investment of their accounts into various investment options offered by the Plan.

**Benefit payments** – On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installment and annuity options as provided by the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If the vested account is not more than \$5,000, the vested account will be paid to the participant in a single lump sum. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59 ½.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

**Basis of accounting** – The financial statements of the Plan have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investments** – Investments are reported at fair value. See Note 3 for discussion of fair value measurement. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual the ex-dividend date. Net appreciation / depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions** – Contributions are reported in the year services are rendered to the Company by the Plan participants.

**Payment of benefits** – Benefits are recorded when paid.

**Administrative expenses** – The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to administration of notes receivable from participants and distributions are charged directly to the respective participant's account.

### 3. FAIR VALUE MEASUREMENTS:

The Fair Value Measurements Topic of the Financial Accounting Standards Board Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in active markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Pooled Separate Accounts (PSAs):* Assets allocated to the separate accounts held by the Plan include stocks (both domestic and foreign) and mutual funds. The trustee, Principal Life Insurance Company, owns the underlying investments in the separate accounts. The Plan owns units of participation in the separate accounts. The fair value of the underlying investments is used in determining the net asset value (NAV) of the pooled separate account. The NAV is available to current investors through Principal's website or to Plan participants by access to their account values. NAV is the basis for current transactions and redemptions as of the measurement date.

*Common Collective Investment Trusts* – Assets allocated to the common collective investment trust held by the Plan include mutual funds, pooled separate accounts and other common collective investment trust. The trustee, Principal Life Insurance Company, holds the underlying investments in trust for the Plan. The Plan owns units of participation in the fair value of the trust's underlying assets. The fair value of the underlying investments is used in determining the net asset value (NAV) of the common collective investment trust. The NAV is available to current investors through Principal's website or to Plan participants by access to their account values. NAV is the basis for current transactions and redemptions as of the measurement date.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. PLAN TERMINATION:**

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their accounts.

### 6. INCOME TAXES:

The Plan is adopted from a Prototype Plan. An opinion letter was issued by the National Office of the Internal Revenue Service as evidence of the acceptability of the form of the Prototype Plan under Code Section 401. An employer who accepts the Prototype Plan will be considered to have a qualified plan only if the conditions of the Prototype opinion letter are satisfied.

The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more than likely would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations prior to 2021.

### 8. PARTIES-IN-INTEREST:

Certain plan investments are managed by the Principal Life Insurance Company, the trustee of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to the trustee by the Plan for administrative services were approximately \$30,000 for the year ended December 31, 2024.

**9. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**10. SUBSEQUENT EVENTS:**

Events and transactions occurring after December 31, 2024 have been evaluated to determine proper recognition and disclosure in the financial statements. Subsequent events and transactions were evaluated through September 30, 2025, which represents the date the financial statements were available to be issued.
