NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following is a brief description of the F.G. Downing Development, Inc. 401(k) Plan (the Plan) provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with salary reduction features as permitted under section 401(k) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent legislation, where applicable. The Plan is funded by employee and discretionary employer contributions. The Plan covers all employees of F.G. Downing Development, Inc., Towne Ford, Inc., Towne Chrysler Plymouth Jeep, Inc., and Towne Chevrolet Buick Cadillac, Inc. (collectively, the Company and Plan Sponsor). The assets of the Plan are maintained in a group annuity contract held by Principal Life Insurance Company as custodian and registered investment funds held by Principal Trust Company as custodian (collectively Principal).

Eligibility

All employees of the Company are eligible to participate in the Plan for purposes of employee deferrals the month following completion of 30 days of service. All employees who have completed one year of service, as defined, and are active participants on December 31 are eligible to receive employer contributions.

Contributions

Participants may authorize an elective contribution rate ranging from 1% of compensation up to the maximum annual limitations as provided by the Internal Revenue Code (IRC). A Roth 401(k) feature is also available under the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company may make discretionary employer matching contributions, and elected to contribution an amount equal to 25%, up to 4% of compensation, for the years ended December 31, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Additionally, the Plan Sponsor makes discretionary profit-sharing contributions. There were no discretionary profit sharing contributions for either of the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, if any, (b) Plan earnings/losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan. Participants may change their investment allocation on a daily basis.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately 100% vested in their elective contributions plus actual earnings/losses thereon. Participants are 20% vested in employer contributions after two years of service, as defined, with a 20% annual increase in each of the next four years.

Forfeitures

Forfeitures of nonvested separated participants may be used to offset plan administrative costs or reduce employer matching contributions. Forfeitures used to reduce employer matching contributions were \$6,556 and \$4,642 for the year ended December 31, 2024 and 2023, respectively. Forfeitures available at December 31, 2024 and 2023 were \$13 and \$686, respectively.

Administrative Expenses

Investment fees are paid by the Plan. Certain other administrative expenses are paid by the Plan Sponsor.

Withdrawals and Distributions

Unless a participant elects otherwise, distributions will be made as soon as practical after a participant's normal retirement date or actual retirement date occurs. The normal retirement date is the date upon which a participant reaches age 65. Participants may elect early retirement if they have attained age 55 and completed six years of service, as defined. Hardship distributions may be taken from a participant's vested account balance, subject to certain limitations.

Participants may receive their accumulated vested benefits held by the Plan's trustee upon termination of employment or elect to keep their vested balance in the Plan until the earlier of normal retirement age, death, or disability if their account balance is below \$1,000. If the participant elects to keep his or her vested interest in the Plan, the participant's account will continue to receive its allocable share of earnings and losses.

Participants may normally elect to withdraw their funds from the Plan upon termination of service, death, disability, attaining age 59½, or earlier in the event of financial hardship. Benefits are recorded when paid.

Notes Receivable from Participants

Participants may borrow a minimum amount of \$1,000 and a maximum amount of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with the applicable federal monthly rate as calculated by the Internal Revenue Service and as determined by the Plan Administrator. The loans are collateralized by the balance in the participant's account and bear interest at the prime interest rate plus 1%. Principal and interest are paid ratably through payroll deductions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires the Plan to make estimates and assumptions that affect certain amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying financial statements.

Valuation of Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold or held during the year.

Income Taxes

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

3. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Principal. Principal is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

Notes receivable from participants of \$312,441 and \$285,201 as of December 31, 2024 and 2023, respectively, also qualify as party-in-interest.

4. FINANCIAL CERTIFICATION

The following financial information relating to the Plan's assets at December 31, 2024 and 2023, as well as investment income and investment transactions for the years then ended, has been derived from information provided by Principal, a qualified institution and the custodian of the Plan's assets, and has been certified by them as complete and accurate.

5. FAIR VALUE MEASUREMENTS

The Plan uses various valuation techniques in determining fair value. ASC Section 820 established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

5. FAIR VALUE MEASUREMENTS (Continued)

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Pooled Separate Accounts (other than the U.S. Property Separate Account):* Valued at net asset value ("NAV"). Invest in domestic stocks, international stocks, and fixed securities, such as asset or mortgage-backed securities and corporate bonds, and in mutual funds that hold such investments. The net asset values of the pooled separate accounts are not publicly quoted. The values of the underlying investments are used in determining the net asset value of each separate account. Underlying equity securities have observable quoted pricing inputs. Underlying fixed securities have observable pricing inputs, including quoted prices for similar assets in the active or non-active markets. Underlying mutual funds are valued at publicly quoted pricing inputs. The pooled separate accounts do not have any unfunded commitments relating to their investments, nor any restrictions on redemptions. Participant-directed redemptions can be made daily and do not have a redemption notice period.
- *U.S. Property Separate Account:* Valued at NAV. Invests mainly in commercial real estate and includes mortgage loans which are backed by the associated properties. The investment is valued based on discounted models which utilize information from brokers on market rents and sales comparables for similar assets as well as applicable cash flows generated by the property. This pooled separate account does not have any unfunded commitments relating to its investments, nor any significant restrictions on redemptions. Each property is appraised by a third party appraiser annually.
- *Common/Collective Trusts:* Valued at NAV. Contain investments in a collective trust fund as well as a variety of separate accounts and mutual funds. The fair value of the collective trust fund and the separate accounts are not publicly quoted pricing inputs. The fair value of the mutual funds are publicly quoted pricing inputs. The fair value of all these investments are used in determining the NAV of the common/collective trust, which is not publicly quoted. The common/collective trusts can be redeemed at NAV as of the measurement date.

5. FAIR VALUE MEASUREMENTS (Continued)

The underlying investments are valued as follows; the fair value of conventional investment contracts is determined using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end. The fair value of conventional investment contracts is determined using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end. Individual assets of the synthetic investment contract are generally valued at representative quoted market prices. Short-term securities, if any, are stated at amortized cost, which approximates market value. Debt securities are valued on the basis of valuations furnished by a pricing service approved by the Trustee, which determines valuations using methods based on market transactions for comparable securities and various relationships between securities which are generally recognized by institutional traders. Accrued interest, if any, on the underlying investments is added to the fair value of the investments for presentation purposes. The common/collective trusts can be redeemed on a daily basis and there are no restrictions. There are no unfunded commitments.

- *Registered Investment Funds:* Values are determined based on quoted market prices in active markets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
