### ***Scope and Nature of ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements***

We have performed an audit of the financial statements of the Vizance, Inc.-401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and December 31, 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) (pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and December 31, 2023 and for the year ended December 31, 2024, stating that the certified investment information (as described in Note 3 to the financial statements) is complete and accurate.

### ***Opinion on the 2024 Financial Statements***

In our opinion, based on our audit and the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report:

- the amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying 2024 financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### NOTE 1 - Description of the Plan

---

##### **General**

The following description of the Vizance, Inc. 401(k) Profit Sharing Plan (the "plan") provides only general information. Participants should refer to the plan document for a more complete description of the plan's provisions.

The plan is a defined contribution plan covering substantially all employees of Vizance, Inc. (the "company"), who have completed three consecutive months of service and are age twenty-one or older. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan's administrative committee is responsible for the oversight of the plan, determining the appropriateness of the plan's investment offerings and monitoring investment performance.

The plan's federal identification number is 39-1309381, and the plan's number is 001.

##### **Contributions**

Participants may contribute pretax elective deferrals and Roth elective deferrals to the plan. The combined pretax and Roth elective deferrals are subject to the annual Internal Revenue Service limit. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The company makes a matching contribution of a discretionary amount, currently 100% of participant contributions up to 3% of participant compensation plus: 50% of participant contributions that exceed 3% of compensation but does not exceed 5% of compensation. Additional profit sharing amounts may be contributed at the option of the company's board of directors. During the years ended December 31, 2024 and 2023, the company made no elective profit sharing contributions to the plan. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

##### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. Amounts forfeited from a participant's account shall be used to restore forfeitures or reduce company contributions, or to pay reasonable plan expenses.

##### **Transfers from Qualified Plans (Rollovers)**

At the discretion of the plan administrator, participants may be permitted to deposit distributions received from other qualified plans into the plan. Such a deposit is referred to as a "rollover". Participants are always 100% vested in their "rollover" account.

#### **NOTE 1 - Description of the Plan -continued**

---

##### **Participant Accounts**

Participant accounts are allocated to the various investment options offered by the plan, as directed by the participants.

Each participant's account is credited with the participant's contribution, along with an allocation of the company discretionary matching contribution, discretionary nonelective contribution, and plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the plan. Allocations are based on participant compensation, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are vested immediately in their contributions and company matching contributions, plus actual earnings thereon. Vesting in the company's profit sharing contributions is based on years of service. Participants become 20% vested after completing two years of service and are vested at an additional 20% for each year of additional service up to six years of service, at which time participants are fully vested. However, upon the participant's death or disability, all amounts are immediately vested.

##### **Benefits**

On termination of service due to death, disability, retirement (age 65), or termination of service due to other reasons, a participant with an account balance less than \$1,000 shall receive a lump-sum distribution. For accounts exceeding \$1,000, the participant may elect to receive a lump-sum distribution or installment payments, or may elect to defer such distribution to any valuation date subsequent to his/her termination (but no later than the valuation date of his/her normal retirement date). The participant may otherwise elect to rollover the distribution to another qualified plan. The plan permits in-service distributions at age 59 ½. The plan also permits hardship distributions if certain criteria are met.

##### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms generally range from one to five years. The loans are secured by the vested balance in the participant's account and bear interest at a commercially reasonable rate of interest. Principal and interest is paid ratably through semi-monthly payroll deductions.

#### **NOTE 2 - Summary of Significant Accounting Policies**

---

##### **Basis of Accounting**

The financial statements of the plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the plan.

##### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

The plan's investments (except for fully benefit-responsive investment contracts, which are reported at contract value) are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's Administrative Committee determines the plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net includes the plan's gains and losses on investments bought and sold as well as held during the year.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the plan are paid directly by the company and are excluded from these financial statements. Investment-related expenses are included within net appreciation of fair value of investments.

##### **Subsequent Events**

These financial statements have not been updated for subsequent events occurring after October 1, 2025, which is the date these financial statements were available to be issued. The plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

#### **NOTE 3 - Information Certified by the Asset Custodians (UNAUDITED)**

The December 31, 2024 and 2023 Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the asset custodians, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The information certified was prepared on the cash basis and includes total investments of \$20,387,025 and \$15,128,427 and total notes receivable from participants of \$164,700 and \$129,999 at December 31, 2024 and 2023, respectively; and related increase in net assets available for benefits of \$5,293,299 for the year ended December 31, 2024.

---

#### **NOTE 4 - Fair Value Measurements**

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets in active markets that the plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- > quoted prices for similar assets or liabilities in active markets;
- > quoted prices for identical or similar assets or liabilities in inactive markets;
- > inputs other than quoted prices that are observable for the asset or liability;
- > inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

#### NOTE 4 - Fair Value Measurements (cont.)

The plan sponsor is responsible for the determination of fair value and accordingly performs periodic analysis on the prices received from the pricing services used to determine whether the prices are reasonable estimates of fair value. As a result of these reviews, the plan sponsor has not historically adjusted the prices obtained from the pricing services. The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following is a description of the valuation methodologies used for assets measured at fair value. There has been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

*Collective Trust Funds*: Valued based on the NAV of units of the common and collective trust funds. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when its determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### **NOTE 5 - Guaranteed Investment Contract with Insurance Company (UNAUDITED)**

---

The plan entered into a traditional benefit-responsive investment contract with Empower Annuity Insurance Company of America, which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan.

Because the guaranteed investment contract meets the criteria to be fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus: earnings, less: participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$32,097 and \$623,681 respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting. The actual average yield earned by the plan for the benefit responsive fund can be derived by averaging the plan's quarterly interest rates. That average for 2024 is 1.43% and for 2023 is 1.28%.

Certain events limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) the plan sponsor offers a competing fund without Empower Annuity Insurance Company of America's agreement, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) closing or disruption of financial markets or exchanges. The plan administrator does not believe that any events which would have limited the plan's ability to transact at contract value with participants are probable of occurring.

Either party to the guaranteed investment contract may terminate the contract with at least 60 days advanced written notice to the other party.

---

#### **NOTE 6 - Party-in-Interest Transactions**

---

Certain plan investments were managed by Empower Trust Company, LLC as of December 31, 2024 and 2023. As custodian of the plan, these transaction qualify as party-in-interest transactions. These are not considered prohibited transactions under ERISA.

The plan contracts with Empower Retirement, LLC as its asset custodian; Empower Trust Company, LLC and Empower Annuity Insurance Company of America, as its recordkeeper; and Blue Chip Retirement Plans, Inc. as its third-party administrator (TPA). Administrative fees paid by the plan to the custodian and TPA totaled \$89,706 and \$76,316 for the years ended December 31, 2024 and 2023, respectively; all of which qualify as party-in-interest transactions.

#### **NOTE 7 - Tax Status**

---

The company adopted a volume submitter profit sharing plan with cash or deferral arrangement which received a favorable opinion letter dated March 31, 2014, stating that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified and the related trust is tax-exempt.

---

#### **NOTE 8 - Plan Termination**

---

Although it has not expressed any intent to do so, the employer has the right under the plan to discontinue their contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their allocated company nonelective contributions.

---

#### **NOTE 9 - Concentration of Market Risk**

---

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is as at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Changes of Net Assets Available for Benefits.
