Notes to Financial Statements

Year Ended December 31, 2024

1. Description of plan:

The following description of the Intergalactic, Inc. DBA Bookmans Retirement Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was established January 1993, and has been amended several times since that date.

General:

The sponsor of the Plan is Intergalactic, Inc. dba Bookmans (Sponsor or Company). The Plan is a defined contribution plan covering all employees of the Sponsor who are at least 18 years of age. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

Participants' contributions:

Under the 401(k) provisions of the Plan, the participants can elect to defer up to 100% of their pretax compensation, subject to current statutory limits determined annually and prescribed by the Internal Revenue Service (IRS). In addition, the Plan also permits eligible participants to make additional voluntary Roth contributions and qualified rollovers from other retirement plans.

Employer contributions:

The Plan adopted safe harbor provisions, stating that the employer will allocate to each participant's matching account an amount equal to 100% of the participant's elective deferrals, up to 4% of the participant's compensation. Employees must complete one year of service (defined as working 1,000 hours during a 12 month period) in order to be eligible to receive the safe harbor contribution.

The employer may also make discretionary profit-sharing contributions. Employees must be employed on the last day of the Plan year or complete at least 499 hours of service during the Plan year in order to receive a discretionary employer contribution. There were no discretionary profit-sharing contributions made during the current Plan year.

Employer contributions are invested in the same funds and increments as directed by the participant for the participant's contributions.

Participant accounts:

Each participant's account is credited with the participant's elective deferral, employer and rollover contributions, actual earnings thereon, and charged with an allocation of administrative expenses. The basis for allocations is defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their total account, including elective deferral contributions, safe harbor contributions, employer contributions and any rollover contributions made to the Plan, plus actual earnings thereon.

1. Description of plan (continued):

Investment options:

Upon enrollment in the Plan, a participant may direct contributions in any increments into any of several investment options. Participants may change their investment options at any time.

Participants' loans:

The Plan allows for participants to obtain loans from the Plan. All loans require written spousal consent, cannot exceed 50% of the vested portion of the participant's account (or \$50,000 if less), and must be a minimum of \$500. The loan must be repaid within five years and will provide for the repayment of interest at rates commensurate with local prevailing rates, as determined by the Plan Administrator, on the date of the loan. Principal and interest may be paid through payroll deduction. The participant's individual account serves as collateral for the loan. Loans will be considered in default if payments are not made for 90 days or if there is any outstanding principal remaining after the last scheduled repayment date. Upon default, death, disability or termination of employment, the entire outstanding principal and accrued interest shall be immediately due and payable. Because the participant's account collateralizes the loan in its entirety, the credit quality of the participant is not assessed by the Plan Administrator. Unpaid loans will be treated as a taxable distribution from the Plan.

For financial reporting purposes, participants' loans are included in the statement of net assets available for benefits as notes receivable from participants.

Payment of benefits:

On termination of service due to death, disability, retirement, or election at age 62, a participant whose vested account balance exceeds \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his/her account, or installments under a systematic withdrawal plan. Participants with account balances less than \$5,000 must take a lump sum distribution as soon as practicable following termination. The Plan requires mandatory distributions in excess of \$1,000 be automatically rolled over to an individual retirement account (IRA) established on behalf of participants who do not affirmatively consent to receive their distributions.

Hardship withdrawals:

If approved by the Plan Administrator, a participant may withdraw the vested portion of his/her individual account balance to satisfy any of the following immediate and heavy financial needs: unreimbursed medical expenses for qualified persons, purchase of a principal residence, to prevent eviction from or foreclosure on a principal residence, to pay for post-secondary education expenses for qualified persons, funeral or burial expenses for qualified persons, for expenses that qualify as a casualty deduction under the Internal Revenue Code (IRC), or expenses or losses incurred on account of a federally declared disaster. Prior to receiving a hardship withdrawal, a participant must first exhaust all other options.

2. Summary of significant accounting policies:

Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in fair value of investments includes both realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of benefits:

Benefits paid to participants are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid for by the Sponsor. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events:

The Plan has evaluated the events that have occurred subsequent to December 31, 2024 through September 25, 2025, the date that the financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

3. Federal income tax status:

The Sponsor adopted a standardized pre-approved profit sharing plan with CODA as published by Principal Life Insurance Company, who obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Sponsor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets or active markets that the Plan does not have access to;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Registered investment companies: These funds are valued at the closing price reported in the active market in which the individual securities are traded.

Common/collective trusts: These trusts' assets are invested and reinvested primarily in mutual funds and separate accounts. The Plan also holds an investment in the Principal Stable Value Z Fund. The Principal Stable Value Z Fund is 100% invested in the Morley Stable Value Fund, which invests in conventional, synthetic and separate account investment contracts. The funds are valued at the net asset value of units of the trust. The net asset value of the funds' shares is determined daily and includes adjustments for investment fees. The funds' daily net asset value is available at www.principal.com.

Pooled separate accounts: These accounts' assets are invested and reinvested primarily in mutual funds, other pooled separate accounts, international stocks, fixed equities, short-term securities, and domestic stocks. Investments are valued using quoted market prices for similar assets in active or non-active markets. The fair value of the accounts has been estimated using their net asset value. The net asset value of the accounts' shares is determined daily and includes adjustments for investment fees. The funds' daily net asset value is available at www.principal.com.

4. Fair value measurements (continued):

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investments:

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company, collectively "Principal".

6. Related party and party in interest transactions:

Certain Plan investments are managed by Principal, the recordkeeper of the Plan. The Plan paid certain expenses to Principal and other service providers during 2024 related to plan administration and investment activity. These transactions qualify as exempt party in interest transactions under ERISA.

Expenses that are paid directly by the Sponsor are excluded from these financial statements. Employees of the Sponsor perform certain accounting and administrative functions for the Plan, however, no employee receives compensation from the Plan.

7. Plan termination:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
