(1) Description of Plan

The following description of Sentry Management, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

(a) General

Sentry Management, Inc. 401(k) Profit Sharing Plan (the “Plan”) is a defined contribution plan covering all eligible employees of Sentry Management, Inc. (Sentry or the Company).

The Plan was adopted effective January 1, 2007. Employees of the Company are eligible to become participants in the Plan upon completion of six months of service and when 21 years of age or older and have completed 500 hours of service within the twelve-month period following employment. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and various provisions of the Internal Revenue Code.

(b) Contributions

Under the Plan, eligible participants may elect to contribute, on a tax deferred basis, a portion of their annual compensation for the year, subject to IRS limitations. In addition, the employer may also make a discretionary profit-sharing contribution. Employees elect the investment vehicle(s) in which their funds and employer matching contributions are invested.

(c) Vesting

Vesting in Sentry’s contribution portion of participants’ actual accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in the employer matching contribution after six years of credited service.

(d) Forfeitures

Forfeitures may be used to reduce subsequent Company contributions. During the year ended December 31, 2024 forfeitures in the amount of \$1,402 were used to reduce Company contributions.

(d) **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(e) **Payments of Benefits**

Upon termination of service, a participant may receive the value of the participant's vested interest in his or her account in a lump-sum amount or in installments.

(g) **Participant Loans**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at 4%, which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

(2) **Summary of Significant Policies**

(a) **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting and present the net assets available for benefits and changes in those assets.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Statements of Net Assets Available for Benefits presents the fair value of the investment contracts as well as the adjustment of the fully benefit-responsive investment contracts from fair value to contract value.

(b) **Notes Receivable from Participants**

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

(c) **Valuation of Investments**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

(d) **Payment of Benefits**

Benefits are recorded when paid.

(e) **Tax Status**

The Plan has received a favorable IRS determination letter. The Plan Administrator believes the Plan is operating in accordance with its provisions and is exempt from federal income tax.

(f) **Use of Estimates**

Management of the Plan has made certain estimates and assumptions relating to the reporting of assets and liabilities and the disclosure of contingent assets and liabilities to prepare these financial statements in conformity with generally accepted accounting principles. Actual results could differ from those estimates.

(g) **Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values.

(g) **Fair Value Measurements - Continued**

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No level 2 inputs were available to the Plan, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. All investments are held in mutual funds and were valued using Level 1 inputs at December 31, 2024 and 2023.

(h) **Date of Management's Review**

Subsequent events were evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

(3) **Investments**

Upon enrollment in the Plan, participants can elect to invest their contributions into the available Voya investment vehicle. Voya is the sole custodian for the participant directed funds. Employer matching contributions, as applicable, are invested into the Participants' accounts based upon the Participants' enrollment investment selection.
