NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 and 2023

A. Plan Description

The following description of the Cembell Industries, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Cembell Industries, Inc. and Albach Company, Inc. (the "Employers") who have one year of service and are age twenty-one or older. The entry date is the earlier of the first day of the Plan year or the first day of the seventh month of the Plan year coinciding with or following the date on which the eligibility requirements are met. The Plan is subject to the provisions of the Employer Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute by salary reduction pursuant to Section 401(k) of the Internal Revenue Code. During each Plan year, the Employers may make discretionary matching contributions for participants. Employers made no matching contributions to Plan participants during 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Employers' contributions, and earnings on the participant's annuity, and, where applicable, life insurance contracts. Each participant's account is charged with fees on the participant's annuity contract and life insurance premiums, where applicable, and with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employers' matching contribution portion of their accounts plus actual earnings thereon is as follows:

Investment Options

The Plan provides a participant-direct investment program whereby participants select for their account any of the investment options available under their individual annuity contract with John Hancock Life Insurance Company ("John Hancock"). The Plan currently offers several variable and guaranteed investment funds. Participants may change their investment options daily.

Payment of Benefits

On termination of service, a participant may receive a lump sum amount equal to the fair value of the participant's vested interest in his or her account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$392 and \$9,249, respectively. These accounts may be used to reduce the Employers' contributions or to offset administrative expenses. In 2024 and 2023, no forfeited non-vested accounts were used to reduce Employers' contributions. In 2024 and 2023, \$9,116 and \$0 of forfeited non-vested accounts were used to offset administrative expenses, respectively.

B. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan.

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are valued at fair value based on quoted market prices. Related investment fees are netted against investment earnings.

Operating Expense

At the discretion of the Employers, the Plan's direct administrative expenses can be paid by either the Employers or the Plan.

Payment of Benefits

Benefits are recorded when payable.

Date of Management's Review

Subsequent events were evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

C. Investments

On May 24, 2000, the Plan entered into a group annuity contract with John Hancock. John Hancock maintains the investments for each of the Plan's participants in pooled separate accounts. The accounts are credited with earnings on the underlying investments (principally mutual funds) and charged for participant withdrawals and administrative expenses charged by John Hancock. All investments are participant-directed.

The December 31, 2024 and 2023 *Statements of Net Assets Available for Benefits*, the investment activities included on the *Statement of Changes in Net Assets Available for Benefits* for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by John Hancock, the Trustee, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting Disclosure under ERISA. The information certified includes total investments and cash of \$8,917,443 and \$7,736,005 at December 31, 2024 and 2023, respectively, and related investment gain of \$1,460,802 for the year ended December 31, 2024.

D. Fair Value Measurements

U.S. Generally accepted accounting principles define fair value, establish a framework for measuring fair value, and establish a fair value hierarchy that prioritizes the inputs to valuation techniques. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

A fair value measurement assumes that the transaction to sell the asset or transfer the liability occurs in the principal market for the asset or liability or, in the absence of a principal market, the most advantageous market. Valuation techniques that are consistent with the market, income or cost approach are used to measure fair value.

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value into three broad levels:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities the Plan has the ability to access.
- Level 2 inputs are inputs (other than quoted prices included within level 1) that are observable for the asset or liability, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the asset or liability and rely on management's own assumptions about the assumptions that market participants would use in pricing the asset or liability. (The unobservable inputs should be developed based on the best information available in the circumstances and may include the Plan's own data.)

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 3 inputs were available to the Plan, and Level 2 inputs were only used when Level 1 inputs were not available.

- Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

- Level 2 Fair Value Measurements

The guaranteed investment contracts with an insurance company are not actively traded. Thus, the fair value of the guaranteed investment contracts is determined using a cost approach.

E. Plan Termination

The Employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. However, the Employers have not expressed any intent to terminate the Plan.

F. Tax Status

During 2016, 2019, and 2022, the Plan was amended. Although the amended Plan has not requested determination from the Internal Revenue Service ("IRS") as to the Plan's tax-exempt status, the IRS has informed the sponsor of the Prototype document adopted by the Employers, by an opinion letter dated June 1, 2015, that the Prototype Plan and Trust were in compliance with the applicable provisions of Section 401(a) of the Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and ERISA. Therefore, no provision for income taxes has been included in the Plan's financial statements.

G. Transactions with Parties-in-Interest

The Employers absorb some of the Plan's administrative, personnel, and audit fees. These costs are approximately \$8,000 per year. These amounts are not reflected in the accompanying financial statements. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

H. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the *Statement of Net Assets Available for Benefits*.
