### **The Board of Directors Abbott House 403(b) Plan**

We have conducted an audit of the financial statements and supplemental schedule (modified cash basis) of Abbott House 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employment Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C), as of and for the year ended December 31, 2024, and have issued our report thereon dated October 1, 2025. Professional standards require that we provide you with information about our responsibilities under auditing standards generally accepted in the United States of America, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our engagement letter to you dated January 9, 2025. This letter confirms our discussions and provides additional required communications related to our audit.

### **Our responsibility under professional standards**

However, as permitted by Section 103(a)(3)(C) of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the information summarized in Note 3 to the financial statements. Because of the significance of the information that we did not audit, we are unable to, and have not, expressed an opinion on the financial statements and supplemental schedule taken as a whole. We did, however, audit the form and content of the information included in the financial statements and supplemental schedule, other than that derived from the information certified by the trustee, in accordance with auditing standards generally accepted in the United States of America and found them to be presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Our audit included obtaining an understanding of the Plan and its environment, including internal control, sufficient to assess the risks of material misstatement of the financial statements and to design the nature, timing, and extent of further audit procedures. However, as part of the scope limitation discussed above, we did not consider internal control relating to the information prepared and certified to by the trustee. Material misstatements may result from (1) errors, (2) fraudulent financial reporting, (3) misappropriation of assets, or (4) violations of laws or governmental regulations, including prohibited transactions with parties in interest or other violations of ERISA rules and regulations, that are attributable to the Plan or to acts by management or employees acting on behalf of the Plan. Our audit did not identify any significant findings requiring communication to you.

The financial statements and supplemental schedule (modified cash basis) are the responsibility of management. Those individuals charged with governance of the Plan are responsible for the oversight of the financial reporting process, and our audit does not relieve management and those charged with governance of their respective responsibilities.

## **Qualitative aspects of significant accounting practices**

### *Significant accounting policies*

Plan management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. There have been no initial selection of accounting policies and no changes in significant accounting policies or their application during the reporting period that had a significant impact on the financial statements. No matters have come to our attention that would require us to inform you about (1) the methods used to account for significant unusual transactions, and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

### *Significant accounting estimates*

Accounting estimates made by the Plan's management are an integral part of the financial statements and are based on Plan management's knowledge and experience about past and current events and assumptions about future events. Actual results could differ from those estimates.

Certain accounting estimates are particularly sensitive because of their significance to financial statements and their susceptibility to change. The Plan's management believes that the estimates used and assumptions made are adequate based on the information currently available. We evaluated the key factors and assumptions used to develop the estimates in determining that they are reasonable in relation to the financial statements as a whole.

### *Financial statement disclosures*

The financial statement disclosures are neutral, consistent and clear.

## **Going concern**

We concur with management's assessment that the Plan will continue as a going concern for one year from the auditors' report date.

## **Significant risks**

We have identified the following significant risks in connection with our audit:

- Revenue recognition; and
- Plan management override of controls.

## **Significant difficulties encountered during the audit**

We encountered no significant difficulties in dealing with the Plan's management relating to the performance of the audit.

### **Uncorrected and corrected misstatements**

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of the Plan's management.

We are required to communicate to you misstatements that remain uncorrected, including any related to prior periods, and the effect, if any, that they may have on the opinion in our report, and request their correction.

Our audit did not identify misstatements that were corrected by management.

### **Disagreements with Plan management**

For purposes of this letter, a disagreement with Plan management is a matter, whether or not resolved to our satisfaction, concerning financial accounting, reporting, or auditing, which could be significant to the financial statements or the auditors' report. No such disagreements arose during the course of the audit.

### **Representations requested from Plan management**

We have requested certain written representations from the Plan's management in a separate letter dated October 1, 2025.

## Independent Auditors' Report

Notes to Financial Statements (Modified Cash Basis)  
December 31, 2024

### **1. Description of Plan**

The following description of the Abbott House 403(b) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering substantially all employees of Abbott House, Inc. (the "Sponsor" or "Employer"). The Employer established the Plan on October 1, 2009 to provide employees with a systematic means of saving for the future. An employee is eligible for participation in the Plan upon their first day of employment. An employee is eligible for Employer contributions upon completion of one year of service and obtaining 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Contributions***

Each year, participants may elect to make deductions on a pre-tax or Roth basis from their eligible compensation as defined by the plan document. Participants who have attained age 50 before the end of the plan year, are eligible to make catch-up contributions. A participant may elect to increase, decrease or suspend their contributions according to procedures established by the Employer. There is an annual limit as to the amount that can be contributed that is determined by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Employer can make a discretionary matching contribution and discretionary nonelective contribution to the Plan. No discretionary matching contributions and discretionary nonelective contribution were made to the Plan in 2024.

#### ***Vesting***

A participant is 100% vested in their contributions and Employer contributions including allocated earnings thereon at all times.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of (a) the Employer contributions and (b) Plan earnings and losses, and charged with an allocation of administrative expenses. Allocations are based on a participant's earnings and losses or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **1. Description of Plan (continued)**

#### ***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less), subject to the approval of a loan application. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 1%. Principal and interest is paid ratably through payroll deductions. Participants may not have more than one outstanding loan at a time. Loans must be repaid within five years, unless the loan is used to purchase a participant's principal residence which extends the maturity date of the loan beyond five years.

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account.

Benefits can also be distributed in the event of a participant's immediate financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need. A participant may request an in-service distribution once they have reached age 59 ½.

#### ***Revenue Sharing Agreement***

The Plan and Metropolitan Life Insurance Company, the trustee of the Plan, have entered into a revenue sharing arrangement whereby a portion of revenue earned by the trustee from certain funds is passed through to the Plan for payments of permitted expenses. In order for the Plan to receive credits as a result of this arrangement, the Plan created an asset holding account. The asset holding account is an account within the Plan, and is used to record keep these funds. The asset holding account balance was \$4,505 and \$3,610 at December 31, 2024 and 2023. During 2024, no amount from assets holding account were used to reduce any plan expenses.

### **2. Summary of Significant Accounting**

#### ***Basis of Accounting and Use of Estimates***

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis, which is a basis of accounting other than accounting principles generally accepted in the United States of America ("U.S. GAAP"); under this basis, investment income is recognized when received and disbursements are recognized when made, and for investments are reflected at fair value and contract value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in conformity with U.S. GAAP.

#### ***Basis of Accounting and Use of Estimates (Continued)***

The preparation of financial statements requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

Although the Plan's financial statements are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than U.S. GAAP, the Plan follows U.S. GAAP guidance on Fair Value Measurements for disclosure purposes. That guidance defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

#### ***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value except for the group annuity contract, which is stated at contract value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The group annuity contract is valued at contract value, which represents contributions plus credited interest less participant withdrawals and fees.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments, includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. When a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded when a distributable event occurs. In 2024, previously deemed loans were repaid to the Plan in the amount of \$8,412.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Certain expenses of the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expense is included in net appreciation in value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date October 1, 2025.

### **3. Information Certified (*Unaudited*)**

Certain information relating to investments and notes receivable from participants disclosed in the accompanying financial statements (modified cash basis) and ERISA-required supplemental schedule, Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) (modified cash basis), including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Metropolitan Life Insurance Company, a qualified institution.

### **4. Group Annuity Contract**

The GTS Fixed Account (Liquid) (the "Account") is a general account product offered through a group annuity contract. The Account is fully benefit-responsive. The Account is guaranteed by Brighthouse Life Insurance Company and is backed by the full faith and credit of Brighthouse Life Insurance Company's general account. The general account of Brighthouse invests primarily in bonds, commercial, agriculture and real estate mortgages, real estate and corporate equities. Brighthouse Life Insurance Company will declare and guarantee an interest rate for each new contribution or premium. Upon renewal, Brighthouse Life Insurance Company will declare a new interest rate for that contribution or premium and its accumulated earnings. The average yield was 3.79% and 3.69% for 2024 and 2023. Participants may transfer their account balance to any other investment options offered under the Plan at any time with no restrictions or penalties.

The Account represents approximately 29% and 32% of the Plan's net assets available for benefits at December 31, 2024 and 2023. The credit risk of Brighthouse Life Insurance Company, as of November 2024, was evaluated by nationally recognized statistical rating agencies as follows: Standard & Poor's (A+), Moody's Investors Service (A3), A.M. Best (A), and Fitch Ratings (A).

### **5. Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

### **6. Tax Status**

The Employer has adopted a plan document effective March 31, 2017 which is intended to satisfy the IRS's final 403(b) regulations. The Plan has since been amended, however, the Employer believes that the Plan, as amended, is designed and currently being operated in accordance with applicable sections of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by the taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### **7. Party-in-Interest Transactions**

Metropolitan Life Insurance Company is the trustee and record-keeper for the Plan. Therefore, amounts paid to Metropolitan Life Insurance Company qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as party-in-interest transactions.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in substantial volatility in the financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
