### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of C.T. Male Associates Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of C.T. Male Associates Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**1. DESCRIPTION OF THE PLAN**

The following description of the C.T. Male Associates Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering substantially all employees of C.T. Male Associates Engineering, Surveying, Architecture, Landscape Architecture & Geology, D.P.C. (the Company). Employees that are at least 21 years of age become eligible to participate in elective deferrals after three months of service. Employees become eligible for employer matching and nonelective contributions after twelve months during which the employee is credited with at least 1,000 hours of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

Each year employer contributions, if any, are made in an amount determined by the Company. Employer contributions, when made, are allocated to eligible participants based on a percentage of their plan compensation. A participant may also make a voluntary contribution in cash within certain limitations. The employer contributions totaled \$609,470 and \$505,586 for 2024 and 2023, respectively. The employee contributions totaled \$1,176,294 and \$1,155,728 for 2024 and 2023, respectively. Participants direct the investment of employer and employee contributions into various investment options offered by the Plan. Employer contributions are reported net of forfeitures on the statements of changes in net assets available for benefits.

Effective January 1, 2017, the Plan was amended to include an automatic enrollment feature and an automatic escalation feature. Under the automatic enrollment feature, the Company will withhold 3% of an eligible employee's compensation every payroll period and contribute that amount to the Plan as a pre-tax deferral unless the employee elects a different contribution amount or opts out of the automatic enrollment. The automatic escalation feature will annually increase this automatic enrollment withholding amount by 1% up to a maximum of 10% unless the participant elects a different contribution amount or opts out of the automatic enrollment.

***Participant Accounts***

The Plan allows each participant to select the investments in the individual account. Investments consist of various registered investment companies (mutual funds), variable annuity contracts and a guaranteed investment fund. Each participant's account is credited with the participant's contribution, if any, and with an allocation of the Company's contribution, if any, in proportion to their compensation. Plan earnings and losses are allocated based on a participant's investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. DESCRIPTION OF THE PLAN**

***Notes Receivable from Participants***

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of the nonforfeitable accrued benefit of the participant account balance under the Plan. Notes receivable terms range from one to five years with payments to be made not less frequently than quarterly. However, notes receivable used to acquire any dwelling unit which is to be used as a principal residence of the participant shall provide for periodic repayment over a reasonable period of time that may exceed five years. Interest is recognized over the term of the note and is calculated based on the prime rate plus 1% as reported by the U.S. Federal Reserve on the first business day of the month the loan is originated.

Notes receivable from participants at December 31, 2024 and 2023, were \$174,611 and \$163,241, respectively.

***Vesting***

Employee elective deferrals and employer contributions are fully vested at the time of the contribution.

***Forfeitures***

Forfeitures of employer contributions paid in excess of allowable limits, can be used to reduce plan expenses or the Company's contributions. During the years ended December 31, 2024 and 2023, the Company used \$-0- and \$181, respectively, to reduce employer contributions. At December 31, 2024 and 2023, forfeiture balances were \$70 and \$68, respectively.

***Payment of Benefits***

Upon termination of employment, participants or their beneficiary have a 100% non-forfeitable right to the vested value of their accounts. They are entitled to receive either a lump-sum distribution amount equal to the value of their account, or annual installments over a period of time.

***Termination of the Plan***

Although it has not expressed an intent to do so, the Company has a right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**2. SIGNIFICANT ACCOUNTING POLICIES**

***Plan Administration Costs and Parties-in-Interest***

The Plan sponsor, C.T. Male Associates Engineering, Surveying, Architecture, Landscape Architecture & Geology, D.P.C., has elected to pay for certain administrative expenses of the Plan. Administrative expenses for the years ended December 31, 2024 and 2023, were approximately \$22,900 and \$20,200, respectively. This includes administrative costs paid to the third-party administrators, Empower Retirement, LLC, as well as audit fees paid to Mengel, Metzger, Barr & Co. LLP.

**2. SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value, except for the guaranteed income fund, which is stated at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Investment income recognized by the Plan includes earnings from investments, net gains (losses) realized from the sale of investments, and the net changes in the unrealized appreciation (depreciation) of investments.

Interest income on notes receivable from participants is recognized by the Plan in the period in which it is earned based on the outstanding principal balance times the stated interest rate at the date the note receivable originated.

***Fair Value Measurements***

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements*, establishes a three-level hierarchy for disclosure of fair value measurements. The valuation hierarchy is based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date. A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The three levels are described as follows.

- Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

- Registered investment companies are valued based on quoted prices in active markets.
- Variable annuity contracts are valued based on quoted prices obtained for the underlying registered investment company which are then adjusted to apply the expense factor disclosed in the annuity contract.
- Collective trust funds are valued according to the provisions of Accounting Standards Update (ASU) 2009-12, *Investments in Certain Entities that Calculate Net Asset Value per Share (or its Equivalents)*. ASU 2009-12 allows for the estimation of fair value of investments in certain investment companies for which the investment does not have

***Fair Value Measurements***

readily determinable value by using net asset value (NAV) per share, or its equivalent, as a practical expedient. The collective trust fund is primarily valued at the closing NAV of the units held by the Plan at year-end based on information provided and certified by the Trustee.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used to determine fair value at December 31, 2024 and 2023.

*Payment of Benefits*

Benefits are recorded when paid.

*Notes Receivable From Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the plan document.

*Estimates*

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**3. INFORMATION CERTIFIED BY THE CUSTODIAN AND TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA as of and for the years ended December 31, 2024 and 2023. Accordingly, the custodian, Empower Life & Annuity Insurance Company of New York and Trustee, Empower Trust Company, LLC, have certified to the completeness and accuracy of the investments and notes receivables from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the schedule of assets

**3. INFORMATION CERTIFIED BY THE CUSTODIAN AND TRUSTEE**

(held at end of year) as of December 31, 2024. The custodian and trustee have also certified to the completeness and accuracy of the related investment income, net appreciation of investments in registered investment companies, variable interest annuities, and collective trust funds, and interest received on participant notes receivable reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

**4. INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has entered into a benefit-responsive investment contract with Empower Life & Annuity Insurance Company of New York (Empower). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The Plan owns a promise to pay interest at crediting interest rates which are announced in advance and guaranteed for a specific period of time as outlined in the group annuity contract. There are no specific securities in the general account that back this annuity contract.

Because the guaranteed investment contract is fully benefit-responsive for participant-initiated transactions, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Generally, there are no events that could limit the ability of the Plan to transact at contract value with the issuer within 90 days or in rare circumstances, contract value paid overtime. There are no events that allow the issuer to terminate the contract, and which require the plan sponsor to settle at any amount different than the contract value either within 90 days or over time.

Interest is credited on a contract basis using a single “portfolio rate” approach. Under this methodology, a single interest-crediting rate is applied to all contributions made to this product regardless of the timing of those contributions. Interest crediting rates are reviewed on a semi-annual basis for resetting. The crediting interest rate is established without the use of a specific formula but may not be less than 1.28%. The average yield earned by the Plan and credited to participants was 1.81% and 1.59% for the years ended December 31, 2024 and 2023, respectively.

**5. TAX STATUS**

The Plan has received a favorable determination from the Internal Revenue Service (IRS) dated November 14, 2022. The Plan has been amended since receiving the determination letter. However, the plan administrator and plan sponsor believe that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and was tax exempt as of the financial statement date.

**5. TAX STATUS**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more than likely would not be sustained upon the examination by the IRS or other applicable taxing authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. RISKS AND UNCERTAINTIES**

The Plan invests in registered investment companies, collective trust funds, variable annuities and an investment contract with an insurance company. These investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with these investment securities, it is at least reasonably possible that changes in the values of these investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

**7. PARTIES-IN-INTEREST**

Additionally, Empower received \$1,350 and \$1,150 in participant transaction fees for the years ended December 31, 2024 and 2023, respectively, which are reflected in net appreciation (depreciation) of investments in registered investment companies.
