The use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date had a readily determinable market value existed. Actual numbers of common shares held of Planters Financial Group, Inc. stock were 41,199 and 42,226 at December 31, 2024 and 2023, and comprised 46 and 47 percent of the Plan's total assets at fair value at December 31, 2024 and 2023, respectively. Our opinion is not modified in regard to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1. Description of the Plan

The following description of the Planters Bank Employee Stock Ownership and 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan sponsored by Planters Bank, Inc. (the "Company"). The Plan operates as a combined stock bonus plan and profit-sharing plan (401(k)) subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and of Sections 401(a) and 501(a) of the Internal Revenue Code (IRC). The portion of the Plan consisting of the employee stock ownership plan (ESOP) is designed to comply with Section 4975(e)(7) and the regulations thereunder of the IRC, and is subject to the applicable provisions of ERISA. The Plan is administered by the Compensation Committee of the Board of Directors of the Company (the "Committee").

The Company is responsible for the administration of the Plan and entrusts the maintenance of records and the day-to-day administration of the 401(k) portion of the Plan to ERISA Services, Inc. The custodian of the 401(k) Plan is The Lincoln National Life Insurance Company. Ellis & Ward Consulting Group provides recordkeeping services for the ESOP.

Plan amendment:

Effective March 25, 2024, the Plan was amended to permit in-service withdrawals of rollover contributions by participants prior to attaining age 59½.

Eligibility:

Participation in the 401(k) is strictly voluntary, and employees can elect to participate on the first day of January or July after attaining the age of 21 and completing 90 days of eligible service. Employees are eligible to participate in the ESOP upon attaining 1,000 hours of service during the Plan year and having been employed on the last day of the Plan year.

Contributions:

Each year, participants may contribute up to 50 percent of pretax annual compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan, which include Company common stock ("Common Stock") outside of amounts contributed by the Company as shown in Note 6. The Company may make discretionary matching 401(k) contributions to the Plan. For the year ended December 31, 2024, the Company contributed a matching contribution of 50 percent of the first 10 percent of base compensation that a participant contributed to the 401(k) portion of the Plan. The discretionary matching 401(k) contributions totaled \$420,298 for the year ended December 31, 2024. Additional profit sharing amounts may be contributed at the option of the Committee. There was no discretionary profit sharing contribution to the 401(k) portion of the Plan for the year ended December 31, 2024. The Company may make discretionary contributions of either cash or Common Stock to the ESOP. During 2024, the Company contributed \$425,000 to the ESOP, which is included in Company contributions receivable at December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts:

Each participant's account in the 401(k) portion of the Plan is credited with the participant's contributions, Company contributions, and Plan earnings. Each participant's account in the ESOP portion of the Plan is credited with Company contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's 401(k) discretionary matching and profit sharing contribution portion of their accounts plus related earnings is based on years of vesting service in which the participants complete 1,000 hours of service. A participant is 100 percent vested after 5 years of credited service.

Vesting in the Company's ESOP contribution portion of their accounts plus related earnings is based on years of vesting service in which the participants complete 1,000 hours of service. A participant is 100 percent vested after 3 years of credited service.

Participants terminating due to normal retirement, death or disability will be 100 percent vested. Additionally, participants are immediately vested in any dividends paid on Company Stock.

Notes receivable from participants:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at the Prime rate plus 2 percent. Principal and interest are paid ratably through payroll deductions.

Payment of benefits:

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or the installment options as provided by the Plan. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59½. Distributions of the Common Stock from the ESOP will generally be made in full shares. Any fractional shares of Common Stock may be paid in cash at the discretion of the Committee.

Forfeited accounts:

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures in the 401(k) portion may be used to pay administrative expenses or to reduce future Company contributions at the discretion of the Company. ESOP forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to the total compensation in a future Plan year. At December 31, 2024 and 2023, forfeited nonvested accounts in the 401(k) portion of the Plan totaled \$30,757 and \$26,584, respectively. During 2024, no forfeitures from the 401(k) portion were used to pay administrative expenses or to reduce Company contributions. During 2024, \$2,784 of cash and shares of Common Stock with a total value of \$2 were allocated to participant accounts.

Voting rights:

Each participant is entitled to direct the individuals appointed by the Board of Directors to administer the Plan (the "Trustees") as to the manner in which voting rights of the shares of Common Stock are to be exercised with respect to any corporate matters that are subject to direction by a participant. The Committee directs the Trustees as to the manner of voting of any Common Stock (a) allocated to participant accounts with respect to such matters as to which no voting instructions have been timely received, (b) contributed to the trust but not yet allocated to participant accounts, and (c) held by the Plan with respect to all corporate matters which involve the voting of such Common Stock other than those matters that are subject to direction by a participant.

Put option:

Under federal income tax regulations, the Common Stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its Stock distributed to participants for which there is no market. The put price is representative of the fair market value of the Stock as determined by an independent valuation specialist. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification:

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in the Common Stock into investments which are more diversified. Participants who are at least age 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period.

Diversification, continued:

In each of the first 5 years, a participant may diversify up to 25 percent of the number of shares of the Common Stock allocated to his or her account, less any shares of the Common Stock previously diversified. In the sixth year, the percentage increases to 50 percent. During 2024, no diversification distributions occurred.

Note 2. Summary of Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

Contributions:

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Investment valuation and income recognition:

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the custodian and an independent appraiser. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan relies significantly on the use of estimates in determining the valuation of the Company's common stock. The financial statements include the Company's common stock valued at \$310 per share at December 31, 2024 and \$288 at December 31, 2023. The stock's value has been estimated by management in the absence of a readily ascertainable market value. This estimate was based on a valuation completed by an independent outside appraiser. Because of the inherent subjectivity in any valuation, the estimated value may differ significantly from the value that would have been used had a ready market for the securities existed, and the difference could be material.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits:

Benefits are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events:

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.

Recently issued accounting pronouncements:

Accounting standards that have been issued or proposed by the Financial Accounting Standards Board (FASB) or other standards-setting bodies are not expected to have a material impact on the Plan's financial statements.

Note 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash: The Plan holds funds in an interest-bearing checking account at Planters Bank to provide daily liquidity. Valued at cost plus accrued interest, which approximates fair value.

Pooled separate accounts: Valued at net asset value (NAV). The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

Company Stock: The value of the Plan's investment in Company Stock was established by an independent third party appraisal using the income and market approaches. The income approach projects future earnings for the Company and applies a discount rate based on the risks of achieving the projected earnings. The market approach utilizes implied multiples from comparable publicly-traded companies to apply to financial metrics specific to the Company. A discount for lack of marketability was then applied to determine the value on a minority, nonmarketable basis.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7. Fully Benefit-Responsive Investment Contract

The Plan invests in a traditional fully benefit-responsive guaranteed investment contract with The Lincoln National Life Insurance Company ("Lincoln") totaling \$788,451 and \$1,838,091 as of December 31, 2024 and 2023, respectively. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is established every January 1 and July 1 and is based on the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period but may not be less than 1 percent. The guaranteed investment contract does not permit Lincoln to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents including complete or partial plan termination or merger with another plan, (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Such events include the following: (a) an uncured violation of the Plan's investment guidelines, (b) a breach of material obligation under the contract, (c) a material misinterpretation, or (d) a material amendment to the agreements without the consent of the issuer.

Note 8. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the custodian and third-party administrator totaling \$23,692 which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

The Plan invests in Company common stock. These are related party and party-in-interest transactions.

Note 9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, the Committee directs the trustees to pay all liabilities and expenses of the ESOP. Subsequently, the interest of each participant in the Plan will be distributed to such participant his or her beneficiary at the time prescribed by the Plan terms and the IRC. In the event of the Plan termination, participants would become 100 percent vested in their Company discretionary matching and profit sharing contributions and Company ESOP contributions.

Note 10. Tax Status

The IRS has determined and informed the Company by a letter dated August 30, 2021, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since receiving the determination letter. The Plan Administrator believes the Plan and trust are operating in a manner that does not jeopardize this tax status.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax provisions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 11. Risks and Uncertainties

The Plan invests in various investment securities, as well as the Company's Common Stock. Investment securities are exposed to various risks such as interest rate, market, and credit risks. The Company's Common Stock is also exposed to these risks, as well as valuation assumptions based on earnings, cash flow and/or other such techniques (Note 5). Due to the level of risk associated with certain investment securities and the investment in the common stock, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Note 12. Subsequent Events

On May 30, 2025, the Plan transitioned its recordkeeping and custodian services for the 401(k) portion of the Plan from The Lincoln National Life Insurance Company to Transamerica Corporation. As part of this transition, a blackout period was implemented beginning on July 21, 2025 and ending on August 29, 2025, during which participants were temporarily unable to direct or diversify investments, request distributions, or initiate loans.

The blackout period was necessary to facilitate the accurate transfer of participant data and plan assets between providers. All participant accounts remained invested during the blackout period, and contributions and loan repayments continued to be processed according to the most recent elections on file. The Plan administrator provided timely notice to all affected participants and beneficiaries in accordance with ERISA Section 101(i) and DOL regulations. No material adverse impact to plan assets or participant rights was identified as a result of the blackout period.


