
### Auditors' Responsibilities for the Audit of the Financial Statements

**Notes to Financial Statements  
As of December 31, 2024 and 2023**

## **1. Description of the Plan:**

### **General**

The National Automobile Dealers Association Employee Health Benefit Plan (the Plan), a welfare benefit plan, was established in 1981 for employees of the National Automobile Dealers Association (NADA or the Plan Administrator), and affiliated companies. The Plan provides for the payment of certain medical and dental expenses for employees, retirees, and their dependents, or reimbursement of out of pocket or non-reimbursable medical and dental expenses through flexible spending accounts. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Information concerning eligibility for benefits and benefit coverage under the Plan is contained in the Employee Health Benefit Plan Document (Plan Document) and Summary Plan Description.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

### **Basis of Accounting**

The financial statements have been prepared on the accrual basis of accounting. Benefits are recorded when paid.

### **Cash and Cash Equivalents**

Cash and cash equivalents consist of highly liquid debt instruments with initial maturities of ninety days or less. The Plan maintains cash balances at two commercial banks which can exceed the FDIC insured deposit limit of \$250,000 per financial institution. At December 31, 2024 and 2023, the Plan's cash balances held at commercial banks did not exceed the FDIC limit. The Plan has not experienced any losses through the date when the financial statements were available to be issued.

### **Deposits**

Deposits consist of amounts on deposit with insurance companies performing claims administration services for the Plan.

### **Administrative Expenses**

All administrative expenses, consisting primarily of claims administration fees, are paid by the Plan in accordance with the Plan Document.

## **Transactions with Related Parties**

NADA makes payments for claims reported and approved for payment and which are reimbursed by the Plan. In addition, NADA pays certain administrative costs for the Plan for which it is reimbursed. The net of any amounts due under these transactions and employer contributions due to the Plan as of December 31 are reflected as Due to NADA or Due from NADA in the Statements of Net Assets Available for Benefits.

### **2. Contributions:**

Contributions to the Plan are made as necessary in accordance with the Plan Document. NADA contributes the difference between the participants' contributions and the amount necessary to provide for payments to be made under the terms of the Plan Document. Participants contribute specified amounts depending upon the chosen benefit options. The average annual costs to retirees age 65 and older in 2024 ranged from \$513 to \$1,026. The average annual costs to retirees age 65 and older in 2023 ranged from \$494 to \$988. These amounts represented 20% to 100% of total annual cost in 2024 and 2023. Forfeited accounts are used to reduce future employer contributions. Although it has not expressed any intention to do so, NADA has the right under the Plan to modify the benefits provided to and contributions required of active employees and retirees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, no further contributions will be made, and benefits will be paid out in accordance with the provisions of the Plan.

### **3. Insurance Premiums and Estimated Benefit Obligations:**

The Plan has contracts with United Health Care Company (UHC), Delta Dental, and Flexible Benefit Administrators to pay certain medical, dental and flexible spending claims. The Plan also paid medical premiums under fully insured contracts with UHC (for AARP Medicare Supplement and prescription coverage for retirees). The Plan maintains a stop-loss insurance policy with UHC. Effective January 1, 2020, the stop-loss insurance policy added an experience refund provision under which UHC will return to the Plan an amount equal to 25% of net profits (net profits is defined as 60% of the sum of all premiums paid less the sum of all specific excess loss insurance claims for the policy period). \$23,000 of the 2022 experience refund remained as a receivable in the 2023 financial statement. Stop loss reimbursements totaling \$589,000 and \$1,101,000 for 2024 and 2023, respectively, have been netted with claims paid in the accompanying Statements of Changes in Net Assets Available for Benefits and the Statements of Changes in Plan Benefit Obligations. Stop loss reimbursements of \$92,000 have been included in refunds receivable in the 2023 Statement of Net Assets Available for Benefits. In addition, the Plan receives certain rebates and pharmacy discount guarantees under their agreement with UHC. A total of \$45,000 and \$7,000 was received under this agreement for 2024 and 2023, respectively, and has been netted with claims paid in the Statements of Changes in Net Assets Available for Benefits. Amounts due of \$36,000 and \$7,000 are included in refunds receivable in the Statement of Net Assets Available for Benefits. The current benefit obligation includes an estimate of claims incurred but not reported (IBNR). IBNR is estimated by the Plan Administrator using prior claims experience.

### **4. Postretirement Benefit Obligations:**

Certain health care benefits are provided for retired employees. Employees become eligible for these benefits if they meet minimum age and service requirements, if they were eligible for retirement benefits, and if they agreed to contribute a portion of the cost based on years of service and age. The Plan was amended effective January 1, 2009, to provide that post-retirement medical coverage will only be provided to participants who have retired as of September 30, 2009. For 2024, the initial health care cost trend rates were assumed to be 6.20% for Post-65 retirees. The Post-65 rates were assumed to decrease gradually to 5.50% for 2028 and remain at the level thereafter. For 2023, the initial health care cost trend rates were assumed to be 6.30% for

Post-65 retirees. The Post-65 rates were assumed to decrease gradually to 5.50% for 2028 and remain at that level thereafter. The health care cost trend rate assumptions have a significant effect on the amounts reported. For example, a one percent point increase in the health care cost trend rate would increase the accumulated postretirement benefit obligation by \$82,000 and \$81,000 as of December 31, 2024 and 2023, respectively. The weighted-average discount rate used in determining the accumulated postretirement benefit obligation was 5.35% and 4.75% for 2024 and 2023, respectively. The Private-sector Mortality Experience Table (“Pri-2012”) with scale MP-2021 was used to determine the accumulated postretirement benefit obligation as of December 31, 2024 and 2023. The increase in the discount rate decreased the obligation by approximately \$52,000. The weighted average discount rate used to determine the obligation as of December 31, 2022 was 4.95%. For 2022, the initial health care cost trend rates were assumed to be 6.30% and were assumed to decrease gradually to 5.50% for 2028 and remain at that level thereafter. The decrease in the discount rate increased the obligation by approximately \$18,000 in 2023.

#### **5. Benefit Obligations:**

The Plan’s deficiency of net assets over benefit obligations at December 31, 2024 and 2023, relates primarily to the postretirement benefit obligation, the funding of which is not covered by the current contributions. It is expected that the excess of benefit obligations over the Plan’s net assets will be funded through future increases in retiree and employer contributions.

#### **6. Tax Status:**

The Trust funding the Plan has received an exemption letter from the Internal Revenue Service dated February 22, 1983, stating that the Trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (the “ Code”) as a Voluntary Employee Beneficiary Association. The Plan and Trust are required to operate in conformity with the Code to maintain the tax-exempt status of the Trust. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. Risks and Uncertainties:**

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

#### **8. Subsequent events:**

Management has evaluated subsequent events for disclosure in these financial statements through September 30, 2025, which is the date the financial statements were available to be issued.

UHC has notified the Plan that the retiree policy will not be renewed after December 31, 2025. Plan management is in the process of evaluating what coverage, if any, will continue for retirees after that date.
