**1. Description of Plan**

The following description of the Hangley Aronchick Segal Pudlin & Schiller 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan generally covering all employees of Hangley Aronchick Segal Pudlin & Schiller ("Plan Sponsor"), who have attained the age of 21. Seasonal employees are excluded from participation. Salary deferral eligibility requirements for these employees have been modified to reflect provisions required by the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 ("SECURE Act 2.0"). Fidelity Management Trust Company is the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

**Contributions**

Participants may elect to contribute up to 60 percent of their pretax annual compensation, as defined by the Plan document, subject to Internal Revenue Service ("IRS") regulations. Participants can elect to designate elective contributions as Roth contributions. The designated Roth contributions is a feature that is permitted under the Internal Revenue Code ("IRC") added by the Economic Growth and Tax Relief Reconciliation Act of 2001, effective for years beginning on or after January 1, 2006. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

In accordance with the Plan document, the Plan Sponsor shall make Safe Harbor non-elective contributions of 4% of each eligible participant's compensation. For the year ended December 31, 2024, the Safe Harbor non-elective contribution made by the Plan Sponsor was \$731,596.

The Plan Sponsor may also make a discretionary matching contribution, as defined in the Plan document, at the option of the Plan Sponsor's Board of Directors. For the year ended December 31, 2024, the Plan Sponsor made a discretionary match of \$0.25 for every \$1.00 of each participant's contributions, with a maximum amount of each participant's contributions equal to 3% of the participant's annual compensation limit, in the amount of \$133,794.

Plan Sponsor contributions are to be paid to the Plan trustee no later than the fifteenth day of the ninth month following the end of the Plan year.

**Participant Accounts**

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contribution and discretionary matching contributions, if any, as well as allocations of Safe Harbor non-elective contributions and Plan earnings. Participant accounts are charged with an allocation of certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. Participants may direct the investment of their deferrals and account balances into various mutual funds investment options offered by the Plan as well as self-directed brokerage accounts. The self-directed accounts are through Fidelity BrokerageLink which is a participant-directed option that allows participants the opportunity to invest in a wide array of securities that are traded on active securities exchanges. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately 100% vested in their voluntary contributions, all Plan Sponsor contributions, plus actual earnings thereon.

**Notes Receivable from Participants**

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan amount is \$1,000. A participant may only have one loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at the prevailing interest rate at the time of borrowing, as determined by the Plan administrator. The loans are generally repaid ratably through payroll deductions over a period not extending beyond five years from the date of the loan unless such loan is for the purchase of a primary residence. Interest rates ranged from 5.25% to 10.50% on loans outstanding as of December 31, 2024.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement or separation, a participant will receive his or her benefits as a lump-sum amount equal to the value of the participant's vested interest in his or her account. In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59½. Rollover account balances may be withdrawn at any time. Per IRS regulations, participants are required to take their first required minimum distributions by April 1 of the year following the year they reach required minimum distribution age (73 in 2024).

**2. Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions. These estimates and assumptions affect the reported amounts of Plan assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's investment policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions**

Contributions from Plan participants and discretionary matching contributions, if any, are recorded in the year in which the employee contributions are withheld from compensation. Safe Harbor non-elective contributions from the Plan Sponsor are recorded in the year in which the related participant compensation was earned.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

**Payments of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable and other participant-specific fees are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in the net appreciation in fair value of investments.

**3. Information Certified by a Qualified Institution**

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for all mutual funds, self-directed brokerage accounts, and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedule.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Self-directed brokerage accounts generally are limited to certain mutual funds, including money market funds, publicly traded common stock, preferred stock, exchange-traded funds, and interest-bearing cash. Mutual funds are valued at the daily closing price NAV as noted above. Shares of stock and exchange-traded funds on securities exchanges are valued at the last reported sales price on the last business day of the plan year. Interest-bearing cash consists of deposits on account in various financial institutions. The carrying amount of interest-bearing cash approximates its fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of levels 1, 2, or 3.

**5. Related-Party and Party-In-Interest Transactions**

Certain of the Plan's investments are mutual funds and participant-directed brokerage accounts managed by Fidelity Investments, which is a related party to Fidelity Management Trust Company, the trustee of the assets as defined in the Plan document. Consequently, these transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Notes receivable from participants also qualify as party-in-interest transactions and are also exempt from the prohibited transaction rules.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, with the approval of the Board of Directors and subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

**7. Risks and Uncertainties**

The Plan's investment fund options provide participants with a variety of investment alternatives with differing levels of risk and income potential. Investment securities are exposed to various risks, such as significant world events, interest rates, credit and overall market volatility risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is reasonably possible that changes in the values of investments could occur in the near term and that such changes could materially affect participants' account balances and the reported amounts in the statements of net assets available for benefits.

**8. Tax Status**

Effective March 1, 2022, through the adoption of a Fidelity Pre-Approved Defined Contribution Plan, the Plan was amended and restated. The IRS issued an opinion letter dated June 30, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with applicable IRC requirements as of that date and, therefore, the related trust is tax-exempt. The Plan administrator has determined that it is eligible to and has chosen to rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan, as amended, is designed and currently being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified under the appropriate section of the IRC and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Plan Amendments**

Effective December 27, 2024, the Plan was amended to make certain administrative changes to the Plan.

**10. Subsequent Events**

Management evaluated subsequent events for the Plan through September 30, 2025, the date the financial statements were available to be issued.
