Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bergey's, Inc., 401(k) Profit-Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit Financial Statements section:

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of Bergey's, Inc. 401(k) Profit-Sharing Plan (Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution 401(k) profit-sharing plan covering all employees of Bergey's, Inc. (the Company), and affiliated companies that have adopted the Plan and who have met certain eligibility requirements. Employees must have attained age 21 and completed three months of service to be eligible for the plan. Participation in the Plan begins the first day of the plan year quarter coinciding with or following the day the participant satisfied the eligibility requirements. Newly eligible participants are enrolled automatically at a minimum deferral rate of 3% unless they opt-out. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was most recently restated January 1, 2024, to include the CARES Act Amendment.

Contributions: Participants may contribute any whole percentage up to 75% of eligible compensation into a pre-tax regular 401(k) account or into an after-tax Roth 401(k) account, subject to annual limitations imposed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company makes matching contributions equal to 25% of elective deferral contributions, up to 3% of total compensation. The Company may also make a discretionary contribution of an amount determined annually by the Board of Directors.

Participant's Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their account upon their effective date of participation.

Investment Options: Upon enrollment in the Plan, a participant may direct the investment of their account into any investment option offered by the Plan. If the participant makes no election, the account is invested in one of the Vanguard Target Date funds based on year of birth. The participants may change their investment options as often as they like.

Payment of Benefits: Payment of benefits on account of retirement, death, disability, or termination of employment will be made in one lump-sum or in installment payments based on life expectancy.

Participant Loans: Participants may borrow a minimum of \$500 from the Plan as evidenced by a note. Loans may be requested up to the lesser of \$50,000 or 50% of their vested account balance. Loan repayments are made in equal installments deducted from each paycheck. Interest is charged at the rate of 1% above the prime interest rate at the time the loan is approved. Participants may have no more than two loans outstanding at any time. The outstanding loan balance and any accrued interest may be repaid in full at any time.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting: The financial statements are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments in registered investment companies and in collective investment trusts are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. The Plan's investment in group annuity contract with an insurance company is a fully-benefit responsive investment contract which is reported at contract value. See Note 5 for discussion of the Plan's investment in a group annuity contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair values of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued interest. Delinquent loans are treated as distributions based upon the terms of the plan document surrounding defaulted loans.

Payment of Benefits: Benefits are recorded when paid.

Forfeited Accounts: Forfeitures represent unallocated employer contributions resulting from the termination of participants with less than fully vested benefits under the Plan. Forfeitures may be used to pay administrative expenses, allocated as additional employer contributions or used to reduce employer contributions. Forfeited non-vested accounts at December 31, 2024 and 2023, totaled \$231 and \$-0-, respectively. During 2024, forfeitures in the amounts of \$4,600 and \$35 were used to offset the employer profit sharing contribution and plan fees, respectively.

Administrative Expenses: Administrative expenses are paid by the Plan if not paid by the Plan Sponsor.

Subsequent Events: In preparing these financial statements, the Plan administrator has evaluated events and transactions for potential disclosure through September 30, 2025, the date the financial statements were available to be issued. See Note 12.

NOTES TO FINANCIAL STATEMENTS

Note 3. Information Certified by the Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by Newport Trust Company, (the Trustee of the Plan).

Note 4. Investments and Fair Value Measurements

The Plan measures, on a recurring basis, its investments at fair value in accordance with Financial FASB codification *Fair Value Measurement*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that are accessible to the Plan. These generally provide the most reliable evidence and are used to measure fair value whenever available.

- Level 2 Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, which are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted prices for similar assets in active markets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

The Plan's investments measured at fair value consist of registered investment companies and collective funds within a collective investment trust. The following are descriptions of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Shares of registered investment companies (mutual funds) are valued at the daily closing prices as reported by the fund. The funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Note 4. Investments and Fair Value Measurements (Continued)

Collective Investment Trusts: The Plan invests in certain collective index funds. The underlying collective trusts are valued based upon the net asset value (NAV) of units of the collective trusts as reported to the Plan by the trusts. Net asset value is used as a practical expedient to estimate fair value because it is unlikely that the trust would sell the investment for an amount different than the reported net asset value. The units of each share class of the collective trusts are valued daily based on closing market prices of the underlying investments. The NAV per unit is computed by dividing the total assets of the trust, less its liabilities, by the total number of units outstanding as of the valuation date. Investment income earned is reinvested in the trust and included in the determination of unit values.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investment Contract with Insurance Company

The Plan has entered into a benefit-responsive, group annuity contract with Mass Mutual Life Insurance Company within which participants may direct their investments into a pooled separate account with a guaranteed rate of return investment option. This account is credited with earnings on the underlying investments and charged for participant withdrawals and certain administrative expenses. The pooled separate account provides a guaranteed rate of return from its investments in various fixed income securities, including but not limited to U.S. dollar-denominated corporate obligations, securities issued or guaranteed by the U.S. Government or its agencies, U.S. dollar-denominated bonds of foreign issuers or bonds of foreign issuers currency hedged into U.S. dollars, mortgage-backed and other asset-backed securities and money market securities including commercial paper.

Because the pooled separate account contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value represents contributions made under the contract, plus credited interest, less participant withdrawals and certain administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than a minimum guaranteed interest rate that is declared semi-annually in advance by Mass Mutual.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

Note 8. Tax Status

The Plan adopted a non-standardized pre-approved plan sponsored by Newport Group, Inc. The non-standardized pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, as to the Plan's qualified status. The IRS has determined that the non-standardized pre-approved plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The non-standardized pre-approved plan opinion letter has been relied upon by this Plan. Although the Plan has since been amended, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Related Party and Party-in-Interest Transactions

Fees paid by the Plan during the year for administrative services, investment management services and custodial services rendered by parties in interest were based on customary and reasonable rates for such services. These transactions qualify as party-in-interest transactions.

Note 10. Prohibited Transactions

During 2024, the Plan Sponsor inadvertently failed to deposit approximately \$567 of participant contributions within the required timeframe as stated by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. Lost earnings on late deposits will be remitted to the Plan in 2025, and the applicable excise tax return will be filed.

Note 12. Subsequent Events

Effective January 17, 2025, the Plan Sponsor acquired Susquehanna Motor Company, Inc. All employees that were obtained as a result of the acquisition will be considered new employees for purposes of 401(k) eligibility.

Effective March 27, 2025, the Plan moved to Fidelity Investments for custodian and recordkeeper services. The Plan was amended effective March 27, 2025 to include the following changes:

- Reduce the eligibility age from 21 years of age to 18 years of age.
- Reduce the service requirement from 3 months of service to 30 days of service.
- Change the enrollment date from the first of the Plan quarter coincident with or next following date requirements were met to immediately upon meeting the eligibility requirements.
- Changed the employer matching contribution from 25% up to 3% to 25% up to 4%.
