### Note 1 - Description of Plan

The following description of Mueller Retirement Savings 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document and the summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

#### General

The Plan is a defined contribution 401(k) retirement plan available to substantially all employees of Precision Tube Company, Mueller Copper Tube Products, Inc., Mueller Copper Tube Company, Inc., B&K, LLC, Kessler/Streamline, Mueller Brass Forgings Company, Inc., Mueller Impacts Company, Inc., and Mueller Brass Co. (collectively, the "Company") covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

During 2023, Precision Tube Company closed their location. Following the closing there were no further contributions.

Employees of the Company are eligible to participate as follows:

Mueller Brass Forgings Company, Inc. Mueller Impacts Company, Inc. Mueller Brass Co.	For those classified as employees of Local 218 and Local 44 hired on or after December 11, 2022, first of the month following 90 days of eligible service (60 days for Mueller Brass Co. - Local 119), as defined in the plan document. For those hired prior to December 11, 2022, on the date of hire but not before December 1, 2022.

#### Contributions

Participants at Precision Tube Company (prior to the closing in 2023), and Mueller Brass Co. - Local 119 may contribute up to fifteen percent (15%) of annual eligible compensation, as defined in the plan document, subject to Internal Revenue Service (IRS) limitations. Mueller Copper Tube Company, Inc., B&K, LLC, Mueller Copper Tube Products, Inc., Kessler/Streamline, Mueller Brass Forgings Company, Inc., Mueller Impacts Company, Inc., and Mueller Brass Co. - Locals 44 and 218 participants may contribute up to sixty percent (60%) of annual eligible compensation, subject to IRS limitations.

Participants may also make rollover contributions representing distributions from other qualified retirement plans. Participants who have attained age fifty (50) before the end of the Plan year are eligible to make catch-up contributions.

The Company matching contributions for Mueller Copper Tube Company, Inc., Mueller Copper Tube Products, Inc., B&K, LLC, Precision Tube Company, Kessler/Streamline, Mueller Brass Forgings Company, Inc., Mueller Impacts Company, Inc., and Mueller Brass Co. - Locals 44 and 218, are equal to one hundred percent (100%) of the first three percent (3%) of eligible compensation contributed by the participant to the Plan, and fifty percent (50%) of the next two percent (2%) of eligible compensation contributed by the participant. The Company matching contributions for Mueller Brass Co. - Local 119 are equal to one hundred percent (100%) of the first two (2%) of eligible compensation contributed by the participant to the Plan.

Participants subject to the Precision Tube Company collective bargaining unit also receive Company contributions equal to one percent (1%) of participants' eligible compensation, given Precision Tube Company's achievement of certain financial targets.

Catch-up contributions are not eligible for the Company's matching contributions.

#### Participant investment account options

The Plan allows participants to direct varying portions of their contributions and account balances among the different investment options consisting of mutual funds, a pooled separate account, a fixed income option and a common collective trust fund offered by Principal Trust Company and Principal Life Insurance Company (collectively, "Principal").

#### Participant accounts

Each participant's account is credited with the participant's deferral contributions and the Company's contributions, plus a proportionate interest in the investment earnings or losses of the funds in which the contributions are invested, and charged with an allocation of administrative expenses. Allocations are based upon the participant's eligible compensation or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1 - Description of Plan (continued)

#### Vesting

Participants are immediately vested in their elective deferral contributions plus earnings thereon. Participants of Precision Tube Company, B&K, LLC, Mueller Copper Tube Company, Inc., Kessler/Streamline, Mueller Brass Forgings Company, Inc., Mueller Impacts Company, Inc., and Mueller Brass Co. are immediately vested in Company contributions and related earnings. Participants of Mueller Copper Tube Products, Inc. vest in Company contributions and related earnings based upon years of service, with 100% vesting occurring after four (4) years of credited service.

In the event of death, disability, normal retirement age (65), or if the Plan is discontinued, participants become 100% vested in all account balances.

#### Notes receivable from participants

Participants may borrow up to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance during the prior twelve month period. The minimum amount that can be borrowed is \$1,000. Employees of Mueller Copper Tube Products, Inc. are not permitted to borrow funds from accumulated Company contributions. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

#### Payment of benefits

Upon termination of service due to death, disability or retirement a participant may elect to receive account distributions either in the form of a lump sum payment or installments over a period of time as defined in the plan document. For terminations due to other reasons, a participant may request the value of the vested interest in his or her account as a lump sum distribution. Withdrawals by a participant while employed are limited to those requested due to events of financial hardship as defined by the plan document or upon the attainment of age 59½.

#### Forfeited accounts

If an employee terminates before his or her employer contributions account has become fully vested, such nonvested portion of the account is forfeited. Participant forfeitures may be used to reduce future employer contributions or pay plan expenses.

### Note 2 - Summary of significant accounting policies

#### Basis of accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

#### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value, except for the fully benefit responsive contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which participant compensation is earned.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are netted with notes receivable from participants and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### Payment of benefits

Benefits are recorded when paid.

#### Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments.

### Note 3 - Information prepared and certified by the trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and the supplemental schedule is complete and accurate:

- Investments at fair value
- Fully benefit-responsive investment contract at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Dividend income
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the supplemental schedule.

### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below.

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4 - Fair value measurements (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust fund:* Valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Pooled separate account:* Invested in a single mutual fund - the Principal Capital Appreciation Institutional Fund (ticker PWCIX). Valued using a publicly quoted pricing input used in determining the net asset value (NAV) of the pooled separate account. The NAV is the basis for current transactions and the pooled separate account can be redeemed at NAV as of the measurement date. The fair value of the underlying mutual fund is based on third-party pricing vendors and utilize observable market information.

The fair value of the investment in the common/collective trust fund has been estimated using the NAV of the investments. Such investments are redeemed on a daily basis and do not have any redemption restrictions other than as disclosed above. Additionally, there are no unfunded commitments.

### Note 5 - Fully benefit-responsive investment contract

The Plan has a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company. Principal Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based upon a formula established by the contract issuer but may not be less than zero percent. The crediting interest rate is reviewed on an annual basis for resetting. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

### Note 5 - Fully benefit-responsive investment contract (continued)

The Plan's ability to receive amounts due is dependent upon the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount difference from contract value. Such events include the following: (1) obligation under the contract, (2) a break of material obligation under the contract, (3) a material representation, or (4) a material amendment to the agreements without the consent of the issuer.

### Note 6 - Related party transactions and party-in-interest transactions

Plan investments are held by Principal. Principal is the trustee for the Plan, and provides the Plan with certain recordkeeping and administrative services. The investments and related investment transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for investment management services are included in net appreciation in the fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments to the trustee of \$41,453 in 2024 and \$40,843 in 2023 for investment management and recordkeeping services which were not covered by revenue sharing. The plan sponsor pays directly any other fees related to the Plan's operations.

### Note 7 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would become 100% vested in their employer contributions.

### Note 8 - Tax status

The IRS has determined and informed the Company by letter dated January 11, 2017, that the Plan and the related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, plan management believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### Note 9 - Risks, uncertainties and concentrations

The Plan invests in various securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024, approximately 16%, 15%, and 17% of the Plan's investments were invested in the Vanguard Growth Index Fund, Fidelity 500 Index Fund, and Principal Fixed Income Guaranteed Option, respectively. At December 31, 2023, approximately 21% and 15% of the Plan's investments were invested in the Columbia Trust Stable Income I-0 Fund and in the Vanguard Growth Index Fund, respectively.

### Note 10 - Subsequent events

Plan management has evaluated subsequent events through August 25, 2025, which is the date that the financial statements were available to be issued.

On January 1, 2025, the Nehring Electrical Works Company LLC 401(k) Plan, United Acquisition, LLC 401(k) Plan, and Elkhart Products Corporation, LLC 401(k) merged into the Plan.
