Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Currie/Curfin Motors 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Currie/Curfin Motors 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the years then ended stating that the certified investment information, as described in the *Information Prepared and Certified by the Custodians* note to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America and
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Currie/Curfin Motors 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Currie/Curfin Motors 401(k) Plan ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

DESCRIPTION OF PLAN

The following description of the Currie/Curfin Motors (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. **General** - The Plan is a contributory, defined contribution plan for the benefit of eligible employees of the Company and related entities (Sponsor). The Sponsor is the Plan Administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Under the provisions of the Plan, employees become eligible to participate in the Plan upon reaching 21 years of age and completing one year of service. The Plan's Trustee is responsible for oversight of the Plan.
2. **Contributions** - The Plan provides for the following contributions:
 - a. **Employee Directed Contributions:** The Plan provides that participants may elect to contribute from 1 to 25% on a pre-tax basis of their eligible compensation for the portion of the plan year in which the employee is eligible to participate in the Plan. Contributions are subject to certain limitations imposed by the Internal Revenue Code (IRC).
 - b. **Sponsor Matching Contributions:** The Sponsor contributes to each eligible participant account a matching percentage of amounts contributed by the participant. The Sponsor match is at a rate of 25% of the first 5% of elective contributions, limited to 1.25% of the employee's compensation.
 - c. **Discretionary Sponsor Matching Contributions:** At the end of any year, the Sponsor may contribute an additional amount on a discretionary basis. Each employee will receive a pro rata share equal to the ratio of their elective contributions to all elective contributions multiplied by the amount of the discretionary contribution. No discretionary Sponsor matching contributions were made in 2024 and 2023.
 - d. **Qualified Discretionary Contributions:** The Sponsor may, but is not required to, make contributions for non-highly compensated employees to assure the Plan satisfies certain statutory nondiscrimination testing requirements. No qualified discretionary contributions were made in 2024 and 2023.
 - e. **Rollover contributions:** The Plan provides that participants may contribute amounts distributed or transferred from another qualified deferred compensation plan.
3. **Participants' Accounts** - Each participant's account is credited with the participant's contribution and Sponsor matching contributions, as well as allocation of discretionary Sponsor matching contributions, qualified discretionary contributions,

- if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. Vesting - Participants are immediately vested in their employee-directed, qualified discretionary and rollover contribution accounts and earnings thereon. Vesting in the Sponsor matching and discretionary Sponsor matching contributions plus actual earnings thereon are based on years of continuous service. A participant is 100% vested after six years of credited service.
 5. Investment Options - Upon enrollment in the Plan, each participant directs the investment of all amounts allocated to their account based on the list of investment alternatives available under the Plan.
 6. Payment of Benefits - Upon eligibility for benefits, the participant may elect one of several methods to distribute the value of the participant's vested account balance, as defined by the Plan. Benefits are recorded when paid. As of December 31, 2024, and 2023, the vested but unpaid balances of terminated participants amounted to \$9,102,928 and \$6,903,218, respectively. The Company elected to make qualified non-election contributions in 2025 and 2024 in lieu of returning excess deferral amounts to participants. The amount of qualified non-election contributions in 2025 and 2024 were \$9,440 and \$38,060, respectively.
 7. Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of the vested portion of their account balance, or \$50,000, reduced by the highest outstanding balance during the prior 12-month period. Loans provide for periodic repayment over a period of five years or less unless the loan is in connection with the participant's principal residence. The interest rates and types of collateral required are contained in the Plan documents. Principal and interest are paid ratably through payroll deductions. All interest paid with respect to these loans is credited to the participant's individual account. Any loss or expense associated with the loan is borne by the participant.
 8. Forfeited Accounts - On December 31, 2024, and 2023, forfeited non-vested accounts totaled \$59,659 and \$21,823, respectively. At the Plan Administrator's discretion, forfeitures may be used to reduce the Sponsor's contributions to the Plan and/or to pay administrative expenses. During 2024, \$22,000 of forfeited non-vested accounts were used to reduce the Sponsor contributions.

9. Administrative Expenses - Investment management services and expenses related to the administration of the Plan are substantially paid by the Plan. The Company absorbs a portion of these expenses. Investment related expenses are included in net appreciation of fair value of investments.
10. Other Income - Pursuant to its service agreement with Transamerica, an Expense Budget Account (EBA) was established for the purpose of paying Plan expenses. Total amounts credited to the EBA for the years ended December 31, 2024 and 2023 were \$48,178 and \$39,785, respectively. During the years ended December 31, 2024 and 2023, \$48,178 and \$39,785 were used to pay Plan administrative expenses. There was no balance in the EBA as of December 31, 2024 and 2023.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition:

Shares of mutual are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The value of the Insurance Company General Account is determined by using a discounted cash flow valuation methodology where the interest rate for the contract is reset biannually. The investment is valued at contract value, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on an accrual basis and dividends are recorded on the ex-dividend date.

The Plan presents, in the Statements of Changes in Net Assets Available for Benefits, the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized gains or losses of those investments.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued):

Notes Receivable from Participants:

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2002, the Plan entered into a benefit-responsive investment contract with Transamerica. Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The stable value option contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in the *Summary of Significant Accounting Policies* note, because the investment contract is fully benefit-responsive, contract value is the relevant measurement attributable for that portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings at guaranteed credit rates, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent. The crediting rates as of December 31, 2024, and 2023 were 2.06% and 1.64%, respectively. Such interest rates are reviewed monthly for the purpose of resetting. The stable value fund does not permit the insurance company to terminate the agreement prior to the schedule maturity date.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes in the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

FAIR VALUE MEASUREMENTS

Generally accepted accounting principles in the United States of America have established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. See *Summary of Significant Accounting Policies* for a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The valuation methods described in the *Summary of Significant Accounting Policies* may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

PARTY-IN-INTEREST TRANSACTIONS

Since Transamerica provided services to the Plan, the investment in the benefit-responsive investment contract constitutes a party-in-interest investment as defined by ERISA. Fees paid by the Plan to Transamerica amounted to \$39,739 and \$26,091, respectively, for the years ended December 31, 2024 and 2023.

Certain employees of the Sponsor provide trustee and administrative services to the Plan. These employees do not receive any compensation from the Plan for their services. Also, certain administrative expenses were paid by the Sponsor on behalf of the Plan, which are excluded from these financial statements.

PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

INCOME TAX STATUS

The Company adopted a volume submitter plan sponsored by Transamerica Retirement Solutions Corporation that obtained its latest opinion letter dated April 7, 2009, in which the Internal Revenue Service stated the prototype plan, as then designed, was acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and believes the Plan was qualified and related trust was tax-exempt as of the financial statements date.

Generally accepted accounting principles in the United States of America requires that Plan management evaluate each tax position taken by the Plan and recognize a liability (or asset) if the Plan has taken an uncertain tax position that more-likely-than-not (i.e., a likelihood of more than 50%), based on the technical merits, would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken. Accordingly, the Plan has recognized no interest and penalties associated with any liability for unrecognized tax benefits. The Plan's policy is to record such amounts, if any, as income tax expense. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.
