## Report of Independent Auditors

To the Administrator of Pretium 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. ### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with US GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### ***Other Matter – Supplemental Schedule Required by ERISA***

Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 (“supplemental schedule”) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **1. Description of the Plan**

The following description of the Pretium 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document or the Plan's Summary Plan Description, not included herein, for a more complete description of the Plan and its provisions.

**General**

The Plan is a profit-sharing defined contribution plan established for the benefit of the employees of Pretium Employer, LLC (the Company), and is subject to the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is a Safe Harbor Plan. Under a Safe Harbor Plan, all required employer contributions are fully vested when made. The Company is the sponsor (Plan Sponsor). The Company appointed Ascensus, LLC as the record keeper, The Vanguard Group, Inc. (Vanguard) as the trustee and custodian, and Fiduciary Wise, LLC as the administrator (Plan Administrator). Vanguard, in its capacity as trustee and custodian, has retained Ascensus, LLC and Ascensus Trust Company as a subcontractor to provide all services as the custodian and trustee.

The Plan covers all full-time employees of the Company. Employees become eligible to make pre-tax deferral or Roth deferrals after entering the Plan and attaining the age of 21. Employees are not required to complete a service requirement before they are eligible to defer a portion of their pay to the Plan. Additionally, employees are not required to contribute a portion of their compensation into the Plan. An employee who elects to not contribute to the Plan will not be enrolled in the Plan as a contributing participant. An eligible employee can periodically adjust their deferral amount.

**Contributions**

Participants may contribute up to the maximum contribution limit provided by the Internal Revenue Code (the Code), currently \$23,000. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company has elected to operate this Plan as a Safe Harbor 401(k) Plan, as defined by the Department of Labor (the DOL). As such, the Plan will be exempt from certain compliance testing requirements because of the safe harbor contributions that will be made into the Plan. Once an employee meets the eligibility requirements and begins making contributions, the Company will make a safe harbor 401(k) matching contribution based on the amount the employee elected to contribute into the Plan as a pre-tax deferral or Roth deferral which also includes any catch-up contributions. Employees will receive a matching contribution of 100 percent of the first 3 percent contributed by the employee, and 50 percent of the contributions made between 3 percent and 5 percent. These contributions are 100 percent vested and cannot be forfeited, even if the employee terminates employment.

The Company also may choose to make a contribution to the Plan as a profit-sharing contribution. Profit-sharing contributions are subject to a vesting schedule and could be forfeited if employment is terminated. To qualify to receive profit-sharing contributions, an employee must meet eligibility requirements and must also have at least 6-months of service during the Plan year and be employed on the last day of the Plan year. For the year ended December 31, 2024, there were no profit-sharing contributions.

All eligible participants are eligible for nonelective employer contributions. Nonelective contributions are contributions the Company may make into the Plan to satisfy certain nondiscrimination tests that apply to the Plan. The amount of the nonelective contributions is determined by the Company each year. These contributions will be allocated to a select group of participants and will always be fully vested. For the year ended December 31, 2024, there were no nonelective employer contributions.

**Participant Accounts**

Each participant's account consists of the participant's contribution (pre-tax deferral and Roth deferral), the Company's nonelective contributions, the Company's safe harbor matching contribution, the allocation of the Company's profit-sharing contributions and earnings on the invested balances. Allocations of nonelective and profit-sharing contributions to participants' accounts are based on participant compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Notes Receivable from Participants**

Participants may apply for a loan to be made from their vested balance in the Plan for a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. A participant may have two outstanding loans at a time. Loans are secured by the balance in the participant's account. Loans issued bear a fixed rate of interest at the prime lending rate plus 2% at the time the loans are issued. Principal and interest are repaid ratably through payroll deductions. Generally, participants must repay loans within 5 years, unless the loan is used to purchase a primary residence. No allowance for credit losses has been recorded as of December 31, 2024, or 2023. For the years ended December 31, 2024, and 2023, the interest rates on participant loans ranged from 5.25% to 10.50% and 5.25% to 9.50%, respectively.

**Payment of Benefits**

The Plan is designed to provide benefits at the time of retirement. However, if employment is terminated because of death, disability, or for any other reason, participants may request a distribution of their account balance from the Plan Administrator. Furthermore, upon approval by the Plan Administrator, participants may be entitled to take distributions from rollover contributions to satisfy certain immediate and heavy financial needs. Participants can elect to withdraw all, or a portion of their account while still employed, upon attainment of age 59 ½.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Investments**

Upon enrollment in the Plan, a participant has the right under the Plan's provisions to direct contributions into any of the Plan investment fund options maintained by Vanguard. Participants can individually direct both employee and employer contributions made on their behalf.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

**Administrative Expenses**

The Plan has entered into service contracts with outside consultants and agencies to perform certain administrative services for the Plan. The fees for these services are paid by the Plan.

**Notes Receivable from Participants**

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest and classified as notes receivable from participants in the Statements of Net Assets Available for Benefits. Delinquent loans are reclassified as benefit payments based on the terms of the Plan document. Interest income is recorded on the accrual basis.

**Investment Valuation and Income Recognition**

Assets and liabilities measured at fair value are categorized into a fair value hierarchy based on whether the inputs to valuation techniques are observable or unobservable. Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Company's own assumptions about the assumptions market participants would use. The fair value hierarchy includes three levels of inputs that may be used to measure fair value as described below.

Level 1 – Quoted prices in active markets for identical assets or liabilities. Level 1 assets and liabilities include mutual funds that are traded in an active exchange market

Level 2 – Observable inputs other than Level 1 prices such as quoted prices in active markets for similar assets or liabilities; quoted prices for identical or similar assets or liabilities in markets that not active; or other inputs that are observable or can be corroborated by observable market data for sustainability the full term of assets or liabilities.

Level 3 – Unobservable inputs that are supported by little or no market activity and are significant to the fair value of the assets or liabilities. Level 3 includes assets and liabilities whose value is determined using pricing models, discounted cash flow methodologies, or similar techniques reflecting the Company's own assumptions about the assumptions market participants would use as well as those requiring significant management judgement.

The Plan's investments are recorded at fair value which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized gains or losses on the sale of investments together with unrealized appreciation or depreciation on investments are presented as net appreciation in fair value of investments. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**3. Certification from the Trustee**

As permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the ERISA, the following information, including investments balances and related investment information in the notes to the financial statements and supplemental schedules required by ERISA, but excluding the fair value measurement leveling, were certified as to completeness and accuracy by Ascensus, acting as an agent for Ascensus Trust Company.

**4. Fair Value Measurements**

The Plan's investments are reported at fair value in the statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were only used when Level 1 inputs were not available.

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year-end. The Plan's investments at fair value were all Level 1 as of December 31, 2024 and 2023.

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024 is reported in net appreciation in fair value of investments.

**5. Risks and Uncertainties**

The Plan invests in various investments which, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Furthermore, due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes, could materially affect the amounts reported in the statement of net assets available for benefits.

**6. Tax Status**

The Plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020 stating the written form of the underlying plan document is qualified under Section 401(a) of the Code, and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the Code. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification.

The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt. Accordingly, no provision for income taxes has been made in the accompanying financial statements.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**7. Party-in-interest Transactions**

Parties-in-interest are defined under the DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. During 2024, administrative fees of \$1,800 were paid by the Plan to Vanguard. The Plan Sponsor paid fees for accounting and audit services. Notes receivable from participants and related interest income from participants also qualify as part in interest transactions.

Certain Plan investments are shares of mutual funds managed by Vanguard. Since Vanguard is the trustee as defined by the Plan these investments qualify as party-in-interest transactions.

**8. Subsequent Events**

Management has evaluated subsequent events and transactions through October 1, 2025, the date the financial statements were available to be issued, and has determined there are no subsequent events that require adjustment to or disclosure in the financial statements.
