1. Description of Plan

The following description of the IG Design Group Americas Inc. 401(k) Plan (Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of IG Design Group Americas, Inc. (IG Design Group), Anker Play Products, Berwick Offray LLC, C.R. Gibson LLC, Cleo Inc., Don Post Studios, Impact Innovations, Inc., LR Texas Corp., Lion Ribbon Company, Inc., McCall Pattern Company, Simplicity Creative Corp., The Lang Companies, Inc., and The Paper Magic Group, Inc. (collectively, the Company) who have completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The IG Design Group Americas Plan Administrator Committee is responsible for the oversight and determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors.

Contributions

Each year, participants in the Plan may contribute up to 100% of pretax compensation, as defined. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans, individual retirement accounts or annuities. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in the applicable Target Date Fund that most closely aligns with their projected retirement date based upon their birth year until changed by the participant. Participants who are still automatically enrolled in the Plan with a deferral rate of greater than zero will have their deferral increased annually by 1% as a pre-tax deferral contribution until a deferral rate of 10% is achieved.

Each participating employer, at the discretion of its Board, may make matching and profit sharing contributions on behalf of eligible participants to the Plan. There was no profit sharing contribution for 2024.

The matching contribution for 2024 was:

- 60% of the first 10% of eligible compensation contributed to the Plan by participants who were employed by Anker Play Products, Impact Innovations, Inc., and The Lang Companies, Inc. as of February 28, 2021
- the amount provided by the applicable collective bargaining agreement for union employees
- 50% of the first 5% of eligible compensation contributed to the Plan by all other participants

Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account, including earnings thereon, is based on years of credited service and a graduated vesting schedule, with 100% vesting after completion of three years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their total vested account balance. The loans are secured by the balance in the participant's account and bear a fixed rate of interest based on the prevailing rates charged by persons in the business of lending money for loans which would be made under similar circumstances at the time the loan was established. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

A participant is eligible to receive a single sum distribution of the vested balance of their account on separation from service with the Company. A participant whose vested balance is \$5,000 or less cannot defer receipt of their distribution. The Plan also provides for the following in-service withdrawals, subject to the Plan's provisions:

- Hardship withdrawals
- Withdrawals after age 59½
- Withdrawals after age 70½
- Withdrawals after normal retirement age
- Withdrawals of after-tax contributions
- Withdrawals of qualified voluntary employee contributions
- Withdrawals of rollover contributions
- Withdrawals for participants performing qualified military service

Forfeited Accounts

Forfeited accounts totaled \$71,065 at December 31, 2024 and \$133,970 at December 31, 2023. Forfeitures are used to reduce future employer contributions and for the payment of administrative expenses. In 2024, forfeited nonvested accounts were used to reduce employers' contributions by \$165,950.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-response investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The IG Design Group Americas Plan Administrator Committee determines the Plan's valuation policies utilizing information provided by investment advisers and Fidelity Management Trust Company (Trustee). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and express mail fees are charged directly to the participant's account and are included in administrative expenses. Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation in fair value of investments.

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee and Massachusetts Mutual Life Insurance Company (Custodian) have certified that the following information included in the accompanying financial statements is complete and accurate:

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Fund and Mutual Funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Investment Agreement with Custodian

The Plan has an investment agreement with the Custodian. This agreement is a group annuity contract that funds benefits for plans satisfying the requirements under section 401 of the Internal Revenue Code. Under the terms of the agreement, 100% of the contributions are allocated to the MassMutual Core SAGIC II separate investment account (MM SAGIC Fund).

The Trustee maintains an accounting record for the Plan of the amounts allocated to the MM SAGIC Fund on the Plan's behalf. The amounts allocated include contributions and interest received, withdrawals made, and fees charged. The Custodian is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The Custodian establishes the crediting interest rate on a quarterly basis and the crediting interest rate cannot be less than 0%. The crediting interest rate was 2.64% for the quarter ending December 31, 2024 and 4.13% for the quarter ending December 31, 2023.

The MM SAGIC Fund meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Custodian, represents contributions made to the MM SAGIC Fund, plus earnings at guaranteed crediting rates, less withdrawals and fees. The contract value of the MM SAGIC Fund was \$14,313,471 at December 31, 2024 and \$16,060,074 at December 31, 2023. Participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account balance at contract value.

There are no reserves against contract value for credit risk of contract issuers of the underlying investments. Certain events allow the Custodian to terminate the agreement. Such events include the Plan providing effective communication to the Custodian that the agreement will be fully or partially terminated as of a specified date not less than 30 days after the date such communication is provided, a determination by the Internal Revenue Service that the Plan no longer meets the requirements of the Internal Revenue Code, the termination or partial termination of the Plan, breaches of a provision of the agreement, and the Custodian providing effective communication to the Plan that the agreement will be terminated as of a date at least 90 days from the date of communication. No events are probable of occurring with the exception of the subsequent events (Note 11) that might limit the ability of the Plan to transact at contract value with the Custodian and that also would limit the ability of the Plan to transact at contract value with the participants; applicable communication to the Custodian will be made.

6. Related Party and Party in Interest Transactions

Certain Plan investments are shares of mutual funds managed by the Trustee. These transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. In 2024 the Trustee was paid \$154,736 of fees for the administration of participant accounts, notes receivable from participants, withdrawal fees, express mail fees, and other services. Administrative fees paid to third parties were \$31,500 in 2024.

The service agreement with the Trustee includes participant revenue credits and revenue credit programs, collectively Revenue Credits. In situations where the recordkeeping revenue received in connection with services exceeds agreed upon compensation, the Trustee can allocate amounts equal to such excess revenue to accounts of eligible participants as negative expenses, participant revenue credit, or deposit amounts equal to such excess revenue in a suspense account, revenue credit program. The total Revenue Credits for 2024 that reduced administrative expenses in the accompanying statement of changes in net assets available for benefits was \$161,602. The balance in the revenue credit program suspense account was \$28,729 at December 31, 2024 and \$35,484 at December 31, 2023. The revenue credit program is used for the payment of administrative expenses.

Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan.

7. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions (Note 11).

8. Tax Status

The Plan adopted a non-standardized pre-approved profit sharing plan with cash or deferred arrangement, which received a favorable opinion letter from the IRS dated June 30, 2020 indicating that Plan was acceptable under section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees (Opinion Letter). Although the Plan has been amended since receiving the Opinion Letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and the related trust is tax exempt.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan had investments of \$46,225,670 at December 31, 2024 and \$45,483,175 at December 31, 2023, concentrated in three investments.

11. Subsequent Events

The Plan has evaluated, for consideration of recognition or disclosure, subsequent events that have occurred through the date of issuance, September 18, 2025, and has determined that, except for the matters noted below, no significant events occurred after December 31, 2024, but prior to the issuance of the financial statements, that would have a material impact on these financial statements.

The Company was sold on May 30, 2025. Following the sale, the Company filed for Chapter 11 protection in the U.S. Bankruptcy Court on July 3, 2025. The Company terminated the employment of 333 employees in July and August 2025; the termination of employees on August 26, 2025 triggered a partial plan termination. As required by law, all affected employees as of the date of partial plan termination became 100% vested in all employer contributions. The Company anticipates the Plan will be terminated in 2026.
