INDEPENDENT AUDITOR'S REPORT

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of The Quadrangle Companies' Tax Deferred Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Quadrangle Companies' Tax Deferred Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.



### 1. Plan Description

The following description of The Quadrangle Companies' Tax Deferred Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established by RGA, Inc. (the Plan Sponsor) under the provisions of Section 401(k) of the Internal Revenue Code (IRC). The Plan covers all employees of Quadrangle Development Corporation, Quadrangle Management Company, Quick Park Inc., and their affiliated companies who have adopted the Plan (collectively, the Companies), who are 21 years of age or older, who are regularly scheduled to work at least 30 hours per week after completing their first hour of service, and who have completed an eligibility year of service (defined as 1,000 hours of service beginning on the date the employee first performs an hour of service). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Fidelity Management Trust Company (FMTC) is the trustee of the Plan and Fidelity Workplace Services LLC (Fidelity) is the Plan's recordkeeper.

#### Contributions

Employees are automatically enrolled in the Plan after meeting the applicable eligibility requirements with a deferral of 3% of their compensation unless they affirmatively elect another deferral amount or elect not to participate in the Plan. Participants may elect to defer between 0% and 90% of their compensation, subject to statutory limitations established annually by the IRC. Participants may also make Roth elective deferrals and participants who are aged 50 or older by the end of the plan year may elect to contribute catch-up contributions up to the maximum allowed by the IRC.

Employer contributions are discretionary and determined on an annual basis. The employer's discretionary matching contribution for the 2024 plan year, as determined by the Companies' board of directors, was 50% of the participant's total deferrals for the year on deferrals up to 6% of eligible compensation. The Companies can also make discretionary profit-sharing contributions; however, no profit-sharing contributions were made during the year ended December 31, 2024.

Contributions are subject to certain limitations imposed by the IRC.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Companies' contributions, and allocations of the Plan's income, losses, and expenses, in accordance with the Plan Document. Participants direct their investments and may change their investment options anytime throughout the year via direct access to the Fidelity website. The benefit to which a

participant is entitled is the benefit that can be provided by the participant's vested account balance.

### **Vesting**

Participants are immediately vested in their contributions and the earnings thereon. A participant vests in employer contributions and earnings thereon according to the following schedule of service:

### **Payment of Benefits**

Plan benefits are available at normal retirement age (65), disability, death, or termination of service. Participants may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account or roll over the value of the participant's vested interest in their account into another qualified plan. The Plan also allows for in-service distributions upon reaching age 59½.

If the participant's vested account balance is less than \$1,000, it will be paid in a lump-sum amount. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. Participants may also receive hardship withdrawals, as defined by the Plan.

### **Administrative Expenses**

Administrative fees charged by the trustee and recordkeeper and investment advisory fees are paid by the Plan. Other administrative expenses are paid by the Companies.

### **Forfeited Amounts**

Forfeitures consist of the portion of employer contributions not vested as of a participant's date of termination and can be used to reduce employer contributions or pay plan expenses. As of December 31, 2024 and 2023, forfeitures of \$19,500 and \$6,931, respectively, were available to offset future employer contributions. During the year ended December 31, 2024, the Companies used forfeitures totaling \$1,615 to pay plan expenses.

### **2. Summary of Significant Accounting Policies**

#### **Date of Management's Review**

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

#### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with U.S. generally accepted accounting principles (GAAP).

#### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Income, Investment Valuation and Transactions**

The Plan's investments are reported at fair value, which is the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation of investments includes the gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

### **3. Tax Status**

The Plan adopted the FMR LLC Pre-Approved Defined Contribution Plan, which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the plan administrator and the plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

GAAP requires the Plan's management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable federal and state tax authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of

December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to audits for years prior to 2020.

#### 4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value that prioritizes the inputs to valuation techniques used to measure fair value as follows: Level 1, investments are valued using unadjusted quoted prices for identical assets in active markets; Level 2, investments are not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to investments valued based on significant unobservable inputs.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market funds (interest bearing cash):* Valued at cost, which approximates fair value (Level 1).

*Registered Investment Companies (mutual funds):* Investments held in mutual funds are valued at quoted daily closing prices as of the last trading day of the Plan year. The mutual funds held by the Plan are deemed to be actively traded. There are no restrictions on redemption, and the funds can be redeemed daily (Level 1).

*Collective Fund:* Investments in the Fidelity Managed Income Portfolio II, a collective fund, are valued at NAV, as a practical expedient. NAV, or contract value, as reported to the Plan by FMTC represents contributions made under the contract, plus earnings, less participants withdrawals, and administrative expenses. Participant purchases and sales may occur daily. If the Plan were to proceed with a full redemption of the collective trust, the issuer reserves the right to temporarily delay the withdrawal from the trust to ensure that the liquidation of the securities is completed in an orderly fashion. As of December 31, 2024 and 2023, the collective fund had no unfunded commitments.

#### 5. Related Party and Party-in-Interest Transactions

The Plan holds investments in funds managed by FMTC and these transactions are considered party-in-interest transactions, however they are exempt from the prohibited transaction rules under ERISA. The Plan pays investment advisory fees to RBC Wealth Management, which are considered party-in-interest transactions. Certain expenses, including audit fees, are paid by the Sponsor on the Plan's behalf.

#### 6. Plan Termination

Although they have not expressed any intent to do so, the Companies or the Plan Sponsor have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in employer contributions made on their behalf.

### **7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market fluctuations, and credit risks. Market risks include global events, such as a pandemic or international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. During the year ended December 31, 2024, the plan administrator conducted periodic reviews of investment options as part of the Plan's overall risk management.

### **8. Custodian and Trustee Certified Information**

FMTC, the trustee of the Plan, has certified the following information as complete and accurate: investments in registered investment companies, collective fund, and interest-bearing cash included in the Statements of Net Assets Available for benefits as of December 31, 2024 and 2023, and the net appreciation in fair value of investments and dividends included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
