INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of TNI Staffing, Inc. f/k/a OR Nurses Nationwide, Inc., 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 – Description of plan

The following description of the TNI Staffing, Inc. f/k/a OR Nurses Nationwide, Inc., 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of TNI Staffing, Inc. f/k/a OR Nurses Nationwide, Inc. (the “Company”) who have attained the age of 21 and completed three months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute a percentage of pretax annual compensation, subject to limits defined by the Internal Revenue Code. Participants can also contribute amounts from other qualified defined benefit or contribution plans. Participants aged 50 or older are eligible to make catch-up contributions as outlined in the Plan. The Company matches contributions dollar for dollar up to a max of \$500 for all participants who have worked a minimum of 1,000 hours during the plan year and are active employees on the last day of the calendar year. Additionally, for the non-highly compensated corporate participants the Company makes a discretionary contribution of deferrals up to 4% of each participant’s eligible compensation, as defined by the plan.

Participant accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The participant accounts are valued yearly at the end of the Plan year.

Investments

Participants may direct contributions in various mutual fund investment options. Participants may change their investment options and transfer previously contributed amounts between mutual funds at any time.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching contributions is on a graded vesting schedule as follows:

Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Distributions are made as soon as administratively feasible following termination. Upon termination, participant accounts in excess of \$5,000 will be directly rolled over into an IRA.

Notes receivable from participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance during the 12-month period ending on the day before the new loan is made or 50% of their vested account balance. The loans are secured by no more than 50% of the vested balance in the participant's account and bear a fixed interest rate of the prime rate plus 1%, which is commensurate with local prevailing rates as determined at the time of issuance by the Plan Administrator. A loan is considered in default if a scheduled payment is not made by the end of the cure period, defined as the repayment period allowed by the Plan Administrator which will not extend beyond the last day of the calendar quarter following the calendar quarter during which the last scheduled installment payment was due but not made. Principal and interest are paid ratably, not less frequently than quarterly, through payroll deductions. Loan terms may not be greater than five years unless the loan is used for purchase of primary residence. The maximum number of loans a participant may have outstanding at any time is two.

Forfeited accounts

For years ending December 31, 2024 and 2023, forfeited employer contributions totaled \$2,496 and \$0, respectively. These accounts will be used to pay plan expenses and reduce future employer contributions. After payment of Plan expenses, forfeitures may be reallocated to participants in the same manner as employer contributions. During the years ended December 31, 2024 and 2023, there were no forfeitures used to pay Plan expenses.

Date of management's review

Management has evaluated subsequent events through October 1, 2025, which was the date the financial statements were available to be issued, for possible recognition of disclosure in the financial statements. Management has determined that there are no material events or transactions that would require recognition or disclosure in the Plan's financial statements.

Note 2 – Summary of significant accounting policies*Basis of accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates in the preparation of financial statements

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements.

Realized and unrealized appreciation (depreciation) in the fair value of investments is based on the difference between the fair value of the assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation).

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator considers the participant loan to be in default, the participant loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan Document.

Plan expenses

The Plan pays various transaction fees and some administrative expenses and the Company pays some basic administrative expenses of the Plan as provided in the Plan document.

Payment of benefits

Benefit payments to participants are recorded when paid. There are no provisions under the Plan for hardship distributions.

Plan Funding

All monies contributed to the Plan are held in a trust. The Plan custodian is responsible for safekeeping of the trust fund and must hold and invest Plan assets in a prudent manner and in the best interest of the Plan participants.

Note 3 – Information prepared and certified by custodian

The following is a summary of the information included in the Plan's financial statements and supplemental schedule for 2024 which was prepared by the trustee of the Plan assets, John Hancock Life Insurance Company, and furnished to the plan administrator. The plan administrator has obtained a certification from the trustee that such information is complete and accurate.

- A. Investments at the beginning and end of the year.
- B. Notes receivable from participants at the beginning and end of the year.
- C. Changes in net assets resulting from investment activities
- D. Information included in the supplemental schedule of assets (held at end of year).

Note 4 – Fair value measurements

FASB Accounting Standards Codification ("ASC") 820, *Fair Value Measurement and Disclosures*, provides a common definition of fair value and establishes a framework for measuring fair value. ASC 820 defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. ASC Topic 820 also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value, and describes three levels of inputs that may be used to measure fair value.

- Level 1 - Quoted prices for identical assets in active markets that the entity has the ability to access as of the measurement date.
- Level 2 - Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, and other inputs that are observable or can be correlated by observable market data.
- Level 3 - Significant unobservable inputs that reflect a plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

Notes to the Financial Statements

December 31, 2024 and 2023

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts: Valued at net asset value (“NAV”) of units held by the Plan at year end, as determined by the issuer, based on the fair market value of the underlying investments. These consist of investments funds made up of a variety of different investment assets. Accordingly, each individual underlying asset is evaluated to determine where its fair value measurement falls within the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Tax status

The Plan operates under the Ellis & Ward Consulting Group Defined Contribution Prototype Plan. This prototype document has received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020. The letter states that the prototype Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”).

Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code.

The Plan is subject to routine audits by various taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

Note 6 – Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the plan, distributions are to be made as soon as administratively feasible and participants would become 100% invested in their employer contributions.

Note 7 – Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 – Transactions with parties-in-interest

John Hancock Life Insurance Company was the recordkeeper and Ellis & Ward Consulting Group was the third party administrator during the year ended December 31, 2024, as defined by the Plan and, therefore, transactions with these companies qualify as exempt party-in-interest transactions.

Fees paid by the Plan to John Hancock Life Insurance Company for contract administration fees were \$27,110 and \$21,637 during the years ended December 31, 2024 and 2023, respectively.

Fees paid by the Plan to Ellis & Ward Consulting Group for third party administrator service fees were \$5,843 and \$1,795 during the years ended December 31, 2024 and 2023, respectively.

Investment advisory fees of \$17,077 and \$14,197 were paid to Waddell and Associates LLC during the years ended December 31, 2024 and 2023, respectively.

Note 9 – Separated participants

At December 31, 2024 and 2023, the Plan held balances for participants who have terminated totaling \$1,464,583 and \$1,022,586, respectively.
