We have performed audits of the financial statements of BDO USA Retirement Plan (formerly BDO USA, LLP Retirement Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of BDO USA Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of BDO USA Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about BDO USA Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with auditing standards generally accepted in the United States of America, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of BDO USA Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about BDO USA Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter

Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the BDO USA Retirement Plan (formerly BDO USA, LLP Retirement Plan) (the Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan 401(k) and profit sharing covering all eligible principals, client service and administrative employees of BDO USA, P.C. (formerly BDO USA, LLP) and certain affiliates (the Company). Principals and employees are eligible to participate upon initial employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Operations

The Company has appointed T. Rowe Price Trust Company (Trustee) to serve as Trustee and a fiduciary committee of employees of the Company to act as plan administrator. The Trustee is responsible for holding the investment assets of the Plan, executing investment transactions, and making distributions to participants. The plan administrator interprets and communicates the provisions of the Plan and ensures that all government and participant reporting requirements are fulfilled. The Plan's fiduciary committee is responsible for oversight, determines the appropriateness of the Plan's investment strategy, and monitors investment performance.

Contributions

Each year, participants may contribute to the Plan up to 75 percent of compensation, as defined by the Plan. The Plan has an automatic or passive enrollment feature with a 3 percent 401(k) pre-tax deferral for all eligible new hires and rehired employees excluding principals. The automatic deferral percentage shall be increased on a uniform basis for all participants with this feature as of August 1 of each year by 1 percent of compensation, up to a maximum of 20 percent of compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

Upon enrollment in the Plan, a participant may direct employer and employee contributions in any of various investment options. Participants may change their investment options daily.

Prior to January 1, 2024, for principals, client service professionals and certain administrative employees, the Company matches 50 percent of each participant's elective deferral up to 8 percent of compensation for those with three or more years of employment and 25 percent of each participant's elective deferral up to 8 percent of compensation for those with less than three years of employment after eligibility is reached. Any rollovers from other qualified plans are held in a participant's rollover account.

Prior to January 1, 2024, for certain administrative employees, the Company generally matches 50 percent of each participant's elective deferral up to 6 percent of compensation for those with three years of employment, and 25 percent of each participant's elective deferral up to 6 percent of compensation for those with less than three years of employment after eligibility is reached.

Contributions (Continued)

As of January 1, 2024, for all groups of employees, upon eligibility, the Company matches 50 percent of each participant's elective deferral up to 8 percent of compensation for those with three or more years of employment, and 25 percent of each participant's elective deferral up to 8 percent of compensation for those with less than three years of employment.

Prior to January 1, 2024, certain principals and administrative employees were allocated a profit-sharing contribution based on a percentage of the participant's earnings. For the year ended December 31, 2023, the profit-sharing contribution for eligible employees was 7.5 percent of the participant's compensation. This contribution was reported as a receivable at December 31, 2023.

As of January 1, 2024, for all groups of employees, the Company may allocate a profit-sharing contribution based on a percentage of the eligible participant's earnings. There was no profit-sharing contribution made for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

A participant's interest in his/her elective deferrals, employer matching contributions and rollovers are fully vested at all times and not subject to forfeiture for any reason. A participant's interest in his/her profit-sharing contribution is vested after three years of service, as defined by the Plan.

Notes Receivable from Participants

Notes receivable from participants are limited to the lesser of \$50,000 or 50 percent of a participant's vested account balance. On notes generated within the Plan, terms may not exceed five years, unless the note is used to acquire a participant's principal residence, in which case the note may not exceed ten years, and notes bear interest equal to the prime rate at loan origination plus 1 percent. Certain notes rolled into the Plan from acquired firms may differ in maturity terms and interest rates. Notes receivable are secured by the vested balance in the participant's account. Principal and interest are paid in equal installments through payroll deductions.

Payment of Benefits

A participant receives benefits upon retirement age of 59 ½, termination of service, disability, or death. A participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or installments. Hardship distributions are permitted under certain conditions.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited accounts totaled \$486 and \$1,584, respectively. These accounts will be used to reduce future employer contributions. During the years ended December 31, 2024 and 2023, the Company's matching contributions were reduced by approximately \$69,000 and \$67,000, respectively, from forfeited accounts.

Plan Amendments

The Plan was amended effective July 1, 2023 to change the sponsor entity type from a Partnership to a C-corporation. Effective August 30, 2023, the Plan was amended to change the Plan Sponsor's name to BDO USA, P.C. and the Plan name from BDO USA, LLP Retirement Plan to BDO USA Retirement Plan.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions and Contributions Receivable

Participant contributions and any related employer contributions are recognized in the period during which the Company makes the respective payroll deductions from the participant's compensation. Discretionary profit-sharing contributions, if any, are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions, in the amount of \$39,966 and \$45,529 to the applicable participants prior to April 15 of the following years, respectively.

Transfers from Related Plan

During 2024, net transfers in the amount of \$39,933,591 were received from the BDO USA, LLP Cash Balance Plan.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Additionally, participants can pay for investment advice from a consultant which is charged directly to the participant's account and is included in administrative expenses. The remaining administrative expenses are recordkeeping expenses paid to the Trustee. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

Other Income

In April of 2022, certain participants of the Plan filed a complaint against the Plan, the Board of Directors, and the Retirement Plan Committee related to their fiduciary duties as administrators of the Plan. The lawsuit was resolved on December 14, 2023, with a settlement of \$2,250,000. During the year ended December 31, 2024, \$1,138,985 was contributed to the Plan, and was allocated amongst the members of the settlement. This amount is reported as other income on the Statement of Changes in Net Assets Available for Benefits.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustee, T. Rowe Price Trust Company, a qualified institution.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820, Fair Value Measurement, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets,
- quoted prices for identical or similar assets or liabilities in inactive markets,
- inputs other than quoted prices that are observable for the asset or liability, and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There were no plan assets requiring the use of Level 3 inputs for the periods presented. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market and mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts (CCTs): Units held in CCTs are valued at the net asset value (NAV) as reported by the trustee, which is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The CCTs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. There are no unfunded commitments related to these investments.

5. Party-in-Interest and Related-Party Transactions

Certain investments are managed by the Trustee. Therefore, the Plan's investments in these funds qualify as party-in-interest transactions. Administrative fees paid to the Trustee were \$734,108 for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. Plan Termination

The Company may, at its discretion, amend or discontinue the Plan. In the event of complete termination of the Plan, each participant will become fully vested in their accounts.

7. Tax Status

The plan adopted the Volume Submitter Profit Sharing Plan with CODA with Document Agility Inc. The underlying non-standardized prototype plan has received an opinion letter from the IRS, dated June 30, 2020, stating that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Contingencies

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
