## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of One Degree 403(b) Plan, formerly the Alluma 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## **Basis for Opinion**

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audits of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an Auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

#### **Supplemental Schedule Required by ERISA**

The supplemental schedule of Assets Held at End of Year as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

---

### 1. DESCRIPTION OF THE PLAN

The following description of the One Degree 403(b) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information. The Plan name was Alluma 403(b) Plan and was changed to One Degree 403(b) Plan effective November 1, 2023.

**General** — The Plan is a defined contribution plan covering eligible employees of One Degree, formerly The Center To Promote Healthcare Access, Inc. dba Alluma (the Company). All employees are eligible to participate in the Plan on their date of hire. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**Contributions** — Participants may elect to contribute through payroll deductions 100% of their annual compensation as defined by the Plan, on a pre-tax basis and/or on a Roth after-tax deferred basis, up to a maximum amount allowed by the Internal Revenue Code (IRC). Newly eligible employees are automatically enrolled to defer 5% of eligible compensation unless the participant makes a contrary election or opts out. There is no provision for annual deferral rate increases for automatically enrolled participants. Participants are also allowed to roll over contributions from other qualified employer-sponsored retirement plans. The Company may make discretionary matching contributions and discretionary nonelective contributions. During the years ended December 31, 2024 and 2023, the Company made discretionary matching contributions of \$64,461 and \$100,037, respectively.

**Participant Accounts** — Each participant's account will be credited with the participant's contributions, the Company's contributions and an allocation of the Plan's earnings and losses. The Plan's earnings or losses, excluding those related to participants' loans, are allocated to the participant's account based upon the proportion that each participant's account bears to the total participants' account balances. Earnings resulting from loans to participants are credited to the respective participants' accounts. Roth contributions and related activity are maintained in separate accounts. Participants direct the investment of their contributions into various investment options offered by the Plan.

**Notes Receivable From Participants** — Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 or (b) 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates. Principal and interest is paid ratably through regular payroll deductions.

**Payment of Benefits** — Distributions and withdrawals are payable upon reaching age 59½, termination, financial hardship, disability, or death. Upon termination of service, an employee's vested account balance of \$5,000 or less will be distributed in a lump-sum amount; and an employee with a vested account balance greater than \$5,000 may elect to receive a lump-sum

payment equal to their account balance, rollover the vested account balance to an account of their choice, or maintain the vested balance in the Plan and continue to share in investment gains and losses. The participant's account is distributed to the participant or, in the event of death, to the participant's beneficiary.

**Vesting** — Participants are 100% vested at all times in their entire account balances.

**Administrative Costs** — Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

**Plan Termination** — Although they have not expressed an intention to do so, the Company has the right to terminate the Plan at any time.

**Tax Status** — The Plan is a volume submitter plan of Standard Retirement Services, Inc. The IRS has determined and informed Standard Retirement Services, Inc. by a letter dated March 31, 2017, that the volume submitter plan is designed in accordance with applicable sections of the IRC. Although the Plan has adopted amendments since adopting the volume submitter plan, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has concluded that as of December 31, 2024, the Plan has no material uncertain tax positions.

## 2. SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** — The accompanying financial statements have been prepared on the accrual basis of accounting.

**Valuation of Investments and Income Recognition** — Investments are reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. Non-registered pooled separate accounts managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC are valued daily based on the market value of the underlying assets in each separate account. The Plan's trustees determine the Plan's valuation policies using information provided by the asset custodians. See Note 3 for information on the fair value measurements.

Fully benefit-responsive investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan's investment in the Stable Asset A Fund and the General Account represent fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investment income from pooled separate accounts is included within the net appreciation or depreciation in fair value of investments consistent with the presentation provided by the custodians.

**Use of Estimates** — Preparation of financial statements in conformity with the accrual basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Contributions** — Contributions from participants are recorded in the year which the employee contributions are withheld from compensation.

**Benefit Payments** — Benefits are recorded when paid.

**Subsequent Events** — The Plan has evaluated subsequent events for recognition or disclosure through the date of the Independent Auditors' Report, which is the date the financial statements were available for issuance.

### 3. INVESTMENTS

**Stable Asset A Fund** — As discussed in Note 2, because the Stable Asset A Fund is fully benefit-responsive, contract value is the relevant measurement attribute for this investment contract. Contract value, as reported to the Plan by Standard Insurance Company (Standard), represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Crediting rates are established quarterly based on account yield forecasts and required margins and will not be less than 1%.

Certain events may limit the ability of the Plan to transact at contract value with Standard. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules.

The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. Standard may terminate the contract with thirty days advance notice for reasonable cause, including the Plan's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000 and plan disqualification.

**General Account** — As discussed in Note 2, because the General Account is fully benefit-responsive, contract value is the relevant measurement attribute for this investment contract. Contract value, as reported to the Plan by Talcott Resolution Life Insurance Company (Talcott), acquired by Empower Retirement, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Crediting rates are established quarterly based on account yield forecasts and required margins and will not be less than 1%.

Certain events may limit the ability of the Plan to transact at contract value with Talcott. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. Talcott may terminate the contract with thirty days advance notice for reasonable cause, including the Plan's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, and plan disqualification.

**Fair Value Measurements** — Generally accepted accounting principles require the Plan to use a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1: Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2: Prices determined using significant other observable inputs. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Prices determined using significant unobservable inputs.

The investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the quoted prices of shares held by the Plan at year-end. The shares are actively traded.

*Pooled Separate Accounts:* Valued at the net asset value of shares held by the Plan at year-end. The net asset value is used as a practical expedient for fair value. The practical expedient would not be used if it is determined to be probable that the investment will be sold for an amount different from the reported net asset value. There are no significant redemption restrictions on the accounts.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments for which fair value is measured using the net asset value per share practical expedient are not categorized within the fair value hierarchy.

The pooled separate accounts are comprised of various funds including Large Cap, Mid Cap and Small Cap Growth and Value funds, Income Funds, Balanced Funds, International Funds, Real Estate Funds and Target Retirement Date Funds. The strategies of the accounts seek to build a portfolio with a diverse collection of stocks, bonds and other investments.

#### 4. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### 5. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS

The following is a summary of the information obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a custodian of the Plan, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, a custodian of the Plan, and the Standard Insurance Company, the custodian of an asset.

- Investments
  - Investment income
    - Net appreciation in fair value of investments
    - Interest and dividends on investments
- Supplemental schedule of assets held at end of year

## **6. PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee Company whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan invests in pooled separate accounts and a General Account of Talcott Resolution Life Insurance Company, which is an affiliate of Empower Trust Company, LLC, a Plan custodian. The Plan also invests in a Stable Asset A Fund of the Standard Insurance Company, a Plan custodian. Therefore, these transactions qualify as party-in-interest transactions.
