Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Family Health Centers 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution, or insurance carrier, that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution, or insurance carrier, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed, as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements, in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control, relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Years Ended December 31, 2024 and 2023**

1. Description of Plan:

The following description of Family Health Centers (the Organization) 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan originally effective October 1, 2002. The Plan has been amended throughout the years to comply with tax legislation and was most recently amended and restated effective July 1, 2022. The Plan is subject to the provisions of ERISA.

Eligibility – Employees are eligible to participate in the salary reduction and employer matching arrangement in the Plan after attaining age 18 and completion of 90 days of service. Participants enter the Plan on the first day of the month coinciding with or next following the date the eligibility requirements are met. For discretionary nonelective employer contributions, participants are eligible to participate after completing one year of service and attaining age 18. Participants are eligible for discretionary nonelective employer contributions on the first day of the plan year or the first day of the seventh month of the plan year coinciding with or next following the date the eligibility requirements are met. In order to receive discretionary nonelective employer contributions, a participant must be employed on the last day of the contribution period and have at least 1,000 hours of service during the contribution period.

Contributions – The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage or a flat amount, limited by plan provisions, of their compensation contributed as pre-tax 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth contributions.

The Organization may, at its discretion, elect to make a qualified matching contribution or discretionary nonelective contribution to the Plan. For the years ended December 31, 2024 and 2023, the Organization contributed, every payroll period, a matching contribution equal to 100 percent of employee deferral contributions, up to 1 percent of compensation.

Participants may also contribute amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or conduit Individual Retirement Accounts. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Vesting – Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the Organization's matching and profit-sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service as set forth in the following table. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

1. Description of Plan (continued):

Benefit payments – Upon termination of service, retirement, death, or disability, a participant may elect to receive an amount equal to the value of the participant’s vested interest in his or her account in a lump-sum distribution. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to plan provisions. If a participant terminates employment and the participant’s account balance does not exceed \$1,000, the plan administrator will authorize the benefit payment without the participant’s consent. If the balance of the terminated participant’s account is between \$1,000 and \$5,000, the plan sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant’s name.

Administration of the Plan – The Plan is administered by the Organization in the form of an advisory committee. Plan assets are invested in accordance with the employee’s instructions. Records of participant account activity are processed and maintained by John Hancock Life Insurance Company (U.S.A.) (John Hancock), which also performs other administrative support services for the Plan. Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan.

Forfeited accounts – Plan forfeitures arise as a result of participants who terminate service with the Organization before becoming 100 percent vested in the Organization’s contributions. These forfeitures may be used to pay administrative expenses or Organization contributions. For the years ended December 31, 2024 and 2023, there were \$2,719 and \$3,881 forfeitures used to pay administrative expenses or reduce the Organization contributions, respectively.

Plan termination – Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan, the participants would become 100 percent vested in their accounts.

2. Summary of Significant Accounting Policies:

Basis of accounting – The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in the pooled separate accounts are valued using the net asset value of units, which is based on observable market prices for the underlying assets held by the Plan at year end.

Purchases and sales of shares are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held, during the year.

Payment of benefits – Benefits are recorded when paid.

2. Summary of Significant Accounting Policies (continued):

Administrative expenses – As provided in the plan document, administrative expenses may be paid either by the Plan or by the Organization. The Organization has historically paid the administrative expenses for the Plan.

Subsequent events – In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 15, 2025, the date the financial statements were available to be issued.

3. Information Certified by the Plan Custodian:

John Hancock, the custodian of the Plan, has supplied the plan administrator with a certification as to the completeness and accuracy of all investment information. This is reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

4. Fair Value Measurements:

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at December 31, 2024 or 2023.

4. Fair Value Measurements (continued):

Following is a description of the valuation methodologies used for assets measured at fair value:

- **Pooled separate accounts:** The fair value of the units held in pooled separate accounts is based on observable market prices of the underlying investments in the account and is based on the net asset value of the shares held by the Plan at year end.
- **Guaranteed interest accounts:** Investments in guaranteed interest accounts are valued at fair value by the insurance company. This is done by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, plan management evaluates a variety of factors, including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in fair value levels – The availability of observable market data is monitored to assess the appropriate classifications of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2, or 3.

5. Group Annuity Contract with Insurance Company:

In 2002, the Plan entered into a group annuity contract with John Hancock. The guaranteed interest accounts are not investment contracts, but investment options, offered under the John Hancock group annuity contract. John Hancock maintains the contributions in a general account. Guaranteed accounts guarantee the return of principal plus compound interest earned over a defined three, five, or ten-year term, and charge for participant withdrawals and administrative expenses. The guaranteed accounts are not considered fully benefit-responsive.

There is no contract rate and no minimum rate. Interest rates are established on the first day of each calendar month and apply to all regular ongoing contributions made to the guaranteed account in that month for all contract holders. This is called the “new money” regular rate. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the guaranteed accounts approximates fair value at December 31, 2024 and 2023.

6. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term, and that such changes could materially affect participants’ account balances, the amounts reported in the statements of net assets available for benefits, and the statement of changes in net assets available for benefits.

The Plan has a concentration of investments in John Hancock Lifestyle Conservative, John Hancock Lifestyle Balanced, and John Hancock Lifestyle Growth. A change in the value of these funds could cause the value of the Plan’s net assets available for benefits to change due to this concentration. In addition, as a result of funds being selected by participants, certain other funds may individually represent a concentration of greater than 10 percent of the Plan’s investments at fair value in the statements of net assets available for benefits. Although these individual funds maintain a level of diversification by investing in multiple equity, debt, or other instruments, there may be a concentration of risk because the funds are invested at the direction of a single fund manager. At December 31, 2024 and 2023, John Hancock Lifestyle Conservative, John Hancock Lifestyle Balanced, and John Hancock Lifestyle Growth each individually represented greater than 10 percent of the Plan’s investments at fair value.

7. Plan Tax Status:

The Organization adopted a nonstandard prototype document with an IRS notification letter dated June 30, 2020, which states the prototype plan document is qualified pursuant to the appropriate sections of the IRC. The Plan has obtained a favorable determination letter from the IRS, but has since been amended. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, they believe that the Plan is qualified and the related trust is tax-exempt as of the financial statement dates. Accordingly, no provisions for income taxes have been included in the Plan’s financial statements.

7. Plan Tax Status (continued):

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are no audits for any tax periods in progress.

8. Party-in-interest Transactions:

Certain plan investments are units of pooled separate accounts and guaranteed interest accounts managed by John Hancock, the Plan's insurance company. The guaranteed interest accounts are not maintained separately from the general assets of John Hancock. Therefore, these transactions qualify as party-in-interest transactions. Certain other fees for investment services paid by the Plan are included in the net appreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment. The plan sponsor pays directly any other fees related to the Plan's operations.

Other party-in-interest transactions follow:

- The plan sponsor provides to the Plan certain accounting and administrative services for which no fees are charged to the Plan. The employees that provide these services also are participants in the Plan.
- The Plan relies on a third-party service provider, Benefits² Administrators LLC, to process the Plan's investment transactions, manage the individual participant accounts of the Plan, and to prepare the IRS Form 5500.
- The plan auditor performs the required annual audit of the Plan.
