#### 1. PLAN DESCRIPTION

The following description of the Astrup Companies 401(k) Plan (Plan) provides only general information regarding the Plan. Participants should refer to the Plan documents for a more complete description of Plan provisions.

##### **General**

The Plan is a multi-employer defined contribution profit sharing plan sponsored by Astrup Drug, Inc. (Astrup). Participating employers of the Plan include:

Smart-Fill Management Group, Inc.  
Astrup Drug, Inc.  
Sterling Rx, Inc.  
Stone Arch LTC, Inc.  
PMP Pharmacy Group, Inc.  
Astrup Companies, LLC  
SanCapRoad, LLC

The Plan covers substantially all employees age 21 or older. Employees with at least one hour of service are eligible to participate in the 401(k) portion of the Plan. To participate in matching and employer discretionary contributions, employees must be eligible to participate in the 401(k) plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### **Contributions**

The Plan allows participant contributions up to 50% of pretax annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. All participating employers match elective deferrals up to 100% of the first 3% and 50% of the next 2% of eligible compensation. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers 40 participant investment options. Additional employer discretionary contributions are determined annually by the participating employers' Boards of Directors. No employer discretionary contributions were elected for 2024 or 2023. Contributions are subject to certain limitations.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution, employers' matching contribution, allocation of the employers' discretionary contribution, allocation of Plan expenses, and net earnings from the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. Each participant is entitled to the benefit that could be provided from his or her vested account balance.

#### 1. PLAN DESCRIPTION (Continued)

##### **Participant Accounts (Continued)**

The Plan has allowed for the provisions of the CARES Act in regards to distributions, loans and required minimum distributions. The Plan will be amended for these changes by December 31, 2025.

##### **Vesting**

Participants are immediately vested in their contributions and employer matching contributions plus actual earnings thereon. Vesting in employer discretionary contributions, forfeitures, and earnings thereon is based on years of credited service. Participants are 100% vested after six years of credited service.

##### **Payment of Benefits**

Upon termination of service, a participant with a non-forfeitable accrued benefit exceeding \$5,000 can elect to receive either a lump-sum amount equal to the participant's vested account balance or installments over a period of time not to exceed the participant's assumed life expectancy (or the participant's and their beneficiary's assumed life expectancies). If no election is made, the plan administrator may elect to distribute the balance in a lump sum to the participant. Prior to separation from service, a participant reaching age 59½ can elect to receive all or a portion of their vested account balance or defer payment until retirement.

Upon termination of service, participants with non-forfeitable accrued benefits between \$1,000 and \$5,000 can elect to receive a distribution in a lump sum or roll over the vested balance into another retirement plan. If no election is made, distributions will automatically roll over into a newly established individual retirement account.

Upon termination of service with non-forfeitable accrued benefits below \$1,000, participants receive a lump-sum distribution.

##### **Forfeited Accounts**

Forfeited non-vested amounts are used either to reduce employer contributions or reduce the fees paid to Empower Trust Company, LLC in the year following the Plan year the forfeiture occurs. Total forfeitures used to reduce administrative expenses were \$-0- for the years ended December 31, 2024 and 2023. Forfeitures available to reduce future employer contributions or administrative expenses totaled \$-0- as of December 31, 2024.

##### **Notes Receivable from Participants**

Under terms of the Plan, participants may borrow up to the lesser of \$50,000 or 50% of their account balance. Loans are secured by the participant's account balance, subject to regulations, and are due in a time period not to exceed 15 years, with interest at rates comparable to local prevailing rates. Principal and interest is paid ratably through bi-weekly payroll deductions.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

##### **Estimates**

Preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

The Plan's investments, except for the guaranteed investment contract, are stated at fair value using quoted market prices, if available. The Plan's guaranteed investment contract is valued at contract value. See Note 3 for further discussion of investment valuation inputs.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date.

Gains and losses (realized and unrealized) are included in statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments. Net appreciation (depreciation) includes the Plan's gains (losses) on investments purchased, sold, and held during the year.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and redemptions are charged directly to the participant's account and are included in investment and administrative expenses.

##### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes in net assets available for benefits.

As of December 31, 2024 and 2023, the Plan had investments totaling \$7,938,221 and \$6,347,537, that were concentrated in one fund, respectively.

Notes receivable from participants are measured at their unpaid principal balance. Interest income from these notes is recorded when earned. Delinquent notes receivable from participants are reclassified as loans in default and are recorded as distributions at the time they are deemed uncollectible.

#### 4. FAIR VALUE MEASUREMENTS

Generally accepted accounting principles established a framework for measuring fair value based on a hierarchy that prioritizes valuation inputs as referenced below:

#### 5. GUARANTEED INVESTMENT CONTRACT

The Plan invests in a benefit-responsive guaranteed investment contract with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Plan management believes that the occurrence of an event that would cause the Plan to transact at less than contract value is not probable. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

#### 6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Empower. Empower Trust Company, LLC is the trustee as defined by the Plan. Fees paid by the Plan to Empower for all accounting and investment management services qualify as party-in-interest transactions and totaled \$55,479 and \$44,140 for the years ended December 31, 2024 and 2023, respectively.

#### **7. INCOME TAX STATUS**

The volume submitter plan adopted by Astrup Drug, Inc. obtained its latest determination letter on November 14, 2022, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the plan administrator and tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

#### **8. ADMINISTRATION OF PLAN ASSETS**

Certain administrative functions are performed by officers or employees of the participating employers. No such officer or employee receives compensation from the Plan.

#### **9. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

Net assets available for benefits and the changes in net assets available for benefits per the financial statements agree to Schedule H of Forms 5500 as of and for the years ended December 31, 2024 and 2023.

#### **10. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.
