To the Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **Foley Hoag LLP Savings & Retirement Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of **Foley Hoag LLP Savings & Retirement Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. NOTES TO FINANCIAL STATEMENTS

NOTE 1: DESCRIPTION OF THE PLAN

The following description of Foley Hoag LLP Savings & Retirement Plan (the "Plan"), provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan is a contributory defined-contribution plan established January 1, 1987, for the purpose of providing an opportunity for retirement income and increased savings to employees of Foley Hoag LLP (the "Firm") who meet minimum length of service requirements. Plan assets acquired under this Plan as a result of employee contributions, Firm discretionary profit-sharing contributions, investment income and other additions to the Plan, will be administered for the exclusive benefit of the participants and their beneficiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility: A participant is eligible to defer compensation after completing one month of service. Once eligible, participants will be automatically enrolled in the Plan and will defer five percent of their compensation.

Contributions: Participants may elect to contribute an amount up to a certain percentage of pretax annual eligible compensation, as defined in the Plan. Participants who have attained the age of fifty before the end of the Plan year are eligible to make catch-up contributions. The Plan allows some, or all, of these contributions to be designated as after-tax, Roth deferral contributions. Participants may also contribute amounts that represent distributions from other qualified plans. Firm contributions are optional and are determined by the Executive Committee of the Firm at the end of the Plan year. Participants may receive a Firm profit-sharing contribution as long as they are employed by the Firm on the last day of the Plan year unless their termination of employment is due to retirement on or after age sixty-two, disability, or death. Contributions are subject to certain limitations under the Internal Revenue Code ("IRC").

Participant Accounts: Each participant's account is credited with the participant's contributions, rollovers, and allocations of the Firm's discretionary profit-sharing contributions and Plan earnings (losses), revenue sharing and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1: DESCRIPTION OF THE PLAN (CONTINUED)

Vesting: Participants are immediately 100% vested in their voluntary contributions and participant rollover contributions, plus actual earnings thereon. Firm discretionary profit-sharing contributions and related earnings are subject to a vesting schedule based on the number of years of continuous service as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 years	0%
2 years but less than 3	20%
3 years but less than 4	40%
4 years but less than 5	60%
5 years or more	100%

Participants' interest in their accounts shall become 100% vested and nonforfeitable without regard to their credited years of service if they are employed by the Firm on or after age sixty-two, incur a permanent disability, or die while employed by the Firm.

If participants who are not fully vested terminate employment with the Firm, the participants shall be entitled to the vested portion of their account. The non-vested portion is forfeited and retained in the Plan to be used to reduce future Firm contributions.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of the participant's vested account balance. Participant loans must be approved by the Plan Administrator. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes Fund. Loan terms range from one to five years or up to 10 years for the purchase of a primary residence. Participants may have three (3) loans outstanding at any time and the loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1% at December 31, 2024. Interest rates on notes receivable from participants range from 4.25% to 9.50% at December 31, 2024. Principal and interest are usually paid ratably through payroll deductions.

Payment of Benefits: Participants are entitled to retirement benefits beginning at the normal retirement age of 62, death, or permanent disability. Participants receive the value of their vested benefits in the form of a lump-sum distribution prior to age 70½. In any event, payment of benefits must commence when the participant reaches age 70½ or, if later, following the year they terminate employment. However, 5% owners of the Firm will be required to begin receiving minimum distributions from their account by April 1st following attainment of age 70½ regardless of whether they have terminated employment at that time. The Plan Agreement contains a more complete description of these provisions and should be referred to by participants.

NOTE 1: DESCRIPTION OF THE PLAN (CONTINUED)

Forfeited Accounts: At December 31, 2024 and 2023, the forfeited non-vested account totaled \$327,506 and \$61,120, respectively. This account will be used to reduce the future Firm discretionary profit-sharing contributions. During the year ended December 31, 2024, the Plan Sponsor utilized \$61,118 of forfeitures to reduce its profit-sharing contributions or to pay Plan expenses.

Investment Options: Participants elect to invest their contributions into various options offered by the Plan. Participants may change their investment options as determined by the rules applicable to each investment.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate a permitted transaction under the terms of the Plan. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors, trustees, and other parties involved with the Plan. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of the Plan's investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

The New York Life Insurance Anchor Account is a pooled separate account made available to participating plans through a group annuity contract. The group annuity contract is an investment contract that is benefit-responsive, meaning it provides for a stated return on principal invested over a specified period and permits withdrawals at contract value for benefit payments, loans, or transfers to other investment options offered to the participant by the Plan.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Risks and Uncertainties: The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowances for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Revenue Sharing to Participants: The Principal Financial Group ("Principal") is the Recordkeeper for the Plan. Certain mutual funds pay fees to Principal for its recordkeeping services associated with these funds for the Plan. Such fees are referred to as revenue sharing between these mutual funds and Principal and are credited back to the accounts of participants who invest in these funds on a proportional basis each month. Revenue sharing is calculated by multiplying the average fund balance each month by a certain agreed upon rate. Total revenue sharing credits aggregated \$92,729 for the year ended December 31, 2024 and are included in the "Net appreciation in fair value of investments" in the accompanying Statement of Changes in Net Assets Available for Benefits.

Payment of Benefits: Benefit payments are recorded when paid. At December 31, 2024, there were no benefit claims which had been processed and approved for payment but not yet paid.

Expenses of the Plan: The Plan has a fee structuring arrangement with Principal to allow for fee equalization. Under this arrangement, asset-based fees paid to Principal are charged directly to participant accounts in the form of a "wrap fee" equal to 0.045% annually on the Plan assets. The wrap fee is a fee that is added to or "wrapped around" each Plan participant's Plan assets and is applied pro rata based on the amount of each participant's Plan assets. Professional services, such as investment consulting, audit, and legal fees are charged to all Plan participants and will fluctuate according to the services required by the Plan and are applied pro rata based on the amount of each participant's Plan assets. Investment related expenses are included in the net appreciation of fair value investments.

Termination of Plan: Although it has not expressed any intent to do so, the Firm reserves the right to terminate the Plan. The Plan Administrator, upon termination, shall cause the assets of the Plan to be allocated for the purposes set forth and in the order of priorities established by ERISA. In the event of termination, participants will become 100% vested in their accounts.

NOTE 4: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate account: The Plan holds interests in a Stable Value Fund, which consists of an investment in the Anchor Account, which is not traded in an active market, and is valued at the NAV of the fund. The NAV, as provided by the contract issuer, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net NAV.

Participants in the New York Life Insurance Anchor Account may ordinarily direct the withdrawal or transfer of all, or a portion of, their investment at contract value. Withdrawals and transfers resulting from certain events, including employer-initiated events may limit the ability of the fund to transact at contract value. These events may cause liquidation of all, or a portion of, a contract at market value. The Plan Administrator believes that the occurrence of any event which would limit the Plan's ability to transact at contract value is not probable.

NOTE 5: GUARANTEED INVESTMENT CONTRACT

The Plan has a fully benefit-responsive investment contract with Principal Life Insurance Company ("Principal"). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Since this contract meets the fully benefit-responsive contract criteria, the contract is included in the financial statements at contract value as reported to the Plan by Principal. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a stated annual interest rate and set scheduled so that the account values increase each day and over the guaranteed period the stated interest rate is applied.

NOTE 5: GUARANTEED INVESTMENT CONTRACT (CONTINUED)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6: RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan engages in investment transactions with funds managed by the Trustee, Principal, and the Plan pays certain related fees. Fees are also paid to the Plan's investment advisor and audit firm by the participants on behalf of the Plan. These are considered party-in-interest transactions and are covered by an exemption from the "prohibited transaction" provisions of ERISA and the IRC, as amended.

NOTE 7: TAX STATUS

The Internal Revenue Service has determined and informed the Firm by a letter dated December 5, 2016, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8: LATE REMITTANCES

As reported on Form 5500, Schedule H, Line 4(a) - Schedule of Delinquent Participant Contributions, certain participant contributions were not remitted to the Plan within the time frame specified by the DOL's regulations, thus constituting nonexempt transactions between the Plan and the Firm. The late remittances amounted to \$26,000 as of December 31, 2024. The Firm took the appropriate steps to correct these late remittances during 2024.
