To the Trustees  
Goodwin's Chevrolet Company 401(k) Profit Sharing Plan:

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Goodwin's Chevrolet Company 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Goodwin's Chevrolet Company 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Notes 3 and 8 to the financial statements, is complete and accurate.

**Opinion**

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Goodwin's Chevrolet Company 401(k) Profit Sharing Plan (the Plan), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Effective January 1, 2024, the Plan was amended to exclude certain forms of compensation from the Plan's definition of compensation.

General - The Plan is a defined contribution plan covering all full-time employees of Goodwin's Chevrolet Company and related participating employers (collectively, the Company) who are age 21 or older and have completed 30 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Trustees are responsible for oversight of the Plan.

Contributions - Each year, participants may contribute a portion of their compensation up to the maximum annual limit set by the Internal Revenue Service on a pre-tax and/or Roth basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company contributes a safe harbor contribution of 3% of gross plan compensation to all participants who have completed one year of service. Additional profit sharing amounts may be contributed at the discretion of the Company's Trustees and are subject to participant investment direction. The Company made a safe harbor contribution of \$382,041 and a profit-sharing contribution of \$124,328 for the year ended December 31, 2024. The profit sharing contribution, as well as certain safe harbor amounts, were paid subsequent to December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts - Each participant's account is credited with the participant's contribution, Company safe harbor contributions, and allocations of the Company's profit sharing contribution and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their voluntary contributions and safe harbor contributions, plus actual earnings thereon. The remainder of their accounts vest 10% in each of the first two years of service and 20% for each year of service thereafter. A participant is 100% vested after six years of credited service, as defined by the Plan, or upon normal retirement age.

Notes receivable from participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the participant's vested account balance and bear interest at the prime rate plus one percent. Principal and interest are paid ratably through payroll deductions.

1. DESCRIPTION OF PLAN, CONTINUED

Payment of benefits - On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account or rollover their balance to an IRA or other defined benefit or defined contribution plan. If a participant's vested account balance is \$5,000 or less (but more than \$1,000), the entire amount will automatically be rolled over directly to an Individual Retirement Plan (IRA) established in the participant's name by the plan administrator. If the vested account balance is \$1,000 or less, the entire amount will be distributed to participants in a lump-sum payment of cash, subject to applicable withholding taxes. Participants with a vested benefit greater than \$5,000 may elect to defer payment of their benefits until a later date. Provided certain conditions are met, the participants may also be entitled to a distribution upon attaining age 59½.

The Plan also allows withdrawals from the plan due to circumstances of financial hardship, in accordance with provisions specified in the Plan document.

Forfeited accounts - Forfeited nonvested accounts may be used to reduce future employer contributions or to pay plan expenses. Forfeited nonvested accounts totaled \$614 and \$153 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, forfeited nonvested accounts were used to reduce plan expenses by \$781.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting - The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates - The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurements date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold, and held during the year.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan document.

Benefit payments - Benefit payments are recorded when paid.

Administrative expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in net appreciation of fair value of investments.

Uncertain tax positions - U.S. GAAP prescribes a comprehensive model for how an organization should measure, recognize, present, and disclose in its financial statements uncertain tax positions the Plan has taken or expects to take on a tax return. The Plan recognizes the tax benefits from uncertain tax positions if it is more likely than not that the tax position will be sustained on examination by the taxing authorities, based on the technical merits of the position.

Subsequent events - The Plan has evaluated events, if any, that have occurred subsequent to December 31, 2024 through September 16, 2025, the date the financial statements were available to be issued, and included information in the notes to the financial statements related to any identifiable events, if necessary.

## 3. FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for investments. Investments are valued using net asset value (NAV) as a practical expedient to estimate fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Pooled separate accounts are valued using NAV as a practical expedient to estimate fair value as determined by the custodian. NAV is based on the value of the underlying investments less operating expenses accrued but not deducted, if any.

*Common Collective Trusts:* Units of the fund are valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments and contracts held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

3. FAIR VALUE MEASUREMENTS, CONTINUED

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are held by John Hancock Life Insurance Company (U.S.A.) (John Hancock). John Hancock is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan also pays various service providers for fees associated with investment and administrative services provided to the Plan, which also qualify as party-in-interest transactions. In addition, loans to participants qualify as party-in-interest transactions.

5. PLAN TERMINATION

Although it has not expressed an intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their nonvested employer contribution accounts.

6. INCOME TAX STATUS

The Plan utilizes an Epic Advisors, Inc. non-standardized pre-approved profit sharing plan for which the IRS issued an opinion letter dated June 30, 2020, stating the form of the Plan was acceptable under the applicable requirements of the Internal Revenue Code (IRC). The Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by John Hancock, the custodian of the Plan.
