### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We were engaged to perform audits of the financial statements of Banner Health Employees 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Banner Health Employees 403(b) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### ***Disclaimer of Opinion***

We do not express an opinion on the accompanying financial statements of Banner Health Employees 403(b) Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

#### ***Basis for Disclaimer of Opinion***

Banner Health Employees 403(b) Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with auditing standards generally accepted in the United States of America (GAAP), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt Banner Health Employees 403(b) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Our responsibility is to conduct an audit of Banner Health Employees 403(b) Plan's financial statements in accordance with GAAP and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of Banner Health Employees 403(b) Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

### ***Other Matter***

#### *Supplemental Schedule Required by ERISA*

The supplemental schedule of Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to, and we do not express an opinion on the supplemental schedule.

### Note 1 – Description of Plan

**General** – Banner Health Employees 403(b) Plan (the Plan) is a defined contribution plan providing retirement benefits to eligible employees of Banner Health and its subsidiaries (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The following is not a comprehensive description of the Plan and, therefore, does not include all situations and limitations covered by the Plan. Participants should refer to the Summary Plan Description (SPD) for more complete information regarding the Plan's definitions, benefits, eligibility, and other matters, a copy of which is available from the Company.

The Company is the sponsor and administrator of the Plan. The Company's Retirement Plans Advisory Committee is responsible for the general administration of the Plan. Custodian functions are performed by Fidelity Management Trust Company (Fidelity). Recordkeeping services are provided by Fidelity Workplace Services, LLC. Costs of administering the Plan are paid by the Company and Plan participants. The Plan was restated effective January 1, 2020, to incorporate all the amendments since the last restatement in 2009.

**Eligibility** – All registry employees of the Company are eligible to participate in the Plan immediately upon hire, provided that they are not eligible to contribute to any other 401(k) plan or 403(b) plan that is sponsored by the Company.

**Contributions** – Each year, participants may contribute up to 100% of their eligible pre-tax compensation, as defined in the Plan. Participants may also elect to make Roth contributions on an after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

**Vesting** – Generally, participants are always 100% vested in their account balance under the Plan. Former participants of the University of Arizona Health Network Savings Plan (the UAHN Plan) with matching contributions attributable to the UAHN Plan vest in matching contributions based on credited service, 25% vested after their second year of service, and an additional 25% each year until fully vested after five years of service.

**Forfeitures** – Generally, the Plan does not have significant forfeitures as participants are always 100% vested in their account balance under the Plan and the Company does not make matching contributions under the Plan. However, former participants of the UAHN Plan with matching contributions attributable to the UAHN Plan vest in matching contributions according to the schedule above. Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,139,314 and \$1,175,470, respectively. During the Plan year ended December 31, 2024, forfeitures of approximately \$136,932 were used to pay Plan expenses.

## **Banner Health Employees 403(b) Plan Notes to Financial Statements**

**Participant accounts** – The Plan maintains individual accounts for each participant. Participants direct the investment of all contributions and earnings into one or more investment options offered by the Plan. Each account is credited with participant contributions and allocation of Plan earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's pro rata share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are variable based on the timing and amounts of paid invoices and deducted from participants' account balances throughout the year. Allocations of recordkeeping fees are based on a fixed amount per participant per year which is deducted from participants' account balances on a quarterly basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes receivable from participants** – Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of one-half of the participant's vested account balance or \$50,000 reduced by the highest outstanding loan balance in the participant's account during the prior 12-month period. All loans must be repaid within five years, unless a participant's loan was used to purchase a primary residence, in which case the loan must be repaid within a reasonable period of time not to exceed 15 years. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the Plan administrator based on prevailing commercial interest rates. The interest rate will remain fixed during the duration of the loan. Principal and interest are paid by the participant directly to Fidelity over the term of the loan. Participants are limited to having one outstanding loan at any given time, unless the participant had two loans outstanding as of January 1, 2020. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25% to 9.50% with various maturities through September 2037.

**Payment of benefits** – Vested benefits are distributed to participants or their beneficiaries upon death, disability, retirement, or termination of employment through one lump-sum payment, installment payments, or the purchase of an individual or qualified joint and survivor annuity contract.

**Voluntary withdrawals** – A participant, while employed by the Company, may withdraw employee contributions and earnings thereon upon either a hardship as defined by the Plan or attaining age 59½ years of age. A participant, while employed by the Company, may also withdraw rollover or non-Roth after-tax contributions and earnings at any time.

**Plan termination** – Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of the Plan's termination, all active participant accounts will become fully vested and the assets of the Plan would be distributed in accordance with the provisions of the Plan agreement.

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

**Benefit payments** – Benefits are recorded when paid.

**Investment valuation** – Investments held by the Plan are stated at fair value. The Plan’s trustee, Fidelity, certifies the fair market value of all investments. If available, quoted market prices are used to value investments. Fair value is defined as the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date (an exit price). See Note 3 for further discussion and disclosures related to fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividend income is recorded on the declaration date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants** – Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

**Expenses** – Several of the investment fund options are subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund’s prospectus. All such fees are charged directly against the fund’s investment performance; thus, they are not separately disclosed in the accompanying financial statements. Participants are assessed separate fees for the administration of loans and repayments thereof, as well as investment advisory services, and such fees are separately disclosed in the financial statements. All other administrative expenses related to the Plan are paid by the Company and Plan participants.

**Use of estimates** – The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

**Risks and uncertainties** – The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent events** – There are two types of subsequent events relating to the accounting and disclosure of events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are issued: recognized subsequent events, which provide additional evidence about conditions that existed at the statement of net assets available for benefits date, and non-recognized subsequent events, which provide evidence about conditions that did not exist at the statement of net assets available for benefits date but arose before the financial statements were issued. Recognized subsequent events are required to be recognized in the financial statements, and non-recognized subsequent events are required to be disclosed. Plan management has evaluated subsequent events for the Plan through September 22, 2025, the date the financial statements were available to be issued.

### **Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds and money market funds)* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Self-directed brokerage accounts* – Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 4 – Certified Investment Information**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends and interest, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

### **Note 5 – Income Tax Status**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the Code) and therefore, it is not currently eligible to receive a determination letter from the Internal Revenue Service (IRS). The Plan is required to operate in conformity with the Code to maintain its qualification under Section 403(b). The Plan administrator believes that the Plan is operating in accordance with the applicable requirements of Section 403(b) of the Code and, therefore, believes the Plan is qualified and the related custodial accounts are tax-exempt.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 6 – Party-in-Interest Transactions**

Certain Plan investments are managed by Strategic Advisers, Inc., a registered investment advisor and an affiliate of Fidelity. During 2024, the Plan paid fees to Fidelity Investments Institutional Operations Company, Inc. and Strategic Advisers, Inc., affiliates of Fidelity (the trustee of the Plan) and, therefore, transactions with these entities qualify as exempt party-in-interest transactions. Additionally, the Plan paid the Company fees for reimbursements of eligible expenses related to the Plan.

Fidelity receives revenue from mutual fund service providers for services they provide to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan. If the revenue received from such mutual fund service providers exceeds the amount due to Fidelity, they remit the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants.

### **Note 7 – Reconciliation to the Form 5500**

The Form 5500 has certain items that differ from amounts shown in the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.
