To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Coastal Meats, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits-modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits-modified cash basis for the years then ended, and the related notes to the financial statements.

Opinion

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following brief description of the Coastal Meats, LLC 401(k) Profit Sharing Plan is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution multiple employer plan covering all employees, excluding leased employees, of the sponsor, Coastal Meats, LLC, who have completed one year of service following the employee's employment commencement date and attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan sponsor is a member of a controlled group and is therefore considered an affiliated employer. Other members affiliated with the plan sponsor and that have elected to adopt Coastal Meats, LLC 401(k) Profit Sharing Plan are Crider-Claxton, LLC, Coastal Processing, LLC, and Statesboro Logistics Solutions, LLC.

Contributions

Each year, participants may contribute up to 100% of the participant's pretax annual compensation, as defined by the Plan, subject to an annual dollar limitation which is set by law. The sponsoring employer will make safe harbor matching contributions equal to 100% of an eligible participant's elective deferrals which do not exceed 3% of compensation, plus 50% of an eligible participant's elective deferrals which exceed 3% but do not exceed 5% of the eligible participant's compensation. In addition, the sponsoring employer may make additional discretionary non-elective contributions or an additional discretionary profit sharing contribution. Any additional discretionary contributions are determined by the Company each year.

Participant Accounts

Each participant's account is credited with the participant's contribution, the employer's safe harbor matching contribution, any additional discretionary contributions made by the employer, and allocations of Plan earnings. Allocations are based on participant earnings, as defined. Each participant's account may also be charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always 100% vested in their salary reduction contributions and the employer safe harbor matching amounts contributed to the Plan. Vesting in employer discretionary contributions are based on years of service. Presently, partial vesting occurs after two years of service and 100% vesting occurs after six years of service.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest Income is recorded when received. Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum of one-half of the vested account balance or \$50,000 reduced by the highest outstanding loan balance in the account during the prior 12-month period. The term for the loan will not exceed 5 years. The loans are secured by the balance in the participant's account and bear interest at a rate established by the Plan Administrator in a nondiscriminatory manner. Principal and interest are paid ratably through payroll deductions. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payments of Benefits

Payment of a participant's account balance is generally only available upon death, disability or retirement. If employment terminates for other reasons, then only the vested portion is available for benefit and it becomes payable as a lump-sum distribution. Any unvested portion is forfeited. However, only employer contributions are subject to vesting and forfeiture. The Plan does provide for hardship distributions. The Plan also provides for in-service distributions once the participant has reached age 59 ½.

1. DESCRIPTION OF THE PLAN (continued)

Forfeitures

Forfeitures arise when participants terminated employment before becoming entitled to receive their full Plan benefits. Forfeiture of amounts attributable to Employer contributions will be used to reduce any Employer contribution.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of significant accounting policies followed by the Plan in preparing the financial statements:

General

John Hancock Retirement Plan Services, as trustee, and William A. Crider, III, as administrator, have responsibility for administration of the Plan's Trust Fund and management of the assets of the Trust Fund.

Basis of Accounting

The accompanying financial statements have been prepared on the modified cash receipts and disbursements basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. That basis differs from generally accepted accounting principles in that certain revenues are recognized when received rather than when earned, and certain expenses and purchases of assets are recognized when cash is disbursed rather than when the obligation is incurred.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Contributions

Participant and employer safe harbor matching contributions are recorded as soon as amounts are determined. Discretionary employer contributions are recorded when they are approved by the Board of Directors.

Payment of Benefits

Benefit distributions are recorded when incurred by the Plan.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0. Forfeitures are used to reduce future employer contributions. In 2024 and 2023, there were no reductions in employer contributions from forfeited non-vested accounts.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gain and losses on investments bought and sold as well as held during the year.

Administrative Expenses

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company.

Reclassification

Certain accounts in the prior-year financial statements may have been reclassified for comparative purposes to conform with the presentation in the current-year financial statements.

3. INVESTMENTS

The Custodian holds the Plan's investments and executes all investment transactions. The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility and credit risks. The Plan attempts to limit these risks by authorizing and offering participants a broad range of investment options that are invested in high quality securities or are offered and administered by reputable and known investment and insurance companies. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. The Plan's exposure to a concentration of risk is limited by the diversification of investments across multiple investment fund options. Additionally, the investments within each investment fund option are further diversified into varied financial instruments.

4. INFORMATION CERTIFIED BY CUSTODIAN

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by John Hancock, the custodian of the Plan, as complete and accurate, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedules:

5. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	<p>Inputs to the valuation methodology include:</p> <ul style="list-style-type: none"> • Quoted prices for similar assets or liabilities in active markets; • Quoted prices for identical or similar assets or liabilities in inactive markets; • Inputs other than quoted prices that are observable for the asset or liability; • Inputs that are derived principally from or corroborated by observable market data by correlation or other means. <p>If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.</p>
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds and equity securities - Valued at the closing price reported on the active market on which the individual securities are traded.

Pooled separate accounts with underlying mutual fund investments – Valued based on the observable net asset value (“NAV”) of the underlying investment. There are no restrictions on the redemption of these investments. There are no unfunded commitments. Redemption may be daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. RELATED-PARTY TRANSACTIONS

Certain Plan investments are managed by John Hancock. John Hancock is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

7. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Plan by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

9. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

10. SUBSEQUENT EVENTS

The plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.
