***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11 and \$0, respectively. The Plan agreement provides for forfeitures to be used to reduce employer contributions. During the 2024 plan year, \$2,126 of forfeitures were used to reduce employer contributions.

***Investment Options***

A participant may direct the investment of their contributions to various investment options offered by the Plan.

***Notes Receivable from Participants***

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate as determined by the plan administrator at the time of application. Principal and interest is paid ratably through payroll deductions. As of December 31, 2024 and 2023, the interest rates on notes receivable from participants ranged from 5.25% to 10.5%.

***Plan Administration***

The Plan is administered by the Company. The Plan assets are maintained by its trustee, Principal Financial Group ("Principal").

***Payment of Benefits***

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, in partial withdrawals or installments over a period not to exceed the participant's estimated life expectancy. If the participant's vested balance is less than \$5,000 at the date of termination of service, and the participant has failed to make a distribution election, the participant's vested interest in his or her account will be distributed as a lump-sum as soon as practicable after termination of service.

***Plan Termination***

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their allocation of employer contributions.
