NOTE 1 - PLAN DESCRIPTION

Effective January 1, 2023, the Plan Sponsor was changed from Atlantic Automotive Corp. to its parent company, MileOne Autogroup, Inc., and the Plan was renamed to the MileOne Autogroup, Inc. 401(K) Plan ("the Plan"). The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established effective September 1, 1988. To be eligible for participation in the Plan, employees must have at least one year of service with MileOne Autogroup, Inc. or a participating employer (the Company) and be age 21 or older. Employees may enter the Plan as soon as administratively feasible following satisfaction of the eligibility requirements. The eligibility requirements are the same for participant and company matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute a percentage of eligible compensation, as defined in the Plan. Participants who elect to contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Contributions withheld are invested in accordance with the participant's election and may be redirected online at any time. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company, upon approval of the Board of Directors, may make a discretionary matching contribution on an annual basis to all eligible employees. During 2024, the Company matched 25% of each eligible employee's contributions up to 4% of annual compensation, not to exceed \$3,450. Company discretionary matching contributions for the year ended December 31, 2024 totaled \$1,528,406, which included \$44,896 of reallocated forfeitures. The Company may, at its discretion, make additional profit sharing contributions to the Plan on an annual basis. There were no profit sharing contributions for the current Plan year. Contributions are subject to certain limitations.

Employees are automatically enrolled at a 3% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. For those employees automatically enrolled, the 3% deferral rate is automatically increased by 1% annually on their entry date anniversary, up to a maximum deferral rate of 8%.

Vesting: Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Vesting in the remainder of their accounts, plus earnings thereon, is based on years of continuous service. A participant or their beneficiary is 100% vested after three years of credited service or upon death or disability. Participants become 100% vested under the Plan (assuming the participant is not already fully vested) if employed on or after the age of 55.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) Company contributions and (b) Plan earnings, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

NOTE 1 - PLAN DESCRIPTION (Continued)

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$500 up to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the participant's vested balance and no more than two outstanding notes are permitted at any time. The notes are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. All notes are covered by demand notes and are repayable through payroll deductions.

Payment of Benefits: Upon retirement, termination of employment, death, disability, or the attainment of age 59 ½, the participant or beneficiary is entitled to receive the vested balance in the participant's account in the form of a lump-sum distribution unless the participant elects another option as provided by the Plan. In addition, participants may also request a distribution from their participant deferral contributions account in the event of a financial hardship as defined by the Plan. Distributions are subject to the applicable provisions of the Plan agreement. Certain income taxes and penalties may apply to withdrawals or distributions prior to age 59 ½.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Forfeited Accounts: Terminating employees of the Plan are paid the current value of the vested balance in their Plan accounts as soon as administratively feasible. Unvested amounts are forfeited and are used to pay Plan expenses or reduce Company contributions.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping, trustee, and investment advisory fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are charged directly to the borrowing participant's account and are included as administrative expenses when incurred.

Payments of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan provides for investment options in various mutual funds. The underlying investment securities are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, the trustee of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following description of the valuation method and assumption used by the Plan to estimate the fair value of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - TAX STATUS

The Internal Revenue Service has issued an opinion letter dated November 14, 2022 indicating that the non-standardized pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The plan has been amended since receiving the latest opinion letter. The plan administrator believes that the Plan is currently designed and being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Empower Trust Company, LLC is the Plan's trustee, Merrill Lynch Pierce Fenner and Smith (Merrill Lynch) is the investment advisor, and Empower Retirement, LLC is the recordkeeper; therefore, the Plan's payment of trustee fees, investment advisory and management, and administrative fees to Empower Trust Company, LLC, Merrill Lynch, and Empower Retirement, LLC qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 8 - DEPARTMENT OF LABOR INVESTIGATION

The Department of Labor selected the Plan for an investigation pursuant to ERISA Section 504. The investigation commenced in June 2020. By letter dated September 4, 2024, the Department of Labor notified the Plan Retirement Committee that it was closing its investigation without further action.
