### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **United Community Action Program 401(k) Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of **United Community Action Program 401(k) Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## Notes to Financial Statements December 31, 2024 and 2023

### **NOTE 1: DESCRIPTION OF THE PLAN**

The following description of the United Community Action Program 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan for the benefit of employees of United Community Action Program, Inc. (the Employer). The Plan is subject to the Department of Labor's reporting requirements under the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Eligibility**

Employees of the Employer who are not a nonresident alien, reclassified employee, union employee, or resident of Puerto Rico are eligible to participate in the Plan at the next entry date upon attaining age 21 and one year of service. Prior to April 19, 2023, entry dates were January 1, April 1, July 1, and October 1 each year. Effective April 19, 2023, entry dates are the first day of the following month coinciding with or next following the date the requirements are met.

#### **Contributions**

Each year, participants may contribute a portion of their pretax annual compensation, subject to certain limitations as defined by the Plan. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Employer makes safe harbor matching contributions. For the year ended December 31, 2024 and 2023, the Employer made matching contributions calculated at 100% of a participant's contributions up to 4% of the participant's compensation. In addition to the safe harbor match, the Employer, in its discretion, may also match participant contributions 100%, not to exceed 6% of the participant's compensation. Catch-up contributions are matched by the Employer.

#### **Investment Options**

Upon enrollment in the Plan, participants may direct their contributions among the various investment options offered by the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's salary deferral contributions, his or her share of the Employer's contributions, and Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant contributions, compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their salary deferral contributions, plus actual earnings thereon. Prior to April 19, 2023, the Employer's contributions vest at 0% the first two years and are fully vested after three years of service. Effective April 19, 2023, the Employer's contributions are immediately 100% vested. Participants are fully vested upon reaching 65 years of age, upon death, and upon disability.

### **Payment of Benefits**

Upon retirement, disability, death, or separation of service, a participant is entitled to receive a lump-sum amount or installment payments equal to the vested value of his or her account. Accounts under certain dollar amounts at the time of the participant's termination may automatically be distributed to the participant. The Plan also allows for in-service withdrawals to participants meeting certain age or hardship requirements.

### **Forfeitures**

Forfeitures can be used to pay reasonable Plan expenses or reduce Employer contributions. During the year ended December 31, 2024, no forfeitures were used. There were no unallocated forfeitures as of December 31, 2024 and 2023.

## ***NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES***

### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Payment of Benefits**

Benefits are recorded when paid. There were no amounts allocated to withdrawing participants' accounts for distributions payable prior to December 31, 2024 and 2023, but not yet paid as of those dates.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Certain activity based fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### Expense Offset Arrangements

Fees incurred by the Plan for the investment management services or recordkeeping are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

### **NOTE 3: INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN AND TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Trust Company LLC (John Hancock), the trustee, as of December 31, 2024 and 2023, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023,
- Interest and dividends and net appreciation in fair value of investments as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and
- The Schedule of Assets Held at End of Year as of December 31, 2024.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### **NOTE 4: FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Codification Topic *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB Codification Topic *Fair Value Measurements and Disclosures* are described as:

---

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

---

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

---

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

---

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at closing price reported on the active market on which the security is traded.

*Collective Investment Trusts:* Valued at the NAV of the units of the collective investment trusts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account (a common collective trust fund as well as separate accounts and mutual funds) less liabilities. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **NOTE 5: RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS**

The Plan investments were managed by Principal Life Insurance Company, the custodian, for the period from January 1, 2023 to April 18, 2023. The Plan investments are now managed by John Hancock Life Insurance Company, the trustee, for the period April 19, 2023 to December 31, 2024. As a result, the investments and the related investment transactions qualify as party-in-interest transactions.

The Plan incurs expenses related to general administration and record keeping. The Employer pays a portion of these and other Plan expenses. The Employer also performs certain administrative functions at no cost to the Plan. The Employer does not expect reimbursement for these expenses.

The Plan is charged fees and expenses through expense ratios charged by the custodian and trustee. The investment expenses ratios vary by fund and are reflected in the value of the investments held by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

### **NOTE 6: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts.

### **NOTE 7: TAX STATUS AND UNCERTAIN TAX POSITIONS**

Prior to April 19, 2023, the Plan adopted the Principal Financial Group Pre-Approved Basic Savings Plan. Principal Life Insurance Company obtained an opinion letter from the Internal Revenue Service dated June 30, 2020. The opinion letter indicated that the form of the plan is accepted under section 401 of the Internal Revenue Code (IRC). Effective April 19, 2023, the Plan adopted the John Hancock Retirement Plan Services, LLC Defined Contribution Pre-Approved Plan. John Hancock Retirement Services obtained an opinion letter from the Internal Revenue Service dated June 30, 2020. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

The Plan accounts for uncertain tax positions in accordance with the provisions of the FASB Codification Topic *Income Taxes*. FASB Codification Topic *Income Taxes* clarifies the accounting for uncertainty in income taxes and requires the Plan to recognize in their financial statements the impact of a tax position taken or expected to be taken in a tax return, if that position is more likely than not to be sustained under audit, based on the technical merits of the position. The Plan administrator has assessed the tax positions taken by the Plan and determined that no positions exist that require adjustment or disclosure under the provisions of FASB Codification Topic *Income Taxes*.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### ***NOTE 8: RISKS AND UNCERTAINTIES***

The Plan's investments are exposed to various risks such as interest rate, market and credit risks. Certain investment options may invest in foreign securities. There are certain additional risks involved when investing in funds with underlying foreign securities that are not present with investments in domestic securities. These risks may involve foreign currency exchange rate fluctuations, adverse political and economic developments and the possible prevention of currency exchange due to foreign governmental laws or restrictions. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect the participant account balances and the amounts reported in the Plan's financial statements.
