Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

- the information in the accompanying financial statements related to assets held by and certified to by John Hancock Life Insurance Company, a qualified institution, agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of Financial Statements section of our report. December 31, 2024 and 2023

### (1) Plan Description

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### (a) General

The Plan is a defined contribution plan covering all employees of Tullock Management Company, Inc. ("the plan administrator") and the following related employers (collectively, the "Company") who have completed one-half year of service and attained age twenty-one. It is subject to the provisions of the Employee Retirement Income Security Act of 1974. The Board of Trustees is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Enterprise Healthcare of Statesville, Inc.  
Wilkinson Care Center, Inc. dba Elderberry Health Care  
Terrace Ridge Assisted Living, Inc.  
Grace Village, Inc.

#### (b) Contributions

Employees may elect to defer up to 15% of their pre-tax salary for retirement purposes. The employer will match a discretionary percentage, determined each year, of eligible employee contributions. An additional discretionary amount determined each year may also be contributed by the Company.

#### (c) Participant Accounts

Each participant's account is credited with the employee's contribution, the employer's contributions, and Plan earnings. Allocations are based on participant earnings on account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Notes to Financial Statements, Continued

### (1) Plan Description, Continued

#### (d) Vesting

Participants are immediately vested in their salary reduction contributions plus actual earnings thereon. Employer contributions and earnings thereon vest upon years of service as follows:

Participants become fully vested under the Plan by attaining normal retirement age, permanent disability, death or termination of the Plan.

#### (e) Payment of Benefits

A participant may elect to receive all or a portion of his vested account after he has terminated service, attained normal retirement age, or has sustained an immediate financial hardship as defined by the Plan. Benefit claims are recorded as expense when they have been approved for payment and paid by the Plan. There were no benefits payable as of December 31, 2024 and 2023.

#### (f) Application of Forfeitures

Upon termination of service, the nonvested portion of the participant's account is used to reduce employer matching contributions for the Plan year immediately following the Plan year in which the forfeiture occurs and any excess is reallocated among active participants' accounts in the ratio that the participant's compensation bears to the total compensation of all participants. Non-vested forfeitures used to reduce the employer's contribution for the years ended December 31, 2024 and 2023, were \$2,431 and \$0, respectively. At December 31, 2024 and 2023, unallocated forfeited accounts totaled \$928 and \$2,025, respectively.

#### (g) Administrative Expenses

Administrative expenses associated with the Plan are paid by the Plan and the Company.

#### **(1) Plan Description, Continued**

##### **(h) Investment Options**

Upon enrollment in the Plan, a participant may direct contributions into various investment options as defined by the Plan. Participants may change their allocation on a daily basis.

##### **(i) Notes Receivable from Participants**

Loans are available to participants, provided the outstanding balance of the loan does not exceed 50% of the participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions.

##### **(j) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their accounts.

#### **(2) Summary of Significant Accounting Policies**

##### **(a) Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

##### **(b) Use of Estimates**

Management uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of Plan assets and liabilities, the disclosure of contingent assets and liabilities, and the reported additions to and deductions from Plan assets. Actual results could vary from the estimates that were used.

#### (2) Summary of Significant Accounting Policies, Continued

##### (c) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### (d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### (e) Certified Investments

Certain information related to investments and notes receivable disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company ("John Hancock").

#### (3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

#### **(4) Tax Status**

The Plan adopted a standardized form of a prototype plan sponsored by Pentegra Services Inc. The prototype plan has received an opinion letter from the Internal Revenue Service as to the prototype plan's qualified status dated June 30, 2020. The prototype plan opinion letter has been relied upon by this Plan. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **(5) Related Party Transactions**

At December 31, 2024 and 2023, Plan assets included investments in funds managed by John Hancock. Transactions with the custodians qualify as party-in-interest transactions under ERISA. Personnel and facilities of the Company have been used to perform administrative services for the Plan at no charge to the Plan. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### **(6) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near future and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

#### **(7) Subsequent Events**

The Plan has evaluated subsequent events through October 1, 2025, the date which the financial statements were available to be issued. There were no significant subsequent events which require disclosure in the financial statements or footnotes.
