Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of the City Bank 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1: Plan Description

The following description of the City Bank 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General. The Plan is a contributory, defined contribution plan covering substantially all employees of South Plains Financial, Inc. (the Sponsor) and its wholly owned subsidiary, City Bank. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility. Employees are eligible to participate in the Plan beginning with their date of hire. Plan entry dates are on the first day of the second month coinciding with or next following the initial date of hire.

Contributions. Under the Plan, both participants and the Sponsor are allowed to make contributions. Participant contributions may consist of pre-tax 401(k) deferrals, after-tax Roth 401(k) deferrals, or rollover contributions. Participant contributions are subject to certain annual limitations under provisions of the Internal Revenue Code (the Code). Participants can revoke their salary deferral elections at any time, and changes to salary reduction elections are permitted monthly.

The Sponsor makes safe harbor non-elective matching contributions to the Plan on behalf of eligible participants equal to 100% of the participant's salary deferrals that do not exceed 5% of their compensation. Although the Sponsor may make additional discretionary profit-sharing contributions to the Plan, as determined annually, no such contributions were made for the years ended December 31, 2024 and 2023.

Participant Accounts. Participants direct the investments for their individual accounts. Each participant's account is credited with the participant's contributions, the Sponsor's safe harbor matching contributions, and allocations of any profit-sharing contributions, along with the investment earnings or losses thereon, and allocations of any administrative expenses.

Vesting. Participants are always fully vested in their contributions and the Sponsor safe harbor contributions, including the related earnings thereon. Participants vest in discretionary Sponsor contribution portions of their accounts (if any, including the related earnings) at a rate of 20% per year following two years of employment, such that the participant is fully vested in such contributions following six years of employment.

Payment of Benefits. Upon termination of service due to death, disability, or retirement, the participant may elect to receive a lump-sum amount equal to the vested balance of the participant's account, or equal installments over a period not to exceed the expected lifetime of the participant and their beneficiary. Upon termination of service for other reasons, the participant may receive the vested interest in the participant's account as a lump-sum distribution only. An automatic, single lump-sum distribution will be made to terminated participants whose vested benefit does not exceed \$7,000. The Plan also permits in-service and hardship withdrawals under certain conditions.

Forfeitures. Forfeitures of terminated participants' non-vested accounts are generally allocated amongst the remaining participants in the Plan in the form of discretionary contributions. There were no unallocated forfeitures at December 31, 2024 and 2023, and no forfeitures were allocated to participant accounts for the years then ended.

Notes Receivable from Participants. Participants may borrow from their account a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their account balance. Loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Plan Termination. Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would automatically become fully vested.

Note 2: Summary of Significant Accounting Policies

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), including specialized industry practices as specified in the American Institute of Certified Public Accountants audit and accounting guide titled *Audits of Employee Benefit Plans*.

Use of Estimates. Financial statements prepared in conformity with GAAP require management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Values. Investments are stated at fair value. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Payment of Benefits. Benefits are recorded when paid.

Administrative Expenses. Certain administrative expenses of the Plan are paid by the Sponsor. Employees of the Sponsor also perform certain administrative functions with no compensation from the Plan. These expenses are not reflected in the accompanying financial statements. Administrative expenses include fees related to the administration of notes receivable from participants, which are charged directly to the participant's account, along with investment-related expenses and other expenses of maintaining the Plan.

Notes Receivable from Participants. Loans to participants are reported at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions in accordance with the terms of the plan document.

Contributions Receivable. Employer contributions receivable are recognized when the Sponsor is obligated to make a contribution pursuant to formal commitments as well as legal or contractual requirements. Employee contributions receivable are recognized when deferrals have been withheld from employees' paychecks but have not been received by the Plan's custodian. The Sponsor is required to remit employee contributions to the Plan as soon as is administratively feasible.

Prohibited Transactions. A "party-in-interest" is a fiduciary or employee of the Plan, any person who provides services to the Plan, the Sponsor or an employee association whose members are covered by the Plan, a person who owns 50 percent or more of the Sponsor or such employee association or relatives of such person just listed. Under ERISA, a Plan fiduciary is prohibited from causing the Plan to engage in the following transactions with a party-in-interest, with certain conditional exemptions provided by ERISA:

- A sale, exchange, or lease of property;
- A loan or other extension of credit;
- The furnishing of goods, services, or facilities;
- A transfer of plan assets to a party-in-interest for the use or benefit of a party-in-interest; or
- An acquisition of employer securities or real property.

A fiduciary is also generally prohibited from using the Plan's assets for his or her own interest or account, acting in any Plan transactions on behalf of a party whose interests are adverse to those of the Plan or its participants and receiving consideration for his or her own account from a party dealing with the Plan in connection with a transaction involving the Plan's assets.

The Plan did not engage in any prohibited transactions for the years ended December 31, 2024 and 2023.

Tax Status. The Internal Revenue Service (IRS) has issued an opinion letter determining that the prototype non-standardized plan is acceptable under Section 401(a) of the Code. It is not a ruling or determination as to whether the Plan itself is qualified; however, an employer adopting this plan will be considered to have a qualified plan. In addition, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. There are currently no audits for any tax periods in progress. Generally, the Plan's tax returns are subject to examination for three years after they are filed.

Note 3: Data Prepared and Certified by Custodian

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Fidelity Personal Trust Company (FPTC), the custodian of the Plan:

For the years ended December 31, 2024 and 2023, FPTC has also certified the completeness and accuracy of the net appreciation in fair value of the Plan's investments totaling \$4,850,641 and \$5,695,777, respectively, and interest and dividend income totaling \$1,212,319 and \$890,220, respectively; interest and dividend income included interest on notes receivable from participants totaling \$35,943 and \$25,018, respectively.

Certain investments are shares of mutual funds managed by FPTC. FPTC is the custodian as defined by the Plan, therefore these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 4: Fair Value Measurements

FASB ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Level 1 Fair Value Measurements. The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end. The mutual funds held by the Plan are deemed to be actively traded thus they must publish their daily net asset values and transact at that price.

Note 5: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with such securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 6: Reconciliation of Financial Statements to Form 5500

The Form 5500 is a joint-agency form, developed by the IRS, the U.S. Department of Labor, and the Pension Benefit Guaranty Corporation, which may be used to satisfy the annual reporting requirements of the Code and Titles I and IV of ERISA. The Plan is required to file a Form 5500 annually, with audited financial statements enclosed. There were no reconciling items between the Form 5500 and the accompanying financial statements as of and for the years ended December 31, 2024 and 2023.

Note 7: Subsequent Events Evaluation

Management has evaluated subsequent events through September 24, 2025, the date which the financial statements were available to be issued. No material subsequent events have occurred during this time which would require recognition in the financial statements or footnotes as of or for the year ended December 31, 2024.
