## Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sync Residential 401(k) (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

## Opinion

## **Basis for Opinion**

## A. Description of Plan

The following description of the Sync Residential 401(k) (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan is a defined contribution plan covering substantially all employees, other than union, non-resident aliens, leased employees, and individuals incorrectly determined to be employees, of Sync Residential, LLC (the Employer or Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.
2. *Eligibility.* Employees become eligible to participate in the Plan, for both employee and Employer contributions, once they have completed six months of service and are 21 years of age or older. Employees are eligible for Employer nonelective contributions if they have met the age requirement, are employed on the last day of the Plan year, and have at least 550 service hours during the Plan year.
3. *Contributions.* Each year, participants may contribute up to 100% percent of pre-tax or after-tax annual compensation, as defined in the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an automatic elective deferral provision starting at 1%, which will increase annually by 1% up to a maximum of 10%. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Employer makes a safe harbor matching contribution on behalf of contributing participants each year which is equal to 100% of employee contributions up to 3% of eligible compensation plus 50% up to 5%. Nonelective contributions may be contributed at the option of the Employer. No such nonelective contributions were made to the Plan for 2024. Participants direct the investment of their contributions and the Employer's contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

4. *Participant accounts.* Each participant's account is credited with the participant's contributions and Employer safe harbor matching contributions, as well as allocations of the Employer's nonelective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

5. *Vesting.* Participants are vested immediately in their contributions and Employer safe harbor contributions, plus actual earnings thereon. Vesting in the Employer's nonelective portion of their accounts is based on years of continuous service and a six-year graded schedule. Separate rules apply in the event of disability or death of a participant.
6. *Payment of benefits.* Upon termination of service due to death, disability, or retirement, a participant can receive a lump sum amount equal to the value of the participant's vested interest in his or her account or a partial payment. Distributions after termination of employment for reasons other than the above shall commence as soon as administratively feasible. Participant consent is required for account distributions over \$5,000. In addition, the Plan allows for hardship distributions if certain criteria are met.
7. *Forfeited accounts.* At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,414 and \$1,280, respectively. These accounts will be used to reduce future Employer contributions or Plan expenses. In 2024, no forfeitures were used.

## B. Summary of Accounting Policies

1. *Basis of accounting.* The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).
2. *Use of estimates.* The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. *Investment valuation and income recognition.* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the trustee and investment advisors.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes gains and losses on investments bought and sold as well as held during the year.

4. *Payment of benefits.* Benefits are recorded when paid.
5. *Expenses.* Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Expenses related to distributions are charged directly to the participant's account and are included in administrative expenses. Recordkeeping and administrative fees are charged directly to administrative expenses. Investment related expense are included in net appreciation/depreciation in fair value of investments.

6. *Subsequent events.* The Plan has evaluated subsequent events through, September 29, 2025, the date the financial statements were available to be issued. Effective February 1, 2025, Plan management changed Plan trustee and recordkeeping services from Ascensus to T. Rowe Price (Reliance Trust Company). The Plan Document was restated as of this date and loans are now permitted under new Plan provisions.

## C. Certified Information

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus as agent for Ascensus Trust Company, the trustee, has certified that the following data included in the Plan's financial statements and supplemental schedules is complete and accurate.

## D. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust:* Valued at the NAV of underlying investments of participant units held by the Plan as of the last trading day of the period, as reported by the managers of the trust.

## E. Party in Interest Transactions

Certain Plan investments are managed by Ascensus as agent for Ascensus Trust Company, the trustee, and therefore, these transactions qualify as party in interest transactions. Additionally, fees were paid to Ascensus for recordkeeping and administration.

## F. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

## G. Tax Status

The Plan adopted a non-standardized defined contribution plan with CODA that has received an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the non-standardized plan was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## H. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. As of December 31, 2024, approximately 51% of the Plan's net assets available for benefits were invested in three of the Plan's mutual funds. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Employer is aware of certain employee and employer contributions that were not funded in accordance with Plan provisions. The Plan administrator is evaluating whether to correct related instances of noncompliance. Any deposits made for missed employee and employer contributions to correct this failure will be made from the Plan Sponsor's assets and not from assets of the Plan. The Plan administrator has represented that they do not believe the errors will materially impact the Plan's financial statements.

## I. Prohibited Transaction

During 2023, the Company inadvertently failed to deposit \$12,503 of participant contributions within the required timeframe as stated by the United States Department of Labor (DOL) regulations. The Company plans to deposit lost earnings to correct this failure in 2025 and make any required filings with the DOL.
