Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Knutson Holdings, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Knutson Holdings, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan sponsored by Knutson Holdings, Inc. (the Company). Nonunion employees are eligible to participate in the Plan on the first of the month immediately following, or coinciding with, the day the employee has been employed for at least three months. Employees subject to collective bargaining agreements, interns and nonresident employees or those part-time, temporary or seasonal employees whose regularly scheduled service is less than 1,000 hours of service in an eligibility computation period are excluded from participating in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company appointed Voya Retirement Insurance and Annuity Company to be the trustee and invest the assets of the Plan. The Plan's Investment Committee is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions: Participants have the option to participate in the Plan through salary deferral contributions and the Company's contributions. Salary deferral contributions can be up to 100% of a participant's eligible earnings up to the maximum permitted by the Internal Revenue Service (IRS). The Plan automatically enrolls all eligible employees with a salary deferral contribution of 5%, unless the participant elects otherwise. The Company makes a nondiscretionary matching contribution equal to 50% of the first 8% of eligible earnings contributed by a participant to the Plan. In addition, the Company may make discretionary profit-sharing contributions. To qualify for the discretionary profit-sharing contribution, the participant must have at least three months of service and be an employee on the last day of the plan year. The Company declared a discretionary profit-sharing contribution of \$0 and \$314,054 for the years ended December 31, 2024 and 2023, respectively.

Effective January 1, 2025, the Company signed an amendment to increase the automatic enrollment provision to 8%, unless the participant elects otherwise.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's matching contributions, and an allocation of (a) the Company's discretionary profit-sharing contribution, if any, and (b) investment results. Participant accounts are charged an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options: The Plan has selected various investment options, as more fully described in the Plan literature, to which participants may designate the allocation of their account balances. The funds vary in type of investments, rates of return and investment risk. Participants may elect to have all or part of their balances and future contributions transferred from one fund to another or in any combination. These elections may be made on a daily basis.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contributions plus actual earnings thereon is based on years of service. The Plan was amended, effective January 1, 2024, whereby participants do not vest in the Company contributions until they reach three years of service time, at which they become fully vested. For participants enrolled in the Plan prior to January 1, 2024, participants are 20% vested after two years of service and 100% vested after three years of service.

Note 1. Description of the Plan (Continued)

Notes receivable from participants: Participants may apply to borrow from their accounts based on the Plan's provisions. A participant may only have one note outstanding at any time, and the amount of the note must be at least \$1,000 and cannot exceed the lesser of 50% of the participant's total vested account balance or \$50,000. The term of a note may not exceed five years, unless the note qualifies as a home loan, in which case the term may not exceed 15 years. Outstanding notes are secured by the balance in the participant's account and bear interest at the prime interest rate on the date of issuance plus 2.00%. The rates of interest on existing notes as of December 31, 2024, range from 6.10% to 9.50%. Principal and interest are paid ratably through payroll deductions with maturity dates through April of 2029.

Benefits paid to participants: Upon a participant's death, permanent disability, retirement or other termination of employment, a participant or the participant's beneficiary, will receive a distribution equal to the value of the participant's vested account balance, as defined in the Plan, in the form of a lump-sum distribution or in installments over varying periods. If, at the time a participant is terminated, their account balance is less than \$1,000, it will be automatically distributed to the participant in a lump sum. If a terminated participant has a balance between \$1,000 and \$5,000, it will be transferred into a qualified individual retirement account for the participant unless the participant has elected to receive a lump-sum distribution.

Forfeited accounts: Forfeited nonvested accounts can be used to fund the Company's contributions or, at the discretion of the Company, to pay the administrative expenses of the Plan. As of December 31, 2024 and 2023, the Plan had a forfeited nonvested account balance of approximately \$20,000 and \$16,000, respectively. The Plan used approximately \$16,000 of forfeited nonvested accounts to partially fund Company contributions in 2024.

Note 2. Significant Accounting Policies

Basis of presentation: The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Fully benefit-responsive investment contracts held by a defined contribution plan are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. All other investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies, utilizing information provided by the Plan's investment advisors and trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participant notes in default are recorded as a distribution based upon the terms of the Plan document.

Note 2. Significant Accounting Policies (Continued)

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule of assets (held at end of year).

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Benefits paid to participants: Benefit payments to participants are recorded when paid.

Administrative expenses: Administrative expenses may be paid by the Company, the Plan, or at the discretion of the Company, paid with forfeitures. The expenses paid directly by the Company are excluded from these financial statements. In addition, investment-related fees are included as an offset to net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Risks and uncertainties: The Plan provides for investment in a variety of investment securities, which are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially impact participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Subsequent events: The Plan Administrator has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by Voya Retirement Insurance and Annuity Company

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, that were prepared by or derived from information provided by Voya Retirement Insurance and Annuity Company, the trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

Note 4. Fair Value Measurements

The framework for measuring fair value provides for measuring a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts: Pooled separate accounts are valued at the net asset value (NAV) of shares held by the Plan at year-end, which is based on quoted prices for similar assets traded in active markets. The NAV, as provided by the custodian, is used as the practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

In accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Subtopic 820-10, the pooled separate accounts held by the Plan are not classified in the fair value hierarchy table that prioritizes the inputs to valuation techniques used to measure fair value because they are measured at NAV per share as a practical expedient.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (f) This category is primarily composed of a fund whose objective is to provide stable total return through investing primarily in short-term debt securities and other fixed-income investments.

Investment contract with insurance company: The Plan has a benefit-responsive investment contract, Voya Fixed Account, with Voya. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Stability of principal is the primary objective of this investment option. The investment contract issuer is contractually obligated to repay the principal and a guaranteed minimum interest rate declared for a defined period. The guaranteed interest rate to the plan cannot be less than 1%.

The Plan held \$762,158 and \$740,557 in this investment contract, which is reported at contract value, at December 31, 2024 and 2023, respectively. As described in Note 2, because the investment contract is fully benefit-responsive, the investment contract is included in the statements of net assets available for benefits as December 31, 2024 and 2023, at contract value. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Note 4. Fair Value Measurements (Continued)

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Voya. The Plan Administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value are not probable.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants would become 100% vested in their accounts.

Note 6. Income Tax Status

The Plan adopted a nonstandardized form of a prototype plan sponsored by Goldleaf Partners. The prototype plan provider has received an opinion letter dated June 30, 2020, from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related-Party and Party-in-Interest Transactions

Voya Retirement Insurance and Annuity Company, the trustee, held the Plan's investments and executed all investment transactions; therefore, these transactions qualify as party-in-interest transactions.
