Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of National Pool Partners Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of National Pool Partners Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about National Pool Partners Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 DESCRIPTION OF THE PLAN

Organization

National Pool Partners Retirement Plan (the “Plan”) is a defined contribution plan covering all eligible employees of National Pool Partners Inc. (the “Company” or the “Employer”). The Plan was established on January 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The most recent Plan restatement came on January 1, 2024.

The following brief description of the Plan provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan’s provisions.

General

The Plan covers all eligible employees of the Company as defined by the Plan Document. To participate in the Plan, employees must be employed by the Company or any affiliate who has adopted the Plan and not be a non-resident alien, a resident of Puerto Rico, or a temporary or seasonal employee. The Plan Administrator is responsible for the oversight of the Plan. Plan management determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

An eligible participant can begin contributing to the Plan upon completing one hour of service within the 30-day time period following the employee’s employment commencement date and attaining the age of 18. The entry date will be the first day of the month following meeting the eligibility requirements.

Contributions

Participants may elect to contribute up to 100% of pretax annual compensation, as defined in the Plan, up to a maximum contribution per employee allowable by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants are permitted to designate a portion or all of their deferral contributions as Roth 401(k) contributions, which are after-tax deferrals to the Plan. Participants may also contribute amounts representing distributions from other qualified plans. The Company makes Safe Harbor contributions using the enhanced matching method equal to 100% of each participant’s elective deferrals not to exceed 4% of participant’s compensation. Safe Harbor contributions are made each payroll period. The employer may make a discretionary additional matching contribution each plan year.

Contributions are calculated using W-2 wage compensation.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers many mutual funds as investment options for participants. Plan management determines funds to be included in the Plan’s investment portfolio and monitors its investment performance.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, (b) Plan earnings or losses, (c) withdrawals, and (d) administrative expenses. Allocations are based on participant account balances, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon, and Safe Harbor employer contributions. Vesting in the Company's discretionary additional match portion of their accounts, plus earnings thereon, is based on years of credited service. A participant is vested 20% for each year of credited service beginning in year two and becomes 100% vested upon completion of six years of credited service. Any participant who attains the normal retirement age, becomes disabled or dies becomes fully vested regardless of length of service.

Payment of Benefits

Upon death, disability, retirement, or termination of service, participants or their designated beneficiaries may receive a lump-sum payment amount equal to the vested amount of their account or installments if participant is subject to lifetime required minimum distributions.

Forfeitures

Forfeitures of terminated participants' non-vested accounts are retained in the Plan and used to reduce future employer contributions or to pay for future Plan expenses. During 2024, the Plan utilized approximately \$11,000 from forfeited non-vested accounts to pay for Plan expenses. There were no forfeitures in 2024. There was approximately \$1,000 and \$12,000 in the forfeiture account as of December 31, 2024 and 2023, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to amend or discontinue the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, the account of each participant will be 100% vested.

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting and in conformity with generally accepted accounting principles in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets

and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in mutual funds are stated at fair value based on closing market quoted prices at year-end. Investments in common collective trust funds are valued based on the plan's interest, represented by investment units, in the underlying investments held within the trust that are traded in an active market. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments represents both realized and unrealized gains and losses.

Contributions

Contributions from employees are recorded as they are withheld from the participant's wages. Contributions from the Company are recorded in the period in which the related participant contributions are due.

Excess Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with the corresponding reduction to contributions. As of December 31, 2024 and 2023, there were no excess contributions.

Benefit Payments

Benefits are recorded when paid.

Plan Expenses

Certain administrative expenses incurred in the operation of the Plan are paid by the Company and are not reflected in the accompanying financial statements. Fees related to the administration of benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Administrative expenses also include certain investment management and plan audit fees.

Subsequent Events

In accordance with Financial Accounting Standards Board Accounting Standards Codification ("FASB ASC") Topic 855, *Subsequent Events*, the Plan evaluated subsequent events through August 26, 2025, the date the financial statements were available for issue.

NOTE 3 FAIR VALUE MEASUREMENTS

In accordance with FASB ASC 820, *Fair Value Measurement*, the Plan assessed the guidelines for measuring fair value. These guidelines provide a fair value

hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. FASB ASC 820 establishes three levels of fair value hierarchy that are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets and quoted prices for identical or similar assets or liabilities in inactive markets. Inputs other than quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data are also included. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan’s investments are held in mutual funds and common collective trusts. The mutual funds are valued using level 1 inputs, while the common collective trusts are valued using level 2 inputs, as of December 31, 2024 and 2023.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used for the periods presented in these financial statements.

Mutual Funds - Shares of the funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Funds - Investments in common collective trust funds are valued based on the plan’s interest, represented by investment units, in the underlying investments held within the trust that are traded in an active market.

NOTE 4 INCOME TAX STATUS

The Company has adopted an Alerus Financial non-standardized pre-approved profit-sharing plan. The Internal Revenue Service ("IRS") has issued a letter, dated June 30, 2020, which stipulates that an employer who adopts this pre-approved plan will be considered to have a plan qualified under Section 401 of the IRC provided all terms of the Plan are followed. The Plan administrator believes that the Plan is currently being operated in compliance with the qualified pre-approved plan. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt as of the date of the independent auditor's report.

Accounting standards require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained a certification from Alerus Financial, N.A., trustee of the

Plan, that all of the information provided by them included in the trust statement, participant valuation summary, and the reconciliation of investment funds is complete and accurate. Information included in the accompanying financial statements and all information in the supplemental schedule is presented in reliance solely upon such certification. No auditing procedures were performed by the independent public accountants with respect to the investments certified as complete and accurate by the trustee, except for comparing such information with the related information included in the financial statements.

NOTE 7 PARTIES IN INTEREST AND RELATED PARTY TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. For the year ended December 31, 2024, the Plan's transactions with parties-in-interest were as follows:

Expenses

All administrative expenses are to be paid by the Plan unless paid by the plan sponsor. Also, certain employees of the Company, who are also plan participants, perform administrative services on behalf of the Plan at no cost to the Plan. Fees related to processing distributions are charged directly to the participant accounts and are included in administrative expenses.

These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.
