We have performed audits of the accompanying financial statements of the Hall Drilling, LLC 401(k) Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE 1 - DESCRIPTION OF PLAN

The following description of the Hall Drilling, LLC 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General - The Plan was established on January 1, 2015 and is a defined contribution 401(k) retirement plan covering all full-time employees of Hall Drilling, LLC (Company) who have completed 60 days of service and have attained age 18. The Plan includes an automatic salary deferral feature of 4%, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). If participants do not make an investment selection at enrollment, contributions are directed into a designated fund until changed by the participant. The designated funds are the Vanguard Target Retirement Funds 2020 to 2060. The specific fund is determined based on the Participant's expected retirement date.

Contributions - Each year, participants may contribute a portion of their annual pretax compensation to the Plan, subject to certain limitations under the Internal Revenue Code (IRC). Those who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company makes a safe harbor matching contribution equal to 100% of each participant's salary deferrals that do not exceed 4% of participant compensation.

Participant Accounts - Each eligible participant's account is credited with the participant's contributions, employer's contributions and an allocation of Plan earnings/losses, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined.

Vesting - Participants are immediately vested in all contributions and corresponding earnings.

Payment of Benefits - Upon termination of service, disability, death, retirement or attainment of age 59 1/2 (in-service distribution), participants or their beneficiaries automatically receive a lump-sum payment if the participant's account balance does not exceed \$5,000. If the participant's account balance exceeds \$5,000, the participant must consent to any distribution before it may be made. Upon death or disability, if a participant's account balance exceeds \$5,000, the participant or his or her beneficiary may elect to receive a distribution in a single lump-sum payment or partial withdrawals or installments but only with respect to minimum required distributions, over a period of not more than the assumed life expectancy. Participants may also withdraw from their participant account balances under certain hardship conditions, as defined in the Plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by the Plan in the preparation of the accompanying financial statements follows:

Basis of Accounting - The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Cash - The Plan considers all investments purchased with a maturity of three months or less to be cash. The Plan maintains cash, at various financial institutions, that may at times exceed federally insured amounts.

Investment Valuation and Income Recognition - Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Administrative expenses are paid for by the Plan to the extent not paid by the Company.

Risks and Uncertainties - The Plan provides for various investment options in a common-collective trust fund and any combination of mutual funds, which include investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in value will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events - Subsequent events are defined as events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are issued or are available to be issued. Management has evaluated subsequent events through September 17, 2025, the date that the financial statements were issued and determined that there have been no events that have occurred that would require adjustments to the disclosures in the financial statements.

NOTE 3 - FAIR VALUE MEASUREMENT

Generally accepted accounting principles establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under generally accepted accounting standards are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Funds:* Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value, and is based on the fair value of the underlying investments (consisting of guaranteed investment contracts, security-backed contracts and common-collective trusts) held by the fund less its liabilities.

- Investments from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income, including interest and dividend income and net appreciation in the fair value of investments as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' accounts will be distributed in accordance with the terms of the Plan agreement.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Alliance Pension Consultants, LLC provides certain recordkeeping and administrative services to the Plan for which it receives compensation, thus it qualifies as a party-in-interest. Fees paid by the Plan for these services for the year ended 2024 totaled \$60,957.

The Plan sponsor provides certain accounting, legal, recordkeeping and administrative services to the Plan for which it receives no compensation.

NOTE 7 - TAX STATUS

The Plan is a nonstandardized prototype plan that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC) and, therefore, the related trust is tax-exempt. The Plan sponsor has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be substantiated upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audit by taxing jurisdictions, however there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to examinations for years prior to 2021.


