The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the Hollywood Woodwork, Inc. Employee Stock Ownership Plan (the Plan) is provided for general information purposes. Plan participants should refer to the plan agreement for a more complete description of the Plan's provisions.

***General and Trust***

Hollywood Woodwork, Inc. established the Plan and Trust effective January 1, 1999, to enable eligible employees to acquire stock ownership interests in the Company, by investing primarily in the shares of the Company's stock. The Plan operates, in relevant part, as a non-leveraged, employee stock ownership plan (ESOP) within the meaning of Section 4975(e) (7) of the Internal Revenue Code of 1986, as amended. The Plan is also subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended. Effective January 1, 2016, the Plan was formally amended and restated to comply with certain changes in laws and regulations.

***Trust Agreement and Plan Administration***

The Plan is governed by a trustee (the Trustee), appointed by the Company with certain fiduciary responsibilities established primarily to ensure the Plan is operated for the exclusive benefit of the plan participants. The Plan is administered by a committee comprised of one or more persons appointed by the Company's Board of Directors (the "Plan Administrator"). The trust agreement, under which the trustee's responsibilities are defined is the Hollywood Woodwork, Inc. Employee Stock Ownership Trust.

The Plan contracts with Principal Financial Group (Principal) for retirement plan administration, transaction processing and recordkeeping services of the Plan's assets, which consist primarily of the non-publicly traded shares of Hollywood Woodwork, Inc. common stock.

***ESOP Ownership***

In accordance with the Stock Purchase Agreement dated December 14, 1999, between Hollywood Woodwork, Inc. and the Trustee, the Trust purchased 48,000 shares of non-publicly traded, no par, common stock at a per share price of \$62.50, constituting 30 percent of the total issued and outstanding shares of the capital stock of the Company. The shares are held in a trust fund established under the Plan. Since 2017, 45,408 shares at a total cost of approximately \$2,980,000 were redeemed and retired to corporate treasury, leaving 114,591 shares issued and outstanding. As of December 31, 2024, the trust retains 48,000 shares or 41.9% of the total issued and outstanding shares of the capital stock of the Company.

***ESOP Ownership*** (Continued)

If the Plan were to finance options to purchase additional shares of stock from the Company in the future, such borrowings would generally be collateralized by the additional shares of unallocated stock. As the principal balance is repaid, an appropriate percentage of stock is released and allocated to the eligible participant accounts in accordance with applicable regulations under the Internal Revenue Code. The lender holds no rights against the shares once they are allocated within the terms of the ESOP. Accordingly, the Plan financial statements would present separately the assets and liabilities and changes therein pertaining to the participant accounts with vested rights in allocated stock (allocated), and those shares of stock not yet allocated to participant accounts (unallocated). All shares of stock are allocated to participant accounts as of December 31, 2024 and 2023.

***Eligibility***

Employees of the Company are generally eligible to participate in the Plan upon reaching 18 years of age and completing one year of service, providing they worked at least 1,000 hours during the consecutive 12-month period. The Plan provides for automatic entry, which occurs on the first entry date, (January 1 and July 1 of each calendar year) once eligibility requirements are met. An eligible employee may also elect to forgo participation in the Plan with respect to any plan year. Such election must be made in writing to the Plan Administrator prior to the first day of the plan year for which the election is to be effective. Once an election not to participate becomes effective, an employee cannot rescind such election without the approval in writing of the employer or the Plan Administrator.

***Contributions***

Contributions to the Plan by participants are not permitted.

***Employer Contributions***

Subject to the conditions and limitations of the Plan, the Company, at the discretion of the Board of Directors, may elect to contribute to the Trustee shares of Company stock or the cash equivalence measured at fair market value on behalf of the Plan, up to the maximum amount permitted under the Internal Revenue Code. Participants who have not met the 1,000-hour minimum service requirement during the plan year in which a contribution is made, or are not employed on the last day of the plan year are generally not eligible for an allocation of the contribution for that year, unless by reason of normal retirement, death or disability. For the plan years ended December 31, 2024 and 2023, the Company contributed and allocated to eligible participant accounts \$236,000 and \$200,000, respectively.

***Payment of Benefits***

Distributions due to death, disability or retirement are required to begin no later than one year after the end of the plan year in which the triggering event occurred. Payment of a participant's account balance under \$25,000 will be made in a lump sum. Account balances greater than \$25,000 will be paid over a five-year period with minimum payments of \$10,000. Distributions for other terminations are required to begin on the vested portion of the participant's account balance no later than the end of the sixth year following the year in which the termination occurred and can be paid over a five-year period. The value of the participant's account subject to distribution will be based upon the most recent ESOP Stock Valuation performed by an independent appraiser, as defined by Internal Revenue Code Section 170.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan as long as the shares are not publicly traded or if the shares are subject to trading limitations. In 2024 and 2023, the Company repurchased from participants holding 2,473 and 2,156 shares of stock at per share prices of \$76.41 and \$81.75, as determined by independent appraisal, respectively.

***Administrative Expenses***

As provided in the Plan agreement, administrative expenses may be paid by the Plan or the Company, at their election. The Company has historically paid both administrative and operating expenses of the Plan.

***Voting Rights***

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries. There were no unallocated shares as of December 31, 2024 or 2023.

***Participant Accounts***

The Plan is a qualified defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of employer contributions, actual earnings thereon, and forfeitures of the non-vested portion of terminated participant accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total compensation of all eligible participants for the Plan year.

***Vesting***

When a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will be entitled to an amount equal to the vested portion of their available account balances based upon total years of service with the Company. Such participant's vesting will be determined in accordance with the following schedule:

Participants whose employment terminates at any time due to normal retirement (65), permanent disability or death, become immediately vested in their total account.

***Forfeitures***

Once a participant terminates from the Plan and incurs five (5) consecutive one-year breaks in service, the non-vested portion of their account balances will be released from their forfeitures account and allocated to remaining eligible participants in the same manner the Company contribution gets allocated. In 2024 and 2023, forfeitures released and reallocated to eligible participant accounts totaled \$2,824 and \$6,301, respectively.

***Put Option***

Pursuant to federal income tax regulations, the Company is required to issue a "Put Option" to all participants receiving a distribution of Company stock from the Plan. The Put Option permits the participant to require the Company to repurchase its shares of non-publicly traded stock or cash equivalent at its then fair market value, as determined by independent valuation. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the Put Option is to ensure that participants holding non-publicly traded shares of common stock have the ability to ultimately obtain cash.

***Diversification***

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company non-publicly traded common stock into investments that are more diversified. Participants who are at least age 55 with 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six -year period. In each of the first five (5) years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage increases to 50%. Participants who elect to diversify receive a cash distribution equivalent to the fair value of the shares held, as determined by the most recent independent valuation. Disbursements attributable to diversification totaled \$47,603 (or 623 shares) and \$25,588 (or 313 shares) for the years ended December 31, 2024 and 2023, respectively.

***Termination of the Plan***

Although it has not expressed any intention to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the interest of each participant's account in the trust fund will become immediately vested and distributed to each participant or his or her beneficiary according to the timeline prescribed by the Plan and pursuant to Internal Revenue Code regulations. Upon termination of the Plan, the Committee shall direct the Trustee to pay all liabilities and expenses of the trust fund.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires the Plan to make estimates and assumptions that affect the reported amounts of net assets available for benefit and disclosure of contingent net assets available for benefit as of the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

***Payment of Benefits***

Benefits are recorded when paid.

***Investment Valuation and Income Recognition***

The shares of non-publicly traded Company common stock are valued at estimated fair value as determined in an ESOP stock valuation performed by an independent appraiser each year. See Note 4 for discussion of fair-value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Risks and Uncertainties***

Investments consist primarily of the employer's common stock, which is exposed to various risks, such as market, concentration and credit risk, and which is estimated using valuation assumptions based on earnings, cash flows, or other techniques. Due to the level of risk associated with the investment in common stock and uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 3. INVESTMENTS**

The Plan's investment in the Company's allocated common shares as of December 31, 2024 and 2023 were as follows:

**NOTE 4. FAIR VALUE MEASUREMENTS**

GAAP provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of fair value hierarchy are described as follows:

Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of the unobservable inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5. CHANGES IN FAIR VALUE LEVELS**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers between Levels 1, 2 or 3.

**NOTE 6. RELATED PARTY AND PARTIES-IN-INTEREST**

The Plan holds investments in the employer's shares of non-publicly traded common stock, which qualifies as a related party and party-in-interest to the Plan. Furthermore, substantially all of the Plans administrative expenses are also paid the employer. Eligible employees who are participants of the plan are parties in interest to the Plan as well as certain members of management who perform administrative and fiduciary duties for the Plan. There were no prohibited transactions between the Plan and the Company or its employees during the years ended December 31, 2024 and 2023.

Principal Financial Group is the record-keeper and custodian of record for the Plan, and therefore qualifies as a party-in-interest to the Plan. Fees paid to the record-keeper from the Company are non-prohibited transactions.

The Trustee to the Plan is also a former employee who receives certain administrative fees for their services to the Plan, which qualifies them as a party in interest. These transactions are allowable related party and party-in-interest transactions to which the Trustee has no authority or influence. Expenses paid to the Trustee are from the Company.

**NOTE 7. TAX STATUS**

The Plan obtained its latest determination letter dated April 27, 2017, in which the IRS stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by a tax authority. The Plan administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8. SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.
