Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Thrasher, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Description of the Plan

General

The following description of Thrasher, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Thrasher, Inc. (Company) for the benefit of employees who are age 19 or older and have completed one month of service. Related employers who also participate in the Plan include Sure-Dry, LLC, Supportworks, Inc., LRE Foundation Repair, LLC, Hello Garage Franchising, LLC, Blackburn Foundation Repair, and Saber Foundation Repair. Long-term part-time employees become an active participant on the earliest date on which they are 19 years of age or older and have been credited with at least three consecutive years of at least 500 hours of service (not including service prior to January 1, 2021). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Principal Trust Company, (Principal) is the Plan's trustee and custodian. Benefit Plans, Inc. serves as recordkeeper.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual pre-tax or Roth contributions of up to 100% of eligible compensation, provided that the contribution does not exceed annual limitations set by the Internal Revenue Service. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Plan allows the employer sole discretion regarding matching contributions. The amount, the allocation formula, and the percentage or dollar amount limit applicable to such match, if any, is the complete and sole discretion of the employer and may vary from year to year. Participants must be employed at the end of the plan year to receive an employee matching contribution for that year. For the plan years ended December 31, 2024 and 2023, the employer made a matching contribution equal to 100% of the first 5% of a participant's elective deferrals.

Participant Investment Account Options

Each participant has the option of directing Plan contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service according to the following schedule:

Notes Receivable from Participants

Loans are not permitted by the Plan, however, loans were permitted by the previous Plans of LRE Foundation Repair LLC, South Cast Piering LLC, and Sure-Dry, LLC which were transferred to the Thrasher Plan in 2024. As such, the loans previously allowed by these Plans were carried over to the Thrasher Inc. Plan under their previous terms. For these outstanding loans, Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 2% above the prime rate at the time of the loan. Principal and interest is paid ratably through bi-weekly payroll deductions over a period not to exceed five years, except for loans for the purchase of principal residence.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or, in substantially equal installments over a period not more than the life expectancy of the beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Upon termination of service for any reason, if the value of the participant's account is less than \$5,000, the participant will receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$325,000 and \$229,000, respectively. These accounts may be used to reduce future employer contributions or administrative expenses. For the years ended December 31, 2024 and 2023, forfeitures totaling approximately \$302,000 and \$242,000, respectively, were used to reduce employer contributions for the respective years.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully-benefit responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

The Plan's interest in the collective investment trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation and matching contributions from the Employer are recorded when the participant compensation is earned.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustee/Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company, LLC, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year end) as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan invests in a collective investment trust and mutual fund managed by Principal. Principal is the trustee and custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. The Plan paid directly \$139,306 and \$113,042 of administrative fees to Principal during 2024 and 2023, respectively.

Note 5. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

Level 1 Quoted prices in active markets for identical assets or liabilities

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Guaranteed Investment Contract

The Plan holds a fully benefit-responsive investment contract with Principal. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit Principal to terminate the agreement prior to the scheduled maturity date.

Note 6. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust document sponsored by Principal Retirement Plan Services, LLC. This prototype plan document has been filed with the appropriate agency. The Internal Revenue Service ruled on June 30, 2020, that the Pre-Approved Defined Contribution Basic Plan Document (the plan document of Benefit Plans, Inc. upon which the Plan is based), as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Transfer of Plan Assets

On April 4, 2024, an agreement was approved effective April 4, 2024 to merge the 401(k) Profit Sharing Plan and Trust assets into the Plan. All LRE Foundation Repair LLC. participants became 100% vested in the Plan upon merger and were provided the option to receive an in service distribution from their fully vested LRE Foundation Repair LLC Employer Matching or Profit Sharing balance. A total of \$1,404,168 in assets was rolled into the Plan on April 4, 2024.

On March 28, 2024, an agreement was approved effective March 28, 2024 to merge the South Cast Piering LLC 401(k) Profit Sharing Plan and Trust assets into the Plan. All South Cast Piering LLC. participants became 100% vested in the Plan upon merger and were provided the option to receive an in service distribution from their fully vested South Cast Piering LLC Employer Matching or Profit Sharing balance. A total of \$330,786 in assets was rolled into the Plan on March 28, 2024.

On March 22, 2024, an agreement was approved effective March 22, 2024 to merge the Sure-Dry, LLC 401(k) Profit Sharing Plan and Trust assets into the Plan. All Sure-Dry, LLC. participants became 100% vested in the Plan upon merger and were provided the option to receive an in service distribution from their fully vested Sure-Dry, LLC Employer Matching or Profit Sharing balance. A total of \$1,344,017 in assets was rolled into the Plan on March 22, 2024.

All assets and liabilities of LRE Foundation Repair LLC, Sure-Dry, LLC, and South Cast Piering LLC were added at fair value as of transfer date in accordance with GAAP. Loans of \$139,323 from the three entities were also transferred to the Plan at their receivable balance as of each transfer date. These asset transfers total \$3,218,294 transferred to the Thrasher Plan in 2024.

The Plan Sponsor has taken appropriate steps to ensure full vesting was applied to transferred participants and has communicated these changes accordingly.
