NOTE 1 - PLAN DESCRIPTION

The following description of American Hospital Association 401(k) Thrift and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a contributory, defined contribution plan providing retirement benefits to eligible employees of American Hospital Association (the Association) who are age 18 or older. Effective January 1, 2020, the Plan was amended to remove the three-month service requirement for employee elective deferrals and the Association's safe harbor contribution. In order to be eligible for the Association's matching contribution, participants must complete one year of service as defined by the Plan. Additionally, in order to be eligible for the Association's discretionary profit-sharing contribution, the participant must be employed on the last day of the Plan year. The Association established a Benefits Steering Committee to be responsible for certain aspects of the Plan's administration. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Each year, participants may contribute a percent of pre-tax annual compensation, Roth and after-tax contributions, as defined in the Plan, and catch-up contributions, all which are not to exceed the Internal Revenue Service (IRS) imposed maximum limitation. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rates set at 6% of eligible compensation and their contributions invested in a designated default fund until changed by the participant. Effective January 1, 2022, deferral rates are automatically increased by 1% in March of each year until they reach a maximum of 15% of eligible compensation. Participants of the Plan may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants are eligible to receive matching contributions after completing one year of service. The Association matches the employee's eligible contribution at 100% of the first 3% of eligible base compensation that a participant contributes to the Plan. In addition, the Plan operates as a safe harbor 401(k) Plan and the Association makes a 3% non-elective contribution to the Plan on behalf of all eligible employees. For the year ended December 31, 2024, such contribution amounted to \$2,038,408. The Plan also provides for a discretionary profit-sharing contribution to be made on behalf of the Association each year. No such profit-sharing contribution was approved or made for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, Association matching and safe harbor contributions, and allocations of plan earnings. Participants' accounts are charged with an allocation of administrative expenses that are paid by the Plan. The allocation is a flat dollar amount, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in all of the Association's contribution portion of their accounts plus actual earnings thereon based on years of credited service. A participant becomes vested at the rate of 50% after the first year, and will be 100% vested after two years of credited service.

Investments

Participants direct the investment of their account balances in any whole percentage in any of the investment options offered by the Plan. The Plan currently offers a wide range of registered investment companies and a common/collective trust as investment options for participants. Participants may change their investment options daily.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant must have a minimum vested balance of \$2,000 and cannot have more than two loans outstanding at any given time. Note receivable terms range from six months to five years or up to 30 years for the purchase of a primary residence. The notes receivable are secured by the balance in the participant's account and bear interest at the prime rate plus 1% at the date the note receivable is made. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service, death, disability, or retirement, participants may receive a lump-sum amount equal to the vested balance of their accounts. If the participant has a vested balance of greater than \$1,000, the participant has the option of leaving the vested balance within the Plan or may elect to rollover the vested balance to another plan or individual retirement account. The Plan's provisions also provide for in-service withdrawals at age 59½ or in the event of financial hardship, as defined by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$12,083. These accounts are used to reduce Association contributions. In 2024, \$59,913 was used to reduce Association contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Benefits Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default based on the provisions of the Plan, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Expenses of the Plan, other than certain investment and administrative activity costs, are paid by the Association. Expenses paid by the Association are excluded from these financial statements. Although the Association has elected to pay these expenses, it is not obligated to do so. If the Association ceases to pay all or part of these expenses in the future, they will be paid by the Plan's trustee out of the assets of the Plan. Certain investment management fees are netted in the appreciation in fair value of investments.

NOTE 3 - INFORMATION CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company (Vanguard), the Plan's trustee, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Collective Trust

Valued based on the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or model-based valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Association has the right under the Plan's provisions to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Vanguard. Vanguard is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

Certain employees of the Association provide administrative services for the Plan and are not reimbursed from the Plan.

NOTE 7 - TAX STATUS

The Plan has adopted a non-standardized form of a prototype plan sponsored by The Vanguard Group. The prototype plan has received an opinion letter from the IRS, dated June 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The prototype plan's opinion letter has been relied upon by the Plan. Although the Plan has been amended since receiving the opinion letter on the prototype plan, the Plan's administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

The Plan's management has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued. No events require recognition or disclosure in the financial statements.
