As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**DECEMBER 31, 2024 AND 2023**

**1. DESCRIPTION OF PLAN**

The following description of the Salient Corporation 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General -

The Plan was established on November 1, 1996. The Plan is a defined contribution 401(k) and profit sharing plan covering substantially all employees of Salient Corporation (the “Company”). Employees are permitted to make elective deferrals to the Plan upon completion of thirty days service and attainment of the age of twenty-one. Eligible employees may enter the Plan on the first day of each month.

Participants are eligible for any Company matching contributions upon completion of thirty days of service and attainment of the age of twenty-one. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Administration -

The Company serves as Plan administrator (the “Administrator”) and is solely responsible for the general administration of the Plan and carrying out Plan provisions. Alerus Financial, N.A. (the “Trustee”), a wholly owned subsidiary of Alerus Financial Corporation, serves as the trustee of the Plan and custodian of Plan assets. Alerus Retirement and Benefits (“Alerus”), a division of Alerus Financial, N.A., provides third-party recordkeeping services. Wealth Enhancement Group, LLC provides investment advisory services to the Plan.

Contributions -

Participants may elect to contribute up to 100% of their eligible compensation to the Plan, subject to the maximum amount allowed under the Internal Revenue Code (the “Code”). Deferral limits under the Code were \$23,000 for the year ended December 31, 2024. In addition, participants age fifty and over at the end of the Plan year could elect to contribute a “catch-up” contribution of \$7,500 during the year ended December 31, 2024.

The Plan provides for the Company to make a fixed matching contribution equal to 100% of participant’s elective deferrals (excluding catch-up contributions) up to a fixed percentage based on years of service as follows:

<u>Years of service</u>	<u>Percentage</u>
Up to four	4%
At least four but less than nine	5%
At least nine but less than twenty	6%
Twenty or more	7%

Company matching contributions made each pay period totaled \$600,416 during the year ended December 31, 2024.

Participants are allowed to make rollover contributions from other qualified plans into the Plan in accordance with regulations under the Code. Further, participants are allowed to make Roth contributions into the Plan.

Participant accounts -

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with the participant's contributions and allocations of the Company's matching contributions and Plan earnings. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan, if not paid by the Company. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting -

Participants are immediately vested in their elective deferrals, rollover contributions, and Company matching contributions plus actual earnings thereon.

Investment options -

Participants direct the investment of their account into various investment options offered by the Plan. The Plan offers a number of investment options including mutual funds and a money market fund as selected by the Administrator.

Notes receivable from participants -

The Plan does not allow for participants to borrow from their participant accounts.

Payment of benefits -

Amounts contributed through payroll deductions may be withdrawn by, or distributed to, a participant only upon termination of employment or attaining the age of 65. Withdrawals prior to attaining the age of 65 are not permitted, except in the event of qualified military leave or a hardship distribution. Upon proof, to the satisfaction of the Administrator, amounts contributed may be withdrawn for qualified military leave or a hardship distribution. Upon termination of service due to death, disability, or retirement, a participant may receive a lump-sum amount equal to the vested value of his or her account.

If upon termination of service, a participant does not attain normal retirement age and the participant's vested account balance is greater than \$5,000, the participant may elect to receive a lump-sum amount, a direct rollover to a qualified plan under the Code, a direct rollover to a qualified Individual Retirement Account equal to the value of his or her vested account balance, or may elect to keep their investments in the Plan. If the vested account balance is less than \$5,000, the balance will be distributed to the participant as soon as administratively feasible. Such distributions will be rolled over to an individual retirement account designated by the Plan Administrator.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of accounting -**

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### **Use of estimates -**

The preparation of financial statements in conformity with GAAP requires the Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Significant estimates include, but are not limited to, the fair value of investments. Actual results may differ from those estimates.

### **Investment valuation and income recognition -**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Administrator determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for a discussion of fair value measurements.

Contributions are recorded by the Plan when withheld from participants. Interest income is recorded by the Plan as earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Payment of benefits -**

Benefit payments to participants are recorded when paid.

#### Expenses -

Certain expenses of maintaining the Plan, including investment advisory, legal, and audit fees are paid directly by the Company and are excluded from these financial statements. Administrative expenses include third-party recordkeeping fees and trustee fees. Participants are also charged administrative expenses for specific transactions within the Plan. Administrative expenses charged to the Plan totaled \$9,473 for the year ended December 31, 2024.

Investment related expenses are included in net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits.

#### Subsequent events -

The Administrator has evaluated subsequent events through September 5, 2025, which is the date the accompanying financial statements were available to be issued.

### **3. FINANCIAL INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

The Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the investment information included in the accompanying financial statements and supplemental schedule of assets (held at end of year) was obtained from data that has been prepared by, or derived from, information provided by the Trustee and furnished to the Administrator.

The Administrator has obtained certification from the Trustee that the information below is complete and accurate as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are as follows:

*Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual and money market funds:* Mutual and money market funds are valued at the net asset value ("NAV") of shares held by the Plan at year end. NAV is derived from the quoted prices in active markets of the underlying investments. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

## 5. PARTY-IN-INTEREST TRANSACTIONS

The Trustee serves as custodian of the Plan's assets. All transactions between the Plan and the Trustee qualify as exempt party-in-interest transactions. The Plan also allows for transactions with certain parties who may perform services or have fiduciary responsibilities for the Plan, including the Company.

## **6. TAX STATUS**

The Company adopted a non-standardized pre-approved profit sharing/money purchase/cash or deferred arrangement plan sponsored by the Trustee that received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020. The opinion letter stated that the Plan is designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the opinion letter, the Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements for the year ended December 31, 2024.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **7. PROHIBITED TRANSACTIONS**

During the year ended December 31, 2024, the Company failed to remit certain employee contributions totaling \$65 to the Plan within the time frame required by the Department of Labor under the plan asset rules. These deferrals are included in the Plan's receivables at December 31, 2024, and have been subsequently remitted to the Plan. Delays in remitting contributions to the custodian were due to administrative errors, and the Company will make contributions to the affected participant's account to compensate them for potential lost income due to the delays.

## **8. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

## **9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the accompanying statements of net assets available for benefits.
